## **DISCLAIMER**

Gallatin County Schools are not responsible for any lost or stolen items while they are at school. Anything of value brought to school by a student should be kept with the student or securely locked in their locker. If an item does not belong at school and the student decides to carry it with them instead of securing it in their locker, they do so at the risk of having the item confiscated.

## **PHILOSOPHY**

The Board of Education and the school staff recognize that instruction is the most important single activity of the school. The primary function of all other departments of the school is to support the instructional program and to maintain a quality program of education for the school system.

It is the desire of the board and the administration that the school have highly qualified personnel for all positions at our school. Employees are expected to devote themselves to the education and welfare of the students, to fulfill their job descriptions to the best of their abilities, and to implement within the scope of their positions, the district policies.

The Board of Education and the school staff accept the responsibility for generating and understanding of American freedom and for the preservation of these freedoms through the development of informed and responsible citizens.

Each teacher in the Gallatin County School should strive to maintain a classroom in which pupils are comfortable, and in which each student is learning.

We believe that the most important teaching starts in the home and at a very early age. The home and school must work together to provide the very best possible for the student as he/she grows. Students usually feel that education, work ethic, responsibility, respect, following rules and guidelines, and being sensitive to the needs of others are important if their parents do. Each student is regarded as being a unique individual and is important to the staff at Gallatin County Schools.

Educators as well as students should be made aware of and be respectful to each individual in his or her daily life and develop a sincere appreciation for the different ethnic, economic, religious and social backgrounds of groups and nations.

The dignity of individuals should be protected with proper consideration for their personal feelings, which may be associated with race, color, creed, and intellectual characteristics. The recognition by the pupil and the teacher of their responsibilities to each other in this connection might well establish a mutual respect, which should stimulate a sound basis for developing high morale and for carrying out school procedures.

Education cannot proceed effectively without good, consistent discipline. Good discipline is best thought of as being positive, not negative, of helping a student to adjust, rather than punishment. Discipline is training to act in accordance with rules to obtain certain goals.

Gallatin County Unit #7 feels it is the responsibility of the school to help the student maintain and further develop his or her self-discipline so that the exercise of individual rights does not infringe upon the rights of others.

To enjoy the benefits of school citizenship, rules and guidelines for student behavior in Gallatin County Schools have been established and adopted to insure standards of conduct which will promote knowledge and learning as mandated by the Gallatin County Unit #7 School Board and the Illinois School Code.

We take pride in the fact that our policies were developed and have been modified periodically by committees of parents, community, and staff members. It continues to be our goal for students to develop "self discipline so that the exercise of individual rights does not infringe upon the rights of others". It is expected that the staff will apply the discipline policies evenhandedly and that they will modify the application of discipline (including handicapped students) in accordance with federal and state laws as well as current court decisions.

## **EARLY DROP OFF FOR WORKING PARENTS**

Students may arrive at school before the start of the school day. Early arrival drop off begins at 7:30 a.m. Parents are to drop off their child at the Junior-Senior High entrance at the front of the building. School Personnel will supervise early arrival students. Do not leave students before 7:30 a.m. as the doors will be locked.

# **ALCOHOL ABUSE**

The consumption, possession, or distribution of alcoholic beverages is not permitted on school buses, in school buildings, or on all other school property. This policy extends to all school sponsored and related activities. Students shall not be permitted to attend school when they are under the influence of alcohol. Students who are under such influence shall be treated in the same manner as though they had alcohol in their possession. If a student is found to be under the influence of, using, possessing, or distributing alcoholic beverages in violation of this policy, the student may be suspended and/or expelled according to the District's discipline policy.

## ATHLETIC HANDBOOK

All athletic rules and regulations are outlined in the athletic handbook.

## ATHLETIC/ACTIVITY PARTICIPATION FEE

Students will be charged a \$52 (max of \$104 per family) athletic/activity participation fee for sports & Scholar Bowl participation. The fee revenue will help fund the school's activity programs.

- The participation fee will be levied only when team rosters have been set after tryouts.
- The participation fee is charged per student/athlete, per year.
- The participation fee does not guarantee playing time.
- The participation fee does not guarantee a full complement of contests.
- Families with two or more siblings participating in the district sports will be charged \$52 per participant, up to a family limit of \$104 per school year.
- Refunds of participation fees will not be given if a student/athlete quits a team, is removed from a team, withdraws from the school, or is injured during a practice and/or contest and cannot play. Refunds in other circumstances beyond district control will be decided on a case-by-case basis.
- Exception: A student athlete who pays the participation fee in a sport that is cancelled prior to the first contest will receive a refund.

## Outlining the waiver criteria:

- Students who have been approved for free/reduced price meals are eligible to receive a waiver of participation fees. Other extenuating circumstances may also apply.

## Waiver process:

- Parents will need to complete the application for waiver of athletic/activity participation fee and return it to the school principal.
  - A separate application for waiver must be filled out for each student/athlete for whom a waiver is requested.

## CONSUMABLE/INSTRUCTIONAL MATERIAL FEE

A consumable/instructional material fee of \$37 per student (max of \$74 per family). Students who qualify for free/reduced lunches may have this fee waived. The waiver must be signed by a parent or guardian and on file in the office within ten (10) days of the first semester. Individuals who are issued books must pay for books that are lost, stolen or damaged; therefore, every student should care for his/her books. When available, students will be given a used book price for the replacement of their lost or damaged book.

#### FINES, FEES, & CHARGES; WAIVER OF STUDENT FEES

The school establishes fees and charges to fund certain school activities. Some students may be unable to pay these fees. Students will not be denied educational services or academic credit due to the inability of their parent or guardian to pay fees or certain charges. Students whose parent or guardian is unable to afford student fees may receive a fee waiver. A fee waiver does not exempt a student from charges for lost and damaged books, locks, materials, supplies, and/or equipment.

Applications for fee waivers may be submitted by a parent or guardian of a student who has been assessed a fee. As student is eligible for a fee waiver if at least one of the following prerequisites is met:

- 1. The student currently lives in a household that meets the free lunch or breakfast eligibility guidelines established by the federal government pursuant to the National School Lunch Act; or
- 2. The student or the student's family is currently receiving aid under Article IV of the Illinois Public Aid Code (Aid to Families of Dependent Children).
- 3 The student's parent is a veteran or active-duty military personnel with income at or below 200% of the federal poverty line.

The building administration will give additional consideration where one or more of the following factors are present:

- An illness in the family;
- Unusual expenses such as fire, flood, storm damage, etc.;
- Unemployment;
- Emergency situations; or
- When one or more of the parents/guardians are involved in a work stoppage.

The building principal will notify the parent/guardian promptly as to whether the fee waiver request has been granted or denied. Questions regarding the fee waiver application process should be addressed to the building principal.

#### **Waiver for School Fees:**

A child who is "directly certified "or "categorically eligible" (i.e., is homeless, migrant or runaway) would automatically receive school fee waivers subject to the federal verification limitations. Proof of income will determine school fee waiver eligibility. A School Fee Waiver Application is included in the appendix of this handbook. The School Fee Waiver Application must include a copy of verified proof of yearly family income and be submitted to the child's office secretary by Friday, August 25<sup>th</sup>, 2023.

#### BULLYING

No student should be subject in school to bullying, aggression and violence. Accordingly, aggressive student behavior including student bullying in all forms is prohibited.

When an incident of bullying is reported, the following steps will be taken by school personnel in order to understand and rectify the disruptive aggressive behavior:

- 1. A prompt, thorough investigation of the alleged bullying incident
- 2. Provide appropriate consequences and remedial action to aggressor
- 3. Protect the victim against retaliation for reporting the incident.

Aggressive behavior is defined as assertive words and/or actions intended to threaten, injure, harass, provoke or incite another person, or as hostile words and/or actions toward the property of another. Bullying is defined as student behavior which hurts, frightens, threatens, or tyrannizes students who are either physically or psychologically smaller or weaker than the person engaging in bullying. Examples of bullying may include, but are not limited to:

Physical Bullying: may include punching, shoving, poking, hair-pulling, or other similar behaviors. Verbal Bullying: may include name calling, teasing, gossip, humiliation, intimidation, or other similar behaviors.

The administration is directed to provide District school and parents education materials designed to assist in preventing bullying and to minimize the risk of being bullied. Students who engage in acts of bullying may be subject to discipline in accordance with the Board's general student behavior policy. Such discipline may include verbal or written reprimand, in-school suspension; change of placement and/or out of school suspension, expulsion, or involvement of local law enforcement at the administration's discretion.

Students who are victims of bullying may also be referred for counseling or other supportive services from school or community agencies. In addition, school personnel shall monitor and identify students who exhibit behaviors that indicate a tendency toward aggressive behavior, including bullying. Upon receipt of the referral, we shall monitor the student, review any non-school, community-based interventions for the student and consider necessary school based interventions including, but not limited to, referral for an evaluation to determine special education eligibility. If the student is currently a student with a disability, the student's IEP or Section 504 team may, when appropriate, assume the functions of the building's student support team.

\*State law (105 ILCS5/10-20.14) requires a school district to notify the parent or guardian of a child who uses aggressive behavior, including bullying, at school. Law Enforcement Hate Crimes Prevention Act 9LEHCPA): An incident motivated by the actual or perceived race, color, religion, national origin, immigration status, gender, sexual orientation, or disability of the victim.

# Prevention of and Response to Bullying, Intimidation, and Harassment

Bullying, intimidation, and harassment diminish a student's ability to learn and a school's ability to educate. Preventing students from engaging in these disruptive behaviors and providing all students equal access to a safe, non-hostile learning environment are important district and school goals.

Bullying on the basis of actual or perceived race, color, national origin, military status, unfavorable discharge status from the military service, sex, sexual orientation, gender identity, gender-related identity or expression, ancestry, age, religion, physical or mental disability, order of protection status, status of being homeless, or actual or potential marital or parental status, including pregnancy, association with a person or group with one or more of the aforementioned actual or perceived characteristics, or any other distinguishing characteristic is **prohibited** in each of the following situations:

- 1. During any school-sponsored education program or activity.
- 2. While in school, on school property, on school buses or other school vehicles, at designated school bus stops waiting for the school bus, or at school-sponsored or school-sanctioned events or activities.
- 3. Through the transmission of information from a school computer, a school computer network, or other similar electronic school equipment.
- 4. Through the transmission of information from a computer that is accessed at a non-school-related location, activity, function, or program or from the use of technology or an electronic device that is not owned, leased, or used by the school district or school if the bullying causes a substantial disruption to the educational process or orderly operation of a school.

*Bullying* includes cyber-bullying and means any severe or pervasive physical or verbal act or conduct, including communications made in writing or electronically, directed toward a student or students that has or can be reasonably predicted to have the effect of one or more of the following:

- 1. Placing the student or students in reasonable fear of harm to the student's or students' person or property;
- 2. Causing a substantially detrimental effect on the student's or students' physical or mental health;
- 3. Substantially interfering with the student's or students' academic performance; or
- 4. Substantially interfering with the student's or students' ability to participate in or benefit from the services, activities, or privileges provided by a school.

Cyberbullying means bullying through the use of technology or any electronic communication, including without limitation any transfer of signs, signals, writing, images, sounds, data, or intelligence of any nature transmitted in whole or in part by a wire, radio, electromagnetic system, photo-electronic system, or photo-optical system, including without limitation electronic mail, Internet communications, instant messages, or facsimile communications. Cyberbullying includes the creation of a webpage or weblog in which the creator assumes the identity of another person or the knowing impersonation of another person as the author of posted content or messages if the creation or impersonation creates any of the effects enumerated in the definition of bullying. Cyberbullying also includes the distribution by electronic means of a communication to more than one person or the posting of material on an electronic medium that may be accessed by one or more persons if the distribution or posting creates any of the effects enumerated in the definition of bullying.

Examples of prohibited conduct include name-calling, using derogatory slurs, stalking, sexual violence, causing psychological harm, threatening or causing physical harm, threatened or actual destruction of property, or wearing or possessing items depicting or implying hatred or prejudice of one of the characteristics stated above.

Students are encouraged to immediately report bullying. A report may be made orally or in writing to the building principal, nondiscrimination coordinator, district complaint manager or any staff member with whom the student is comfortable speaking. All school staff members are available for help with a bully or to make a report about bullying. Anyone, including staff members and parents/guardians, who has information about actual or threatened bullying is encouraged to report it to the district complaint manager or any staff member. Anonymous reports are also accepted by phone call or in writing.

# **CLASS PARTIES**

There will be no school sponsored parties during the school day. All parties connected with the school must be approved by the principal a week in advance of the event. No food or drink will be taken to a classroom during the school day unless approved by the principal.

# CLASS TRIP - 8TH GRADE

- 1. Sponsors and the principal will determine the place, time, and details of the trip.
- 2. Eligibility for the trip will be as follows:
  - A. Students must pass ALL classes in the third and fourth quarters, and be passing at mid-term of 4th quarter. An average of the two quarters will not be accepted as passing. i.e. You may not have received an F grade at the end 3rd quarter or mid-term of 4th quarter
- B. Students must pass ALL classes for the entire year. i.e. You may have received an F grade first or second quarter, but your average for the year must be passing.
  - C. Students must have passed the Illinois and the U.S. Constitution test if it has been given prior to the trip.
  - D. Ten or more tardies = exclusion from trip.
  - E, Third ACR full day assignment = automatic exclusion from trip.
  - F. One Suspension = automatic exclusion from trip.
  - G. 10% or more absences from school that includes all unexcused absences = automatic exclusion from trip.
  - H.The principal makes the final decision on the 8<sup>th</sup> grade trip attendance.

# **CLOSED CAMPUS**

This means that after students arrive at school they are not to leave the campus unless permission is obtained from the principal. The campus is also closed to anyone except registered students in good standing, employees, and those parents and visitors who have specific and approved business at the school. All visitors are to report to the office immediately upon entering the campus. Anyone entering the campus who does not fit in one of the above categories may be considered a trespasser.

#### **CLOSED LUNCH POLICY**

The Gallatin County School District has a closed lunch policy that prohibits students from leaving the building for lunch. Students who leave the building for lunch or who have not received permission to report to other areas of the building will be considered truant.

## CONDITIONS WHICH FAVOR THE DEVELOPMENT OF GOOD SCHOOL DISCIPLINE

A. An adequate home which:

- 1. Assumes the primary responsibility for the discipline of the child.
- 2. Is aware of the child's responsibilities and obligations in the school as well as in the community and establishes home conditions, which are favorable to his or her success in school.
- 3. Recognizes that school personnel must necessarily concern themselves primarily with group training and group behavior.
- 4. Cooperates with school authorities and participates in conferences regarding the behavior, health, and

academic progress of the child.

B. A responsible student who:

- 1. Respects constituted authority, which includes not only obedience to school rules and regulations, but also conforms to the laws of the community, state, and nation.
- 2. Reflects respect and consideration for the personal and property rights of others and has an understanding of the need for cooperation with all members of the school community.

C. A responsible school in which the professional staff:

- 1. Encourages the use of good guidance procedures.
- 2. Maintains an atmosphere conducive to good behavior.
- 3. Exhibits an attitude of respect for students that has a positive influence in helping students develop good citizenship traits.
- 4. Plans a flexible curriculum to meet the needs of all students.
- 5. Promotes effective training or discipline based upon fair and impartial treatment of all students.
- 6. Develops a good rapport among the teaching staff, and between the administration and the

teaching staff.

7. Endeavors to involve the entire community in order to improve the quality of life in that community.

# DEPRESSION AND SUICIDE AWARENESS AND PREVENTION

Youth suicide impacts the safety of the school environment. It also affects the school community, diminishing the ability of surviving students to learn and the school's ability to educate. Suicide and depression awareness and prevention are important goals of the school district.

The school district maintains student and parent resources on suicide and depression awareness and prevention. Much of this information, including a copy of the school district's policy, is posted on the school district website. Information can also be obtained from the school social worker.

## **DISASTER DRILLS**

#### SAFE ENVIRONMENT DRILL

When the announcement is made over the intercom system that includes a code word(s), teachers are to lock their classroom doors, turn out the lights, and make sure all students are away from any windows or doors. They are to stay in this position until the "ALL CLEAR" has been announced over the intercom system.

#### EARTHQUAKE DRILL

At teacher command students are to drop and cover. In the event of an earthquake or other such emergencies, sit under your desk until the all clear announcement has been made.

## **TORNADO DRILL**

WARNING SIGNAL: Pulsating Bell

ALL CLEAR SIGNAL: Announcement over the intercom Rooms 100-119, 201, 300-322, 400-419, 501-519, & 601-604:

Stay in room and go to wall next to hallway

Rooms 606 (art) Go to Art storage room

600 (library) Go to high school hallway

700 (junior high gym) Go to dressing room

702 Stay in room

708-716 Go to north/south vocational hallway

800 (Multi-purpose) Go to storage room #804

900 (high school gym) Go to dressing room

NOTE: During a tornado drill or emergency, students are to sit on the floor with their faces to the wall. All fire doors should be closed. All windows and classroom doors should be closed.

#### DISCRIMINATION GRIEVANCE PROCEDURE

Any employee, citizen or student who believes he has been discriminated against by any administrator, supervisor, or employee of the district may seek redress of the grievance as follows:

- 1. Whenever possible the aggrieved should attempt to resolve the matter through an informal conference with the administrator, supervisor, or employee charged with the discrimination.
- 2. If step 1 fails, the grievant should lodge an official, written complaint with the district coordinator of Section 504, ADA or IDEA. Following consultation with grievant (the individual accused of discrimination and/or other knowledgeable individuals) the District Coordinator will issue written findings regarding the matter. Such written findings shall be issued within 15 calendar days of the filing of the grievance.
- 3. Appeal of the step 2 finding may be made by the aggrieved or the individual accused of the discrimination. The written appeal must be filed with the District Superintendent within seven calendar days of the issuance of The step 2 findings. Following appropriate consultation the superintendent shall issue his written findings within 15 calendar days of his receipt of the appeal.
- 4. Appeal of the step 3 finding may be made by the aggrieved or the individual charged with the discrimination. The written appeal must be to the Board of Education through the Board President within seven calendar days of the issuance of the step 3 findings. The Board of Education shall conduct a hearing on the issue within 15 calendar days of the receipt of the written appeal. Findings shall be by a majority vote of members present at the hearing. Nothing shall prevent either party or the Board of Education from being represented in step 1-4 by an attorney or other spokesperson. Furthermore, this grievance procedure shall not prevent a party from seeking redress in a court of law.

## **DISPENSING MEDICINE POLICY**

Only those medications which are necessary to maintain the child in school and must be given during school hours shall be administered.

Medication may be administered by school personnel if the following regulations are met: A. The medication is to be given by the principal's designee and is to be kept in a secure place. B. Written instructions (\*) signed by both parent and physician are required and shall include: 1. Child's name

- 2. Name and purpose of medications
- 3. Time to administer and the dosage
- 4. Possible side effects
- 5. Termination date for administering medication
- 6. All permission for long-term medication shall be renewed at least annually by the licensed physician. . Sample form is attached at the end of this handbook. Please see the school nurse to obtain this form. C. The medication must be brought to school in a container appropriately labeled by the pharmacy or physician. D. The parents of the child must assume responsibility for notifying the school of any change in medication and for providing the school with written instructions from the physician.
- E. The school district retains the discretion to reject requests for the administration of medication. F. The advisory committee shall meet annually to review and/or revise the medication dispensing policy. (\*) These instructions are to be placed in the pupil's temporary file and a copy of the instructions is to be sent to the proper designee.

Taking medication during school hours or during school-related activities is prohibited unless it is necessary for a student's health and well-being. When a student's licensed health care provider and parent/guardian believe that it is necessary for the student to take a medication during school hours or school-related activities, the parent/guardian must request that the school dispense the medication to the child by completing a "School Medication Authorization Form."

No school or district employee is allowed to administer to any student, or supervise a student's self-administration of, any prescription or non-prescription medication until a completed and signed School Medication Authorization Form is submitted by the student's parent/guardian. No student is allowed to possess or consume any prescription or non-prescription medication on school grounds or at a school-related function other than as provided for in this procedure.

#### Self-Administration of Medication

A student may possess and self-administer an epinephrine injector (e.g., EpiPen®) and/or an asthma inhaler or medication prescribed for use at the student's discretion, provided the student's parent/guardian has completed and signed a School Medication Authorization Form.

Students who are diabetic may possess and self-administer diabetic testing supplies and insulin if authorized by the student's diabetes care plan, which must be on file with the school.

Students with epilepsy may possess and self-administer supplies, equipment and medication, if authorized by the student's seizure action plan, which must be on file with the school.

Students may self-administer (but not possess on their person) other medications required under a qualified plan, provided the student's parent/guardian has completed and signed a School Medication Authorization Form.

The school district shall incur no liability, except for willful and wanton conduct, as a result of any injury arising from a student's self-administration of medication, including asthma medication or epinephrine injectors, or medication required under a qualifying plan. A student's parent/guardian must indemnify and hold harmless the school district and its employees and agents, against any claims, except a claim based on willful and wanton conduct, arising out of a student's self-administration of an epinephrine injector, asthma medication, and/or a medication required under a qualifying plan.

#### **Undesignated Medications**

The school wellness center may maintain the following undesignated prescription medications for emergency use: (1) Asthma medication; (2) Epinephrine injectors; (3) Opioid antagonists; and (4) Glucagon. No one, including without limitation, parents/guardians of students, should rely on the school or district for the availability of undesignated medication. This procedure does not guarantee the availability of undesignated medications. Students and their parents/guardians should consult their own physician regarding these medication(s).

#### **Emergency Aid to Students**

Nothing in this policy shall prohibit any school employee from providing emergency assistance to students, including administering medication.

# DRESS CODE

Students may wear any clothing which is generally considered morally decent and safe in the school situation. Extreme dress is inappropriate. Young men and women should recognize the importance of being well groomed at all times. Clothing need not be expensive to be clean, neat and attractive. One of the most important factors in being well groomed is wearing clothing appropriate for the occasion. Dress that may be proper at home or on the beach may be out of place at school. Clothing shall not be hazardous to the health and safety of the students or disruptive to the educational program of the school. Any extremes of dress which detract from the orderliness of the school program by bringing undue attention to the individual are, of course, inappropriate. For example: Shoes must be worn at all times. Bare midriff clothing, "see-through mesh" attire, undershirts as outerwear, half-shirts, halters, spaghetti straps, T-tops, tank tops or split-side shirts, house shoes, pajamas, caps, hats, or sunglasses, shall not be worn. Length of shorts, skirts and dresses must be within five (5) inches from the top of the knee. Holes or slits in jeans must not be more than 5 inches above the knee. No baggy pants without belts and no showing of undergarments. Shirts and scoop neck tops must have a neckline that is no lower than four fingers from the center of the collar bone. Clothing accessories/attachments such as gloves, studded bracelets, chains etc. should not be worn. Leggings/yoga pants must be worn with a top of a length that, at a minimum, covers the "bottom" and is consistent in length from front to back. Students should also refrain from wearing items of clothing which contain printed messages, logos, and/or activity which are deemed offensive, illegal or condone an activity which is socially unacceptable or unwise (i.e. tobacco, alcohol, drugs, profane comments or gestures, etc.).

• When a student's dress becomes inappropriate for the school setting, then it becomes the responsibility of the school to intervene. Faculty and administration reserve the right to determine whether students dress is appropriate or disruptive to the educational process. A student who is inappropriately dressed will be asked to correct the problem immediately or be sent home to change. The time missed as a result will be considered unexcused. All classrooms are air-conditioned; therefore, students should wear adequate clothing. Students are expected to follow student dress guidelines presenting themselves decently and appropriately at all times during school, educational trips, extra-curricular events and activities. During "dress-up days" such as during Spirit Week, attire must adhere to the school dress guideline. Any deviation must be approved by the principal.

## **DRUG ABUSE**

The Board of Education has adopted a Drug Abuse Policy. The illicit use, possession or distribution of drugs or look alike drugs and drug paraphernalia is not permitted on school buses, in school building, or on school grounds at any time. This policy extends to all school sponsored and related activities. Students shall not be permitted to attend school when they are under the influence of illicit drugs. For the purpose of this policy, students who are under such influence shall be treated in the same manner as though they had drugs in their possession. If a student is found to be illicitly using, possessing, or distributing drugs or look-alike drugs and drug paraphernalia, they may be suspended for a period of up to 10 days and/or expelled. In addition, parents and juvenile authorities shall be notified promptly. When a substance is suspected to be an illicit drug, the identity of the student shall be given to the proper authorities for prosecution.

## **DRUG TESTING POLICY**

Any student who participates in extracurricular activities sanctioned by the Illinois Junior High School Association will be subject to the drug testing policy.

# **ENFORCEMENT OF RULES AND REGULATIONS**

When self-discipline fails, regulations for the management of school behavior, including those adopted by the Board, must be enforced by those directly responsible for the operation of the schools. School staff members will make every effort, individually, collectively, and cooperatively, with appropriate available community resources, to help each student gain acceptable self-discipline standards. The School Board of Unit #7 has this legal responsibility according to <a href="https://disciplinestandards.org/linestandards">The Illinois School Code</a>.

- 1. SCHOOL DETENTION: Students may be detained before school, during lunch, or after school as a disciplinary measure. This includes students transported by school bus. A reasonable attempt shall be made to contact the parent or quardian.
- 2. OTHER REMEDIES: The principal, any administrative personnel, or any teacher of the school shall be authorized to take reasonable action in connection with student misbehavior. Reasonable action might include: A. Counseling with a student or group of students.
  - B. Conferences with a parent or group of parents.
  - C. Assigning students alternative assignments.
  - D. Rearranging class schedules.
  - E. Requiring a student to remain after regular school hours.
  - F. Restriction of extracurricular activities.
  - G. Delayed access to Drivers Education.
- 3. REMOVAL FROM CLASS (CLASSROOM DISRUPTION): The principal may remove a student from class when the seriousness of the offense, when the persistence of the misbehavior, or when the disruptive conduct, in consultation with the teacher, disrupts the educational process of the other students in the classroom, or when the student has been disrespectful, defiant, or insubordinate.
- 4. PROBATION: Students on probation will not be allowed to participate in extracurricular activities during the probation period. Extracurricular activities shall include all school activities which are not directly related to a specific course in which the student is enrolled on a regular basis. Violation of probation may result in the extension of the probationary period or in the suspension of the student from school for a period of not more than three school days. **NOTE:** Parents will be notified in writing or in person when a student is placed on probation. In all cases the assignment of probation will be by the principal or superintendent.
- 5. ALTERNATIVE CLASSROOM: The term "Alternative Classroom" means the students attends school during regularly scheduled hours and is assigned to a classroom where he/she receives his/her assignments and studies under supervision. All work completed while in the in-school suspension will count toward the students grades. A. Student may not eat at the same time as the other students.
  - B. Student must keep up with homework and other assignments.
  - C. Parents will be notified by mail of the alternative classroom assignment.
- 6. SUSPENSION: The term "suspension" means disciplinary action whereby a student is separated from school and any extracurricular and related activities for a period of ten school days or less and which does not constitute an expulsion under number 7 of this section.
- 7. EXPULSION: The term "expulsion" means disciplinary action taken by the Board of Education whereby a student by Board of Education resolution:
  - A. Is separated from school attendance and extracurricular/related activities for a period in excess of ten school days.
  - B. As a result of Public Act 89-371, the school board may extend student expulsions into the following school year. Effective January 1<sup>st</sup>, 1996, the maximum expulsion period is extended from the end of the current year to the end of the next school year for a maximum expulsion period of two school years.
- 8. REFERRAL OF CHRONIC TRUANTS: Chronic truants and their parents will be referred to the Office of the State's Attorney for prosecution under Illinois statues.

#### **GUIDELINES FOR DETERMINING PENALTIES**

Any violation of state or local law will be promptly reported to the appropriate law enforcement authorities. 1. These examples are not the only acts or condition for which suspension or expulsion is warranted, nor do they limit this handbook.

- 2. Subsequent cases of the same offense may result in more severe disciplinary action. 3. Physical attack upon any person may be grounds for expulsion from school.
- 4. Expulsion may be levied on any student who is found to be carrying a weapon to, from, or within Gallatin County Schools; or to, from, or in attendance at any school-sponsored activity. 5. Any student who has initiated, or taken part in an act of vandalism or arson as described in this handbook may be expelled. Further, it shall be the practice of the school district to seek to recover damages from the parents of any minor, or from any person, who has initiated, or taken part in any act of vandalism as described in this handbook.

## **ENROLLMENT PROCEDURE**

Before a student can enroll at Gallatin County Unit #7, a student must present a valid birth certificate (a copy of a birth certificate is not acceptable). Students also need to bring or have requested their student records from their previous school. Out of state students will need to present a physician's signed school physical before student can attend.

- 1. No Illinois school is required to admit a new student unless they can produce their Student Transfer Form; OR 2. School records from previous out of state school through appropriate transfer forms, or through direct contact with that school's officials; OR
- 3. While serving a suspension or expulsion from previous school district.

## **FAMILY LIFE & SEX EDUCATION CLASS**

Students will not be required to take or participate in any class or courses in comprehensive sex education, including in grades 6-12, instruction on both abstinence and contraception for the prevention of pregnancy and sexually transmitted diseases, including HIV/AIDS; family life instruction, including in grades 6-12, instruction on the prevention, transmission, and spread of AIDS; instruction on diseases; recognizing and avoiding sexual abuse; or instruction on donor programs for organ/tissue, blood donor, and transplantation, if his or her parent or guardian submits a written objection. The parent or guardian's decision will not be the reason for any student discipline, including suspension or expulsion. Nothing in this Section prohibits instruction in sanitation, hygiene or traditional courses in biology.

Parents or guardians may examine the instructional materials to be used in any district sex education class or course.

# **FUNDRAISING ACTIVITIES**

All school fundraising must be approved by building and district administration using the district fundraising approval form. (See Coach/Sponsor handbook) Fundraising must have a designated purpose prior to the beginning of sales. The projects must be planned and carried out in cooperation with building administration and comply with the Coach/Sponsor Handbook and Board Policy 7:325 Student Fundraising. Parent organizations and booster clubs are invaluable resources to the District's schools. While parent organizations and booster clubs have no administrative authority and cannot determine District policy, the School Board welcomes their suggestions and assistance.

Parent organizations and booster clubs may be recognized by the Board and permitted to use the District's name, a District school's name, or a District school's team name, or any logo attributable to the District provided they first receive the Superintendent or designee's express written consent. Consent to use one of the above-mentioned names or logos will generally be granted if the organization or club has by-laws containing the following:

The organization's or club's name and purpose, such as, to enhance students' educational experiences, to help meet educational needs of students, to provide extra athletic benefits to students, to assist specific sports teams or academic clubs through financial support, or to enrich extracurricular activities.

- 1. The rules and procedures under which it operates.
- 2. An agreement to adhere to all Board policies and administrative procedures.
- 3. A statement that membership is open and unrestricted, meaning that membership is open to all parents/guardians of students enrolled in the school, District staff, and community members.
- 4. A statement that the District is not, and will not be, responsible for the organization's or club's business or the conduct of its members, including on any organization or club websites or social media accounts.
- 5. An agreement to maintain and protect its own finances.
- 6. A recognition that money given to a school cannot be earmarked for any particular expense. Booster clubs may make recommendations, but cash or other valuable consideration must be given to the District to use at its discretion. The Board's legal obligation to comply with Title IX by providing equal athletic opportunity for members of both genders will supersede an organization or club's recommendation.

Permission to use one of the above-mentioned names or logos may be rescinded at any time and does not constitute permission to act as the District's representative. At no time does the District accept responsibility for the actions of any parent organization or booster club regardless of whether it was recognized and/or permitted to use any of the above-mentioned names or logos. The Superintendent shall designate an administrative staff member to serve as the recognized liaison to parent organizations or booster clubs. The liaison will serve as a resource person and provide information about school programs, resources, policies, problems, concerns, and emerging issues. Building staff will be encouraged to participate in the organizations.

# **GRADUATION COMMENCEMENT EXERCISES**

Commencement Exercises are held at the end of the second semester. To participate in the graduation ceremony all fees must be paid. Only 8th graders who have fulfilled all district requirements for graduation may participate. 8th graders are required to pay \$10 towards a gown rental fee to attend commencement practice sessions.

## **GRADUATION EXERCISE REQUIREMENTS**

- 1. The district does not withhold a student's grades, transcripts, or diploma because of an unpaid balance on the student's school account.
- 2. 8th graders must participate in graduation rehearsal in order to participate in graduation exercises. It is the student's responsibility to know the time and the place for rehearsal; to participate in the graduation ceremony, all fees must be paid.

# **HARASSMENT**

Any form of harassment will not be tolerated. If harassment is suspected, whether it be physical, verbal, or sexual, the principal or assistant principal should be notified immediately. Harassment is defined as any act, verbal or physical, that disturbs or torments another individual. These acts would include, but not be limited to, racial slurs, comments about one's anatomy, inappropriate student to student physical contact, or threats of intimidation. No person, including a school or school district employee or agent, or student, shall harass, intimidate, or bully a student on the basis of actual or perceived; race; color; national origin; military status; unfavorable discharge status from military service; sex; sexual orientation; gender identity1; gender-related identity or expression; ancestry; age; religion; physical or mental disability; order of protection status; status of being homeless; actual or potential marital or parental status, including pregnancy; association with a person or group with one or more of the aforementioned actual or perceived characteristics; or any other distinguishing characteristic. The District will not tolerate harassing. intimidating conduct, or bullying whether verbal, physical, sexual, or visual, that affects the tangible benefits of education, that unreasonably interferes with a student's educational performance, or that creates an intimidating. hostile, or offensive educational environment. Examples of prohibited conduct include name-calling, using derogatory slurs, stalking, sexual violence, causing psychological harm, threatening or causing physical harm, threatened or actual destruction of property, or wearing or possessing items depicting or implying hatred or prejudice of one of the characteristics stated above.

#### **Sexual Harassment Prohibited**

The school and district shall provide an educational environment free of verbal, physical, or other conduct or communications constituting harassment on the basis of sex as defined and otherwise prohibited by State and federal law.

Awareness and Prevention of Child Sexual Abuse, Grooming Behaviors, and Boundary Violations For more information and warning signs of child sexual abuse, grooming behaviors, and boundary violations, please see Appendix A attached to the end of the handbook.

#### Making a Report or Complaint

Students are encouraged to promptly report claims or incidences of bullying, intimidation, harassment, sexual harassment, or any other prohibited conduct to the Nondiscrimination Coordinator, Building Principal, Assistant Building Principal, Dean of Students, a Complaint Manager, or any employee with whom the student is comfortable speaking. A student may choose to report to an employee of the student's same gender.

# **Equal Educational Opportunities and Sex Equity**

Equal educational and extracurricular opportunities are available to all students without regard to race, color, nationality, sex, sexual orientation, gender identity, ancestry, age, religion, physical or mental disability, status as homeless, immigration status, order of protection status, or actual or potential marital or parental status, including pregnancy.

No student shall, based on sex, sexual orientation, or gender identity be denied equal access to programs, activities, services, or benefits or be limited in the exercise of any right, privilege, advantage, or denied equal access to educational and extracurricular programs and activities.

Any student or parent/guardian with a sex equity or equal opportunity concern should contact your building administrator.

## **HEAD LICE**

The school will observe the following procedures regarding head lice.

- 1. Parents are required to notify the school nurse if they suspect their child has head lice. 2. Infested students will be sent home following notification of the parent or guardian.
- 3. The school will provide written instructions, products needed, and our Wellness Center's Family Resource Developer to parent or guardian regarding appropriate treatment for the Infestation.

A student excluded because of head lice will be permitted to return to school only when the parent or guardian brings the student to school to be checked by the school nurse or building principal and the child is determined to be free of the head lice and eggs (nits). Infested children are prohibited from riding the bus to school to be checked for head lice.

# **HIGHLY QUALIFIED TEACHER**

Parents may request the educational status of their child(ren)'s teacher(s) by filling out and submitting a "Teacher Status Request Form". Forms may be obtained from the superintendent's office.

#### **HOME & HOSPITAL INSTRUCTION**

A student who is absent from school, or whose physician, physician assistant or licensed advanced practice registered nurse anticipates his or her absence from school, because of a medical condition may be eligible for instruction in the student's home or hospital.

Appropriate educational services from qualified staff will begin no later than five school days after receiving a written statement from a physician, physician assistant, or licensed advanced practice registered nurse. Instructional or related services for a student receiving special education services will be determined by the student's individualized education program.

A student who is unable to attend school because of pregnancy will be provided home instruction, correspondence courses, or other courses of instruction before (1) the birth of the child when the student's physician, physician assistant, or licensed advanced practice nurse indicates, in writing, that she is medically unable to attend regular classroom instruction, and (2) for up to 3 months after the child's birth or a miscarriage. ## JUNIOR HIGH HONOR ROLL

To be on the honor roll, a student must attain a 92.5 average. Grades are calculated by the computer. No grades greater than 100 will be recorded or used in figuring class rank or honor roll.

## **LEAVING SCHOOL**

No student is to leave school without having permission from the office. They must also sign out, and sign back in upon their return. Failure to do this will result in an unexcused absence. This could be considered truancy.

# LIMITED ENGLISH PROFICIENCY

Students with a limited proficiency in English will be identified. Their level of proficiency will be assessed and methods of instruction will be provided to meet the educational strengths and needs of the student. A program will be developed with a goal to move to a proficiency in English with exit goals established. The student's parents or guardian will be notified and the program shall be established within 30 days after the beginning of the school year or within 2 weeks after the student's enrollment. Parents/guardians of English Learners will be informed how they can: (1) be involved in the education of their children;, and (2) be active participants in assisting their children to attain English proficiency, achieve at high levels within a well-rounded education, and meet the challenging State academic standards expected of all students; and (3) participate and serve on the District's Transitional Bilingual Education Programs Parent Advisory Committee. # MEALS PROCEDURES- Breakfast/Lunch Program

The Board promotes healthy, high-quality school meals, recognizing that students need adequate, nourishing food in order to learn, grow and maintain good health. To assure students have access to healthy meals, the district participates in the National School Breakfast and Lunch Programs.

# All Gallatin County Students will receive free breakfast and lunch this school year.

All students will receive one breakfast and one lunch tray each day free of charge. There will be no charging to lunch accounts this school year. For students who wish to purchase an extra school meal, A la carte items, or beverages, we recommend advance payments be made online and/or cash and check payments made to the lunch secretary's office. Students may also bring lunch. Please label lunch boxes with your

child's name. As always, soda and fast food lunches are discouraged.

Parents, the new online payment system will take credit and debit cards. This online program is called, "My School Bucks" and is located on the main page of our schools website at www.gallatincusd7.com. Click open "My School Bucks" and follow the instructions to set up an account.

Once you have your account you may also Pay All Student Fee's Online with credit or debit cards. The "My School Bucks" software will list individual students' school fees for this school year. The program is user friendly and should be helpful for parents. Please take the time to visit the gallatincusd.com website and click on <a href="https://www.myschoolbucks.com">https://www.myschoolbucks.com</a> to set up a user account for your child/children this school year.

## PAST ACCOUNT BALANCES

During the past our lunch secretary has maintained accounts for each individual student; if your child has a previous account balance you may use the online payment system to take care of this debt or set up a payment plan with the lunch secretary by calling (618) 272-3821 Extension 1234.

# **WAIVER FOR SCHOOL FEES**

A child who is "directly certified "or "categorically eligible" (i.e., is homeless, migrant or runaway) would automatically receive school fee waivers subject to the federal verification limitations. Proof of income will determine school fee waiver eligibility. A School Fee Waiver Application is included in the appendix of this handbook. The School Fee Waiver Application must include a copy of verified proof of yearly family income and be submitted to the child's office secretary by Friday, August 26, 2022.

## **NON-DISCRIMINATION POLICY**

It shall be the policy of the Gallatin County Unit #7 Board of Education to prohibit discrimination against any employee, student, or individual on account of race, color, creed, religion, national origin, age, sex, or disability. Furthermore, it shall be the policy to make reasonable accommodations for qualified applicants, employees, students, and individuals with disabilities, such as each of the following, unless it demonstrably would impose an "undue hardship" on the operation of the program:

- 1. Make facilities used by employees readily accessible to and usable by disabled persons.
- 2. Make modifications or adjustments to the job application process that enables a qualified applicant with a disability to be considered.
- 3. Making modification or adjustments in the work environment that enables a qualified individual with a disability to perform the essential functions of that position.
- 4. Making appropriate adjustments or modifications of examinations, training materials, or policies. 5. Job restructuring, part-time or modified work schedules.
- 6. Reassignment to a vacant position.
- 7. Acquisition or modification of equipment or devices.
- 8. The provision of readers or interpreters or other similar action.

## NO PASS-NO PLAY POLICY

The Board of Education believes that school sponsored, school supported and extracurricular activities provide students with invaluable educational, as well as instructional skills, and knowledge. The Board further recognizes, however, that a student's academic education must take precedence over participation in such activities. As such, and in accordance with Section 10-20.30 of the School Code, the Board has determined as follows:

- 1. All students in this District between grades nine and twelve, who participate in any school sponsored activity, including school supported athletic or extracurricular activities, shall maintain a minimum passing grade in all classes. Passing or failing shall mean the grade average that the student would receive if he/she were transferring from the District on the day eligibility is checked (i.e. year to date average).
- 2. Any student who fails to meet the minimum requirements established in paragraph 1 of this Policy shall be suspended from further participation in any school sponsored, school supported or extracurricular activity for one week AND/OR until such student raises his or her grades to passing.
- 3. Any student in this District between grades 5 and 8, who was retained the prior school year is not eligible to participate in any school sponsored, school supported or extracurricular activity.

The Board of Education authorizes the administration to promulgate rules and regulations to implement and enforce this policy.

Legal Reference: The School Code, 105 ILCS5/10-20.30.

#### PARENTS RIGHT TO KNOW

In accordance with Section 1111(h)(6) RIGHT-TO-KNOW, the Gallatin County School District is notifying every parent of a student in a Title I school that you have the right and may request information regarding the professional qualifications of your child's classroom teacher.

## PARENT/TEACHER CONFERENCES

Parents are encouraged to keep in contact with their child's teacher, especially if a problem exists. Teachers will be available before school, during planning time and after school for conferences. Parents should call 618-272-3821 ext, 1300 to arrange for a convenient conference time. Teachers will not be available for conferences during teaching time except in extreme emergency situations.

#### PESTICIDE APPLICATION

During the first week of each month the Gallatin County School District will have an outside agency come into the building to spray for insects. Parents may turn in a written request to the superintendent's office if they would like to be notified in advance of the day the building is sprayed.

#### PHYSICAL EXAMINATIONS/PROOF OF IMMUNITY

It shall be the policy of Gallatin County Community Unit #7 School to enforce the requirements of Section 27-8 of the School Code regarding physical and dental exams. As per current regulations (5-1980) fulfillment of the requirements for immunizations and providing the school with dates of each shall be part of this policy as well. Failure to obtain proof of immunization with dates and/or physical exams will lead to the exclusion of the student from school until the recommended requirement is met.

## **Required Health Examinations and Immunizations**

All students are required to present appropriate proof of a health examination and the immunizations against, and screenings for, preventable communicable diseases within one year prior to:

- 1. Entering kindergarten or the first grade;
- 2. Entering the sixth and ninth grades; and
- 3. Enrolling in an Illinois school for the first time, regardless of the student's grade.

Proof of immunization against meningococcal disease is required for students in grades 6 and 12. A diabetes screening must be included as part of the health exam (though diabetes testing is not required). Students between the age of one and seven must provide a statement from a physician assuring that the student was "risk-assessed" or screened for lead poisoning. Beginning with the 2017-2018 school year, an age-appropriate developmental screening and an age appropriate social and emotional screening are required parts of each health examination.

Failure to comply with the above requirements by October 15 of the current school year will result in the student's exclusion from school until the required health forms are presented to the school, subject to certain exceptions. A student will not be excluded from school due to his or her parent/guardian's failure to obtain a developmental screening or a social and emotional screening.

New students who register mid-term have 30 days following registration to comply with the health examination and immunization requirements. If a medical reason prevents a student from receiving a required immunization by October 15, the student must present, by October 15, an immunization schedule and a statement of the medical reasons causing the delay. The schedule and statement of medical reasons must be signed by an appropriate medical professional.

# **Eye Examination**

All students entering kindergarten or the school for the first time must present proof by October 15 of the current school year of an eye examination performed within one year. Failure to present proof by October 15, allows the school to hold the student's report card until the student presents: (1) proof of a completed eye examination, or (2) that an eye examination will take place within 60 days after October 15.

#### **Dental Examination**

All students entering kindergarten, second, sixth and ninth grades must present proof by May 15 of the current school year of having been examined by a licensed dentist within the last 18 months. Failure to present proof allows the school to hold the child's report card until the student presents: (1) proof of a completed dental examination, or (2) that a dental examination will take place within 60 days after May 15.

#### **Exemptions**

A student will be exempted from the above requirements for:

- 1. Medical grounds if the student's parent/guardian presents to the building principal a signed statement explaining the objection;
- **2.** Religious grounds if the student's parent/guardian presents to the building principal a completed Certificate of Religious Exemption;
- 3. Health examination or immunization requirements on medical grounds if a physician provides written verification:
- **4.** Eye examination requirement if the student's parent/guardian shows an undue burden or lack or access to a physician licensed to practice medicine in all of its branches who provides eye examinations or a licensed optometrist; or
- **5.** Dental examination requirement if the student's parent/guardian shows an undue burden or a lack of access to a dentist.

## PROMOTION POLICY

A student will be retained if they do not meet the following criteria:

- Students must pass math, reading, and science.
- Students must pass the Illinois and United States Constitution tests by the end of the 8th grade year.

#### STUDENT PROMOTION

The Board of Education adheres to the Illinois School Code's prohibition on promotion of a student to the next grade level based on social reasons, such as age. It is, therefore, the policy of this District that students shall be promoted to the next grade level based on the following criteria:

- 1. Successful completion of the curriculum.
- 2. Attendance
- 3. Performance based on state and local testing.
  - 4. Local goals and objectives indicating that the student can perform at the expected grade level.

Students shall not be promoted for purely social reasons.

Legal Reference: 105 ILCS 5/10-20.9a

20 U.S.C. Sec. 1412(a)(17)(A)(I)

#### **PUPIL POLICIES**

- 1. Children entering kindergarten or sixth and ninth grades and before participation in Drivers Education and Athletic Activities shall present a physical administered by a competent physician on the first day of school. Transfer students must have a physical examination and immunization dates on file within 30 school days or they will be excluded from school pursuant to section 27-8.1 of the School Code of Illinois. Dental exams are required for all 6<sup>th</sup> graders.
- 2. Pre-school age children are not permitted to visit school unless accompanied by a parent. 3. Physical education is a required subject. All students will be enrolled in a P.E. class unless they have a doctor's excuse which will have to be re-evaluated every 20 school days.
- 4. Children who ride the bus to a school activity shall return by bus. Any pupil who does not ride the bus home from a school activity must present a note to their sponsor signed by their parents giving permission to ride home by another form of transportation, or he must be excused by the principal. Each pupil must in all cases, notify the bus driver.
- 5. No knives or weapons of any kind, matches, cigarettes, tobacco products/tobacco look alike, pornographic materials. If an electronic device, (such as but not limited to iPods, CD players, etc) is brought to school, it must be removed and stored away (out of sight) before entering the school building. It must be stored in your locker. Such items will be confiscated if brought in the building. The school is not responsible for any lost or stolen electronic devices.
- 6. The privilege of riding a bus may be withdrawn when any pupil persists in violating rules and regulations. 7. Each student shall pay for all damage he or she may do to school property or the property of others within one week after demand thereof unless by arrangement with the principal. With arrangement, payment can be deferred until a later date. Failure to make such a payment may result in suspension. 8. All correspondence and summer school work must be authorized in advance by the superintendent before credit can be given.
- 9. Pupils are expected to restrain themselves from any show of affection towards others while on school property or while attending school activities off the school premises.

10. Pupils are permitted to use the school telephone only for emergencies. Student will be allowed to call home three times during the school year for reasons not considered an emergency (i.e. students calling home for items that were left at home). It is the student's responsibility to bring all items needed for school and/or extracurricular activities that day.

Cell phones must be kept out of sight and in an inconspicuous location, such as a backpack or locker. They must be turned off during the regular school day unless the supervising teacher grants permission for them to be used. They may not be used in any manner. Misuse will result in confiscation and be returned to the student according to disciplinary guidelines established by the administration.

- 11. Students who lose or damage a book while it is checked out to them will be expected to pay for it at the following rate: First year of use—100% of actual cost; second year of use—75% of actual cost; third year of use—50% of actual cost; fourth and subsequent years of use—25% of actual cost. A teacher may require a student to purchase necessary items for class work.
- 12. Student accident insurance is provided for a nominal fee.
- 13. Any student who desires to participate in any extracurricular activity shall have all school fees paid before the student may actively participate in that event. All extracurricular activities and/or Driver's Education are required to have the student insurance which the school handles. The insurance requirement will be waived upon presentation of evidence signed by a parent or guardian that the student is adequately insured. 14. Good manners, courtesy, and personal pride shall be exhibited by all students during school hours and during school sponsored activities. (i.e. not running in the halls; wearing hats in the building; loud, boisterous, or profane speech.)
- 15. It is the responsibility of each student to leave the area of disruption involving students. The students mere presence as an onlooker tends to lend support and encouragement to those students causing disruptions. Failure to cooperate may subject onlookers to disciplinary action.
- 16. All pupils shall be responsible for learning the requirements of promotion and/or graduation. These are announced each year, and copies may be obtained from the principal. Programs for transfer students must be approved by the Junior High School Principal. Eighth graders who have not completed requirements for graduation by the last day of school prior to graduation shall not participate in graduation exercises. 17. Participation in extracurricular activities may be denied to pupils who fail to conform to school rules. 18. Any student who wishes to ride a different bus other than their regular bus must bring a note from home and get permission from the superintendent or principal before being allowed to do so. 19. Breakfast and lunch will be free for all students for the 2019-2020 school year.
- 20. All equipment purchased by the school for individuals (uniforms, shoes, etc.) must be paid within 30 days and before issue.
- 21. The school will not issue acetaminophen (Tylenol), antacid tablets, cough drops, or any internal medicine without a written physician order and signed parent consent. First aid supplies are available and first aid will be provided. 22. Students who do not ride the bus should not arrive on school grounds before 7:45 a.m. 23. Students will not loiter in the halls. They will proceed to areas as directed by teachers. 24. Študents may wear any clothing which is generally considered morally decent and safe in the school situation. Extreme dress is inappropriate. Young men and women should recognize the importance of being well groomed at all times. Clothing need not be expensive to be clean, neat and attractive. One of the most important factors in being well groomed is wearing clothing appropriate for the occasion. Dress that may be proper at home or on the beach may be out of place at school. Clothing shall not be hazardous to health and safety of the students or disruptive to the educational program of the school. Any extremes of dress which detract from the orderliness of the school program by bringing undue attention to the individual are, of course, inappropriate. For example: Shoes must be worn at all times. Bare midriff clothing, "see-through mesh" attire, undershirts as outerwear, half-shirts, halters, spaghetti straps, T-tops, tank tops or split-side shirts, house shoes, pajamas, caps, hats, or sunglasses shall not be worn. Length of shorts, skirts and dresses must be within five (5) inches from the top of the knee. Holes or slits in jeans must not be more than 5 inches above the knee. No baggy pants without belts and no showing of undergarments. Shirts and scoop neck tops must have a neckline that is no lower than four fingers from the center of the collar bone. Clothing accessories/attachments such as gloves, studded bracelets, chains etc. should not be worn. Leggings/yoga pants must be worn with a top of a length that, at a minimum, covers the "bottom" and is consistent in length from front to back. Students should also refrain from wearing items of clothing which contain printed messages, logos, and/or activity which are deemed offensive, illegal or condone an activity which is socially unacceptable or unwise (i.e. tobacco, alcohol, drugs, profane comments or gestures, etc.).
  - When a student's dress becomes inappropriate for the school setting, then it becomes the responsibility of the school to intervene. Faculty and administration reserve the right to determine whether students dress is appropriate or disruptive to the educational process. A student who is inappropriately dressed will be asked to correct the problem immediately or be sent home to change. The time missed as a result will be considered unexcused. All classrooms are air-conditioned; therefore, students should wear adequate clothing. Students are expected to follow student dress guidelines presenting themselves decently and appropriately at all times during school, educational trips, extra-curricular events and activities. During "dress-up days" such as during Spirit Week, attire must adhere to the school dress guideline. Any deviation must be approved by the principal.
- 25. Discrimination Policy: The Board of Education of Gallatin County Unit District #7 shall not condone discrimination practices on the basis of sex, color, race, or creed. The superintendent will be the coordinator. His duties shall be to investigate complaints and supervise the district's efforts to comply with Title IX. All complaints shall be routed by way of the building principal to the coordinator and then to the Board of Education.

26. Cheating: In the event that a student is caught cheating on a test or on some other assignment, the student will be given a grade of "zero" for the assignment. Moreover, the teacher may require make-up or additional work and may administer other disciplinary actions such as detentions, parent conferences, etc. 27. No gang logos, colors, signs, paraphernalia, or gang activities are allowed at school. Further, anti-gang uniforms and vulgarities are prohibited. Gang like activities are defined as any conduct by a student for the furtherance of a common purpose. 28. Chewing gum will not be permitted on the school grounds because of the problems it causes carpets and floors. If brought to school, it will be confiscated. Edibles will likewise be confined to the commons. 29. Parents and students must sign a usage clause or statement with guarantee that the Internet will be used ethically and correctly. Parents must agree to pay if student causes damage to Internet access or destroys records or data. 30. Backpacks and large bags are not allowed in the classroom, they are to be kept in the student's locker. 31. Media Center: Books may be checked out of the media center for 2 weeks with the exception of reference books. They are to be checked out overnight. A fine of 5 cents per day will be assessed on overdue books and 30 cents per day will be charged for overdue reference books. All books are bar-coded and every student has a library number. If the barcode is damaged an assessment of \$1.00 will be charged. Material taken without checking out will be assessed a fine. Students are responsible for returning books on time according to the date stamped in the books.

32. Jr. High Students will not be allowed to wear flip flops or sandals during P.E.class. If a student wears flip flops or sandals to school, they will be required to have non-marking tennis shoes to change into during P.E.

# SCHOOL ATTENDANCE

Good schoolwork depends, to a large extent, on punctual attendance. Make-up work cannot completely take the place of regular classroom work. Parents must assume their share of responsibility for the regular and punctual attendance of their children.

A parent excused absence is one where the parent calls the office to report a student ill or absent. Parent excused absences are limited to ten (10) days per year, and no more than (5) per semester. Any absences after (10) parent excused absences in the school year will be considered unexcused absences. The student and parent/guardian will be notified that a doctor's excuse will be required after the 5<sup>th</sup> absence each semester.

School beings at 8:10 a.m. When a student is absent from school, **parents must call** the office @ 272-3821 ext, 1300 before 10:00 a.m. on the day of their child's absence as per IL School Code, Section 122: 26-36. 1. On the day following an absence, the student must bring a signed note from their parents <u>explaining the</u> <u>absence</u> or a phone call from the parents by 9:00 a.m. for absences.

Failure to bring a note or phone call will result in an unexcused absence.

2. If a student has any medical appointments or is absent for 3 or more consecutive days due to illness, a doctor's excuse may be required.

A student may not miss more than 55 minutes in any school day or he/she will be counted absent in the Official Illinois Attendance Register. Students signing out and back in must not be gone more than 55 minutes or he/she will be counted absent. Whether absences are excused or unexcused has no bearing upon the attendance record.

Attendance of school sponsored activities and trips will not be counted as an absence.

Parents may <u>prearrange</u> excused absences for trips. The arrangement must be made at least 2 or more days prior to the requested absence. Students who have had their parents prearrange for an absence will be excused. The arrangement must be a written request and signed by the <u>parent</u>, <u>student</u>, <u>and principal</u>.

When the second bell rings, the student must be in his/her seat ready to start working, or he/she is <u>tardy</u> to that class. **Individual teachers will address tardiness. Students may receive writing assignments.** 

The Gallatin County Schools recognizes three types of absences. The type, some examples, and the corresponding school action to be taken are indicated as follows:

TYPE I - LEGAL: Any absence allowed by the laws of the State of Illinois.

TYPE II - SCHOOL ACCEPTED:

Any absence due to sickness, death in family, prearranged absences, school-sponsored trips, and family emergency situations. School officials will evaluate emergency situations. Prearranged absences are those anticipated prior to the actual day or period of absence (i.e. doctor appointments, necessary family trips, and funerals). In order for the prearranged absences to be excused, the parent must inform the office as soon as possible prior to the last day of attendance. The student should obtain assignments or make-up work <u>before</u> the absences if at all possible and give it to the teacher.

Make-up work must be completed and given to the individual teachers. Students may be granted up to one day missed to

complete make-up work. It is the student's responsibility to obtain the make-up assignments from the teachers. It is the classroom teacher's responsibility to hold each student accountable for missed class time. TYPE III - UNACCEPTABLE:

#### A. UNEXCUSED ABSENCES

Any absence that is not considered legal or reasonable, but which is not typical of truancy; or reasons characterized by careless planning (i.e. oversleeping, running errands for parents or employers, taking off from school to work or shop, etc).

The principal or his representative will decide and issue unexcused absences. Parental permission to be absent from school does not necessarily mean an excused absence for the purpose of making up work or simply being an excused absence. The following actions or consideration may result from unexcused absence: 1. The student will be barred from any or all extracurricular activities scheduled for that date.

- 2. The student may be assigned detentions to be served before, during, or after school. 3. The student will not have the opportunity of doing make-up work for credit in the class missed. 4. The student will receive zeros for all graded work missed such as: tests, homework, participation grades, quizzes, etc.
- 5. After three unexcused absences in any one semester, a one-day in school suspension could results. Also, there may be a parent conference arranged.
- 6. Skip and related type absences may result in some type of detention or suspension.

#### B. TRUANCY

Any absence without the consent of the parents and school. In cases of truancy, the parents will be notified, an unexcused absence given, and make-up work time may be required.

When a student is truant, he/she may be required to make up this time during the noon hour. To make up this time, students will sit in an assigned area away from their friends. Repeated truancy could require additional disciplinary action.

"Chronic or habitual truant" shall be defined as a child who is absent from school without valid cause from compulsory school attendance for 5% or more of the 180 regular attendance school days; this calculates to nine (9) days per school year. The student and parent/guardian will be notified that a doctor's excuse will be required after the 9<sup>th</sup> absence.

"Truant minor" is defined as a chronic truant to whom supportive services, including prevention, diagnostic, intervention and remedial services, alternative programs and other school and community resources have been provided and have failed to result in the cessation of chronic truancy or have been offered and refused.

#### **TARDINESS**

A student is tardy to class when he is not in his assigned station and ready for work when the class bell rings. Passing times are three minutes in length - sufficient time to move to any other areas of the building without undue difficulty. The following procedures should be followed when you are late to class:

- 1. If you are <u>late in arriving to school</u>, report directly to the <u>office</u> for an admit slip to be marked present. Your admit slip will be marked excused or unexcused, depending upon the reason for your tardiness. There are few reasons for being tardy which are excusable; <u>however</u>, <u>many are understandable</u> and will result in little or no difficulty to the student or parent. <u>Habitual tardiness is another matter and will not be tolerated</u>. Every effort necessary to correct habitual tardiness will be made.
- 2. If you are detained by a teacher, secure an admit slip from that teacher and report to class. If you are tardy for any reason report directly to class. <u>Do not come to the office</u> since admit slips will not be issued. Each teacher shall determine the validity of the excuse and advise the student of such. Classroom teachers will assign reasonable punishment for being tardy to class.

Teachers will also keep a record of all students who are tardy and will report habitually tardy students to the office where corrective measures will be taken.

The principal shall make the determination if tardiness is becoming a pattern and will assign appropriate corrective measures such as:

- 1. The principal or classroom teacher will assign reasonable punishment.
- 2. The student may be assigned unexcused absences for one or more periods.
- 3. If the principal determines that a pattern of tardiness is established, the student may be suspended, barred from extracurricular activities, and/or parent conference arranged.

## TRUANCY POLICY

Student attendance is critical to the learning process. Truancy is therefore a serious issue and will be dealt with in a serious manner by the school and district. Students who miss 5% or more of the prior 180 regular school days without valid cause (a recognized excuse by the school or the state) are considered chronic truants. Students who are chronic truants will be offered support services and resources aimed at correcting the truancy issue. If chronic truancy persists after support services and other resources are made available, the school and district take further action, which may include the following:

- The truancy officer will conduct home visits
- Referral to the State's Attorney
- Appropriate school discipline

A parent or guardian who knowingly and willfully permits a child to be truant is in violation of state law. Parents, or persons having custody or control of a truant child may be fined up to \$500 and/or sentenced to thirty (30) days in jail for a class "C" misdemeanor when a child continues to violate the Illinois Compulsory Attendance Laws. If unexcused absences persist after available supportive services and other school resources have been exhausted, possible punitive action, including suspension, expulsion or court action will be taken.

The parent(s) or legal guardian should make every effort to make sure their child(ren) attend school regularly.

Consequences for Truancy: Once a student has been absent nine (9) days or has three (3) unexcused absences they will be subject to the following consequences as well as all district unexcused absence guidelines and policies: 4<sup>th</sup> unexcused absence: 1 day detention

5<sup>th</sup> unexcused absence: 1 day detention & truancy letter sent

6<sup>th</sup> unexcused absence: 2 days detention

7<sup>th</sup> unexcused absence: ½ day ACR (alternative classroom)

8<sup>th</sup> unexcused absence: 1 day ACR

9<sup>th</sup> unexcused absence: referred to Gallatin County States Attorney

Subsequent absences: 1-3 days ACR through out-of-school suspension 1-5 days

## SCHOOL OPERATIONS DURING A PANDEMIC OR OTHER HEALTH EMERGENCY

A pandemic is a global outbreak of disease. Pandemics happen when a new virus emerges to infect individuals and, because there is little to no pre-existing immunity against the new virus, it spreads sustainably. Your child's school and district play an essential role, along with the local health department and emergency management agencies, in protecting the public's health and safety during a pandemic or other health emergency.

During a pandemic or other health emergency, you will be notified in a timely manner of all changes to the school environment and schedule that impact your child. Please be assured that even if school is not physically in session, it is the goal of the school and district to provide your child with the best educational opportunities possible.

Additionally, please note the following:

- 1. All decisions regarding changes to the school environment and schedule, including a possible interruption of in-person learning, will be made by the superintendent in consultation with and, if necessary, at the direction of the Governor, Illinois Department of Public Health, local health department, emergency management agencies, and/or Regional Office of Education.
- 2. Available learning opportunities may include remote and/or blended learning. Blended learning may require your child to attend school on a modified schedule.
- 3. Students will be expected to participate in blended and remote instruction as required by the school and district. Parents are responsible for assuring the participation of their child. Students who do not participate in blended or remote learning will be considered truant.
- 4. All school disciplinary rules remain in effect during the interruption of in-person learning. Students are subject to discipline for disrupting the remote learning environment to the same extent that discipline would be imposed for disruption of the traditional classroom.

- 5. Students and parents will be required to observe all public health and safety measures implemented by the school and district in conjunction with state and local requirements.
- 6. During a pandemic or other health emergency, the school and district will ensure that educational opportunities are available to all students.
- 7. School personnel will work closely with students with disabilities and other vulnerable student populations to minimize the impact of any educational disruption.
- 8. Students who have a compromised immune system, live with an individual with a compromised immune system, or have a medical condition that may impact their ability to attend school during a pandemic or other public health emergency should contact school officials.
- 9. During a pandemic or other health emergency, teachers and school staff will receive additional training on health and safety measures.
- 10. In accordance with school district or state mandates, the school may need to conduct a daily health assessment of your child. Parents and students will be notified of the exact assessment procedures if this becomes necessary.
- 11. Parents should not send their child to school if their child exhibits any symptoms consistent with the pandemic or other health emergency.
- 12. Please do not hesitate to contact school or district officials if you have any concerns regarding your child's education, health or safety.

# SCHOOL BUS RIDERS INSTRUCTIONS

School bus riders, while in transit, are under the jurisdiction of the school bus driver unless the local board of education designates some adult to supervise the riders. Audio and video recordings may be used randomly on school buses.

To ensure the safety of students, unauthorized persons will not be allowed to ride a bus. This includes, but is not limited to, unregistered students, visiting students, and adults, unless authorized by the school administration in the form of a permission slip or through direct contact with the bus driver. Upon enrollment, a new student must get a bus pass from the office.

It is recommended that all riders, parents of riders, and teachers become thoroughly familiar with the following regulations governing school bus riders. This may be accomplished by giving each student a mimeographed copy of "Instructions to School Bus Riders".

- 1. Be on time at the designated school bus stop; help keep the bus on schedule.
- 2. Stay off the road at all times while waiting for the bus.
- 3. Be careful in approaching the place where the bus stops. Do not move toward the bus until the bus has been brought to a complete stop.
- 4. Do not leave your seat while the bus is in motion.
- 5. Be alert to a danger signal from the driver.
- 6. Remain in the bus in the event of a road emergency until the bus has been brought to a complete stop.
- 7. Keep hands and heads inside the bus at all times. Do not throw anything out of the bus.
- 8. Remember that unnecessary confusion diverts the driver's attention and could result in a serious accident.
- 9. Be absolutely quiet when approaching a railroad crossing.
- 10. Treat bus equipment as you would valuable furniture in your own home. Never tamper with the bus or any of its equipment.
- 11. Assist in keeping the bus safe and sanitary at all times.
- 12. Carry no animals on the bus without permission of the school transportation director and the superintendent and/or the principal.
- 13. Keep books, packages, coats, and all other objects out of the aisles.
- 14. Leave no books, lunches, or other articles on the bus.
- 15. Be courteous to fellow pupils and the bus driver.
- 16. Help look after the safety and comfort of smaller children.
- 17. Do not ask the driver to stop at places other than the regular bus stop. The driver is not permitted to do this, except by proper authorization from a school official.
- 18. Observe safety precautions at discharge point. Where it is necessary to cross the highway, proceed to a point at least 10 feet in front of the bus on the right shoulder of the highway where traffic may be observed in both directions. Wait for a signal from the bus driver permitting you to cross.

- 19. Observe the same rules and regulations on other trips under school sponsorship as you observe between home and school. Respect the wishes of the chaperone appointed by the school.
- 20. School officials will assign students to specific seats on the bus if necessary.
- 21. No eating, drinking, or chewing gum on the bus.

Students who do not conform to these rules and are in frequent violation of them will be dealt with in the following manner. A. School officials will confer with the student and the driver.

- B. School officials will confer with parents.
- C. If the above steps do not solve the problem, the student may lose his/her riding privileges for one week. D. If problems continue to exist, the student may lose his/her riding privileges for the remainder of the school year. 1. Safety is the most important issue concerning transportation of students.
- 2. If a student has discipline problems on the bus, the student and the driver will have a conference and try to resolve the problem. The driver will keep a record of said conference.
- 3. If a minor problem is report to the principal, he will have a conference with the student and send a copy of the conference results to the driver. The parents will be notified.
- 4. If a student is disrespectful or refuses to follow the directions of the driver, the student may be suspended and/or lose bus riding privileges. The parents will be notified.
  - 5. A student may be suspended from riding the bus for up to 10 consecutive school days for engaging in gross disobedience or misconduct, including but not limited to the following:
    - a) Violating any school rule or school district policy
    - b) Willful injury or threat of injury to a bus driver or to another rider
    - c) Willful and/or repeated defacement of the bus
    - d) Repeated use of profanity
    - e) Repeated willful disobedience of a directive from a bus driver or other supervisor
    - f) Such other behavior as the building principal deems to threatened the safe operation of the bus and/or its occupants

If a student is suspended from riding the bus for gross disobedience or misconduct on a bus, the School Board may suspend the student from riding the school bus for a period in excess of 10 days for safety reasons. A student suspended from riding the bus who does not have alternate transportation to school shall have the opportunity to complete or make up work for equivalent academic credit. It is the responsibility of the student's parent or guardian to notify the school that the student does not have alternate transportation.

# **SCHOOL LOCKERS**

A student's locker is the property of the school and must be used for the purpose intended: a storage area for books, school supplies, and outdoor garments. If school officials have a reasonable suspicion the student has placed illegal or dangerous materials or substances in the locker, school officials may then search the locker, with or without the student's knowledge or consent. In brief, students should not keep anything in their locker that they would not want anyone to find. All lockers are to be kept clean and orderly. Lockers should be cleaned out at least once every 9 weeks.

#### SCHOOL PRAYER

The Gallatin County CUSD #7 has no policy that prevents constitutionally protected prayer

#### **SEARCH & SEIZURE**

In order to maintain order, safety, and security in the schools, school authorities are authorized to conduct reasonable searches of school property and equipment, as well as of students and their personal effects. "School authorities" includes school liaison police officers.

School Property and Equipment as well as Personal Effects Left There by Students School authorities may inspect and search school property and equipment owned or controlled by the school (such as, lockers, desks, and parking lots), as well as personal effects left there by a student, without notice to or consent of the student. Students have no reasonable expectation of privacy in these places or areas or in their personal effects left there. The building principal may request the assistance of law enforcement officials to conduct inspections and searches of lockers, desks, parking lots, and other school property and equipment for illegal drugs, weapons, or other illegal or dangerous substances or materials, including searches conducted through the use of specially trained dogs.

## Students

School authorities may search a student and/or the student's personal effects in the student's possession (such as, purses, wallets, knapsacks, book bags, lunch boxes, etc.) when there is a reasonable ground for suspecting that the search will produce evidence the particular student has violated or is violating either the law or the school or district's student rules and policies. The search will be conducted in a manner that is reasonably related to its objective of the search and not excessively intrusive in light of the student's age and sex, and the nature of the infraction.

School officials may require a student to cooperate in an investigation if there is specific information about activity on the

student's account on a social networking website that violates the school's disciplinary rules or school district policy. In the course of the investigation, the student may be required to share the content that is reported in order for a school to make a factual determination. School officials may not request or require a student or his or her parent/guardian to provide a password or other related account information to gain access to the student's account or profile on a social networking website.

#### Seizure of Property

If a search produces evidence that the student has violated or is violating either the law or the school or district's policies or rules, evidence may be seized and impounded by school authorities, and disciplinary action may be taken. When appropriate, evidence may be transferred to law enforcement authorities.

#### Questioning of Students Suspected of Committing Criminal Activity

Before a law enforcement officer, school resource officer, or other school security person detains and questions on school grounds a student under 18 years of age who is suspected of committing a criminal act, the building principal or designee will: (a) Notify or attempt to notify the student's parent/guardian and document the time and manner in writing; (b) Make reasonable efforts to ensure the student's parent/guardian is present during questioning or, if they are not present, ensure that a school employee (including, but not limited to, a social worker, psychologist, nurse, guidance counselor, or any other mental health professional) is present during the questioning; and (c) If practicable, make reasonable efforts to ensure that a law enforcement officer trained in promoting safe interactions and communications with youth is present during the questioning.

# SCHOOL STUDENT RECORD NOTIFICATION STATEMENT

The building principal or his designee is the official records custodian of each building.

The following information pertains to the rights and obligations of parents, students, and the school under the Illinois School Students Records Act (ISSRA) Chapter 122, Par. 50-1 et seq. of the Illinois Revised Statutes (1985) and the Rules promulgated thereunder by the Illinois State Board of Education, which can be found at 23 Illinois Administrative Code 375.

- 1. The student permanent record consists of basic identifying information, academic transcript, attendance record, accident reports and health record, record of release of permanent record information, and may also consist of records of awards and participation in school-sponsored activities. No other information will be placed in the student permanent record. The permanent record will be kept for 60 years after graduation or permanent withdrawal. [ISSRA, Par. 50-2(e); 50-4(e)]
- 2. The student temporary record consists of all information that is of clear relevance to the education of the student, but is not required to be in the student's permanent record. It may include family background information, intelligence test scores, aptitude test scores, psychological and personality test results, and teacher evaluations. A record of release of temporary record information must be included in the student temporary record. The temporary record will be reviewed for elimination of out-of-date, inaccurate, or unnecessary information every 4 years or upon a student's change in attendance centers, whichever occurs first. The temporary record will be destroyed entirely within 5 years after graduation or permanent withdrawal. (ISSRA, Par. 50-2(f); Rules, Section 375.10)
- 3. Parents or any person specifically designated as a representative by a parent have the right to: A. Inspect and copy all permanent and temporary records within a reasonable time and in no case later than 15 days after the date of receipt of such request by the official records custodian. A student shall have the right to inspect and copy his or her school student permanent record. The school charges \$.35 per page for copies. No parent or student shall be denied a copy of school student records due to inability to bear the cost of such copying. (ISSRA, Par. 50-5)
- B. Have present at the option of either the parent or the school, a qualified professional, who may be a psychologist, counselor, or other advisor, and who may be an employee of the school or employed by the parent, to interpret the information contained in the student temporary record. If the school requires that a professional be present, the school shall secure and bear any cost of the presence of the professional. If the parent so requests, the school shall secure and bear any cost of the presence of a professional

employed by the school. [ISSRA, Par. 50-0(b)]

- C. Challenge the accuracy, relevancy or propriety of any entry in the school student records, exclusive of grades, by requesting a hearing with the school.
- (i) The request for a hearing shall be submitted in writing to the school and shall contain a notice of the specific entry or entries to be challenged and the basis of the challenge.
  - (II) An informal conference will be held within 15 school days of receipt of the request for a hearing. (III) If the challenge is not resolved by the informal conference, a formal hearing shall be innate. (IV) Formal hearing: A hearing officer, who is not employed in the attendance center in which the student

is enrolled, shall be appointed by the school and shall conduct a hearing within a reasonable time but no later than 15 days after the informal conference, unless an extension of time is agreed upon by the parents and school officials. The hearing office shall notify the parents and school officials of the time

and place of the hearing. Each party shall have the right to present evidence and to call witnesses, the right to cross-examine witnesses, and the right to counsel. A record of the hearing shall be made by tape recording or court reporter. The decision of the hearing officer shall be rendered no later than 10 school days after the conclusion of the hearing and shall be transmitted to the parents and the school district. The hearing officer's

decision shall be based solely on the evidence presented at the hearing and shall order a) retention of the challenged contents of the student record; or b) removal of the challenged contents of the student record, or c) change, clarification, or addition to the challenged contents of the student record. The parties shall have the right to appeal the decision of the hearing officer to the Regional Superintendent of Schools.

- (V) Appeal: Notice of appeal must be presented to the Regional Superintendent of Schools within 20 school days after the decision of the hearing officer. The opposing party shall be notified of the appeal at the same time. Within 10 school days, the school shall forward a transcript of the hearing, a copy of the record entry in question and any other pertinent materials to the Regional Superintendent of Schools. Upon receipt of such documents, the Regional Superintendent of Schools shall examine the documents and record, make findings, and issue a decision to the parents and the school district within 20 school days of receipt of the documents. If the subject of the appeal involves the accuracy, relevance or propriety of any entry in special education records, the Regional Superintendent of Schools should seek advice from appropriate special education personnel who were not authors of the entry. The school shall be responsible for implementing the decision of the Regional Superintendent of Schools. Such decision shall be final, and may be appealed to the Circuit Court of the county in which the school is located. (ISSRA Par. 50-7; Rules, Section 375.90)
- 4. No school records or information contained therein may be released, transferred, disclosed or otherwise disseminated, except as follows:
  - a. to a parent or student or person specifically designated as a representative by a parent; [ISSRA, Par. 50-6(a)(1)]
  - b. to an employee or official of the school or school district or the State Board of Education with a current demonstrable educational or administrative interest in the student, in furtherance of such interest; [ISSRA, Par. 50-6(a)(1)]
  - c. to the official records custodian of another school in which the student has enrolled or intends to enroll, provided that the parent receives prior written notice of the nature and substance of the information to be transferred and opportunity to inspect, copy and challenge such information. If the address of the parents is unknown, notice may be served upon the records custodian of the requesting school for transmittal to the parents. Such service shall be deemed conclusive; and ten school days after such service, if the parents make no objection, the records may be transferred to the requesting school; [ISSRA, Par. 50-6(a)(3); Rules, Section 375.70(a)]
- d. to any person for the purpose of research, statistical reporting or planning, provided that no student or parent can be identified from the information released and the person(s) requesting the use of such information has signed an affidavit agreeing to comply with all rules and statutes regarding school records; [ISSRA, Par. 50-6(a)(4); Rules, Section 357.70(d)(2)]
- e. pursuant to a court order--provided that the parent shall be given prompt written notice upon receipt of such order, of the terms of the order, the nature and substance of the information proposed to be released in compliance with such order and an opportunity to inspect, copy and challenge the contents of the school student records; [ISSRA, Par. 50-6(a)(5); Rules, Section 375.70(c)(3)]
- f. to any person as specifically required by state or federal law, provided that such person shall provide the school with appropriate identification and a copy of the statute authorizing such access and that the parent receives prior written notice of the nature and substance of the information to be released and an opportunity to inspect, copy and challenge such information. If the release of information relates to more than 25 students, such prior notice may be given in a local newspaper of general circulation or other publication

directed generally to parents; [ISSRA, Par. 50-6(a)(6); Rules, Section 375.70(b)]

- g. subject to regulations of the State Board, in connection with an emergency to appropriate persons if the knowledge of such information is necessary to protect the health and safety of the student or other persons, provided that the parents are notified as soon as possible of the information released, the date of release, the person, agency or organization receiving the information, and the purpose of the release; (ISSRA, Par. 40-6(a)(7); Rules, Section 375.60)
- h. to any person with the prior specific, dated, and written consent of the parent designating the person to whom the records or designated portions of the information to be released. The parent has the right to inspect, copy and challenge the records or designated portions of the information contained within the records or designated portions of the information contained within the records; [ISSRA, Par. 50-6(a)(8); Rules, Section 375.70(d)]
- 5. Parents may insert their child's school student record a statement of reasonable length setting forth their position on any disputed information contained in that record. The school shall include a copy of such statement in any subsequent dissemination of the information in dispute. [ISSRA, Par. 50-7(d)] 6. Parents will be given reasonable prior notice before any school student record is destroyed or information deleted there from and an opportunity to copy the record or information proposed to be destroyed or deleted. [ISSRA, Par. 50-4(h)]
- 7. Except for the student and his parents, no person to whom information is released and no person specifically designated as a representative by a parent may permit any other person to have access to such information without prior consent of the parent obtained in accordance with ISSRA, Par. 50-6(a)(8). [ISSRA Section 50-6(d)] 8. A record of any release of information shall be maintained for the life of the school student records and shall be available only to the parents and the official records custodian. The record of release shall include the nature and substance of the information released, the name of the person requesting such information, the capacity in which such a request has been made, the purpose of such a request, the date of the release, the name and signature of the official records custodian releasing such information, and a copy of any consent to such release. [ISSRA, Par. 50-6(c)]

- 9. All rights and privileges accorded a parent under the ISSRA shall be come exclusively those of the student upon his 18<sup>th</sup> birthday, graduation from secondary school, marriage, or entry into military service, whichever occurs first. Such rights and privileges may also be exercised by the student at any time with respect to the student's permanent school record. [ISSRA, Par. 50-2(g)]
- 10. The following is designed as a directory information and may be released to the general public unless the parent requests that any or all such information not be released: student's name and address, academic awards, degrees and honors; information in relation to school-sponsored activities, organizations and athletics, the student's major field of study; and period of attendance in the school. (ISSRA, Par. 50(e); Rules, Section 375.80)
- 11. No person may condition the granting or withholding of any right, privilege, or benefit or make as a condition of employment, credit, or insurance the securing by any individual of any information from a student's temporary record which such individual may obtain through the exercise of any right secured under the Illinois School Student Records Act. (ISSRA, Par. 50-8)
- 12. Upon graduation or permanent withdrawal of a handicapped student, psychological evaluations, special education files, and other information contained in the temporary record which may be of continued assistance to the student may, after five years, be transferred to the custody of the parent or student if the student has succeeded to the rights of the parents. The school will explain to the student and the parent the future usefulness of psychological evaluations, special education files, and other information contained in the student temporary record. [Rules, Section 375.40(d)]
- 13. Any policies of the school relating to school student records which are not included in the Act or Rules. 14. Copies of the Illinois School Student Records Act, Chapter 23, Illinois Administrative Code 375 (Student Records), and the district or school policies relating to school student records which are not included in the Act or the Rules are available for review in the office of the school records custodian and the district superintendent.
- 15. The Wabash and Ohio Valley Special Education District at Norris City, Illinois is the official and legal custodian of all special education records for Gallatin County Community Unit District #7.

## **SCHOOL RECORDS**

A school student record is any writing or other recorded information concerning a student and by which a student may be identified individually that is maintained by a school or at its direction or by a school employee, regardless of how or where the information is stored, except for certain records kept in a staff member's sole possession; records maintained by law enforcement officers working in the school; video and other electronic recordings (including electronic recordings made on school busses) that are created in part for law enforcement, security, or safety reasons or purposes, though such electronic recordings may become a student record if the content is used for disciplinary or special education purposes regarding a particular student.

The Family Educational Rights and Privacy Act (FERPA) and the Illinois Student Records Act afford parents/guardians and students over 18 years of age ("eligible students") certain rights with respect to the student's school records. They are:

- 1. The right to inspect and copy the student's education records within 10 business days of the day the District receives a request for access.
  - The degree of access a student has to his or her records depends on the student's age. Students less than 18 years of age have the right to inspect and copy only their permanent record. Students 18 years of age or older have access and copy rights to both permanent and temporary records. A parent/guardian or student should submit to the building principal a written request that identifies the record(s) he or she wishes to inspect. Within 10 business days, the building principal will make arrangements for access and notify the parent/guardian or student of the time and place where the records may be inspected. In certain circumstances, the District may request an additional 5 business days in which to grant access. The District charges \$.35 per page for copying but no one will be denied their right to copies of their records for inability to pay this cost. These rights are denied to any person against whom an order of protection has been entered concerning the student.
- The right to have one or more scores received on college entrance examinations included on the student's academic transcript.1
   Parents/quardians or eligible students may have one or more scores on college entrance
  - examinations included on the student's academic transcript. The District will include scores

on college entrance examinations upon the written request of the parent/guardian or eligible student stating the name of each college entrance examination that is the subject of the request and the dates of the scores that are to be included.

- 3. The right to request the amendment of the student's education records that the parent/guardian or eligible student believes are inaccurate, irrelevant, or improper.

  A parent/guardian or eligible student may ask the District to amend a record that is believed to be inaccurate, irrelevant, or improper. Requests should be sent to the building principal and should clearly identify the record the parent/guardian or eligible student wants changed and the specific reason a change is being sought. If the District decides not to amend the record, the District will notify the parent/guardian or eligible student of the decision and advise him or her of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent/guardian or eligible student when notified of the right to a hearing.
- 4. The right to permit disclosure of personally identifiable information contained in the student's education records, except to the extent that the FERPA or Illinois School Student Records Act authorizes disclosure without consent.

Disclosure without consent is permitted to school officials with legitimate educational or administrative interests. A school official is a person employed by the District as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the School Board. A school official may also include a volunteer, contractor, or consultant who, while not employed by the school, performs an institutional service or function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of personally identifiable information from education records (such as an attorney, auditor, medical consultant, therapist, or educational technology vendor); or any parent/guardian or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility or contractual obligation with the district. Upon request, the District discloses education records without consent to officials of another school district in which a student has enrolled or intends to enroll, as well as to any person as specifically required by State or federal law. Before information is released to these individuals, the parents/guardians or eligible student will receive prior written notice of the nature and substance of the information, and an opportunity to inspect, copy, and challenge such records. Academic grades and references to expulsions or out-of-school suspensions cannot be challenged at the time a student's records are being forwarded to another school to which the student is transferring.

Disclosure is also permitted without consent to: any person for research, statistical reporting or planning, provided that no student or parent/guardian can be identified; any person named in a court order; appropriate persons if the knowledge of such information is necessary to protect the health or safety of the student or other persons; and juvenile authorities when necessary for the discharge of their official duties who request information before adjudication of the student.

- 5. The right to a copy of any school student record proposed to be destroyed or deleted. The permanent record is maintained for at least 60 years after the student transfers, graduates, or permanently withdraws. The temporary record is maintained for at least 5 years after the student transfers, graduates, or permanently withdraws. Temporary records that may be of assistance to a student with a disability who graduates or permanently withdraws, may, after 5 years, be transferred to the parent/guardian or to the student, if the student has succeeded to the rights of the parent/guardian. Student temporary records are reviewed every 4 years or upon a student's change in attendance centers, whichever occurs first
- 6. The right to prohibit the release of directory information.

Throughout the school year, the District may release directory information regarding students, limited to:• Name

- Address
- · Grade level

- Birth date and place
- · Parent/quardian names, addresses, electronic mail addresses, and telephone numbers
- Photographs, videos, or digital images used for informational or news-related purposes (whether by a media outlet or by the school) of a student participating in school or school-sponsored activities, organizations, and athletics that have appeared in school publications, such as yearbooks, newspapers, or sporting or fine arts programs
- Academic awards, degrees, and honors
- · Information in relation to school-sponsored activities, organizations, and athletics
- Major field of study
- Period of attendance in schoolAny parent/guardian or eligible student may prohibit the release of any or all of the above information by delivering a written objection to the building principal within 30 days of the date of this notice.
- 7. The right to request that military recruiters or institutions of higher learning not be granted access to your student's information without your prior written consent.2

  Federal law requires a secondary school to grant military recruiters and institutions of higher learning, upon their request, access to secondary school students' names, addresses, and telephone numbers, unless the student's parent/guardian, or student who is 18 years of age or older, submits a written request that the information not be released without the prior written consent of the parent/guardian or eligible student. If you wish to exercise this option, notify the building principal.
- 8. The right contained in this statement: No person may condition the granting or withholding of any right, privilege or benefits or make as a condition of employment, credit, or insurance the securing by any individual of any information from a student's temporary record which such individual may obtain through the exercise of any right secured under State law.
- 9. The right to file a complaint with the U.S. Department of Education concerning alleged failures by the District to comply with the requirements of FERPA.

# SCHOOL VISITATION RIGHTS ACT

The School Visitation Rights Act permits employed parents/guardians, who are unable to meet with educators because of a work conflict, the right to time off from work under certain conditions to attend necessary school functions such as parent-teacher conferences, academic meetings and behavioral meetings. Letters verifying participation in this program are available from the school office upon request.

#### SECURITY CAMERAS

For the safety and security of our students, security cameras have been installed inside the school as well as around the exterior of the building. Security cameras will be in operation 24 hours a day.

## STUDENT BIOMETRIC INFORMATION

Before collecting biometric information from students, the school must seek the permission of the student's parent/guardian or the student, if over the age of 18. Biometric information means information that is collected from students based on their unique characters, such as a fingerprint, voice recognition or retinal scan.

## **Education of Children with Disabilities**

It is the intent of the district to ensure that students who are disabled within the definition of Section 504 of the Rehabilitation Act of 1973 or the Individuals with Disabilities Education Act are identified, evaluated and provided with appropriate educational services.

The School provides a free appropriate public education in the least restrictive environment and necessary related services to all children with disabilities enrolled in the school. The term "children with disabilities" means children between ages 3 and the day before their  $22^{nd}$  birthday for whom it is determined that special education services are needed. It is the intent of the school to ensure that students with disabilities are identified, evaluated, and provided with appropriate educational services.

A copy of the publication "Explanation of Procedural Safeguards Available to Parents of Students with Disabilities" may be obtained from the school district office.

Students with disabilities who do not qualify for an individualized education program, as required by the federal Individuals with Disabilities Education Act and implementing provisions of this Illinois law, may qualify for services under Section 504 of the federal Rehabilitation Act of 1973 if the student (i) has a physical or mental impairment that substantially limits one or more major life activities, (ii) has a record of a physical or mental impairment, or (iii) is regarded as having a physical or mental impairment.

# **Accommodating Individuals with Disabilities**

Individuals with disabilities will be provided an opportunity to participate in all school-sponsored services, programs, or activities. Individuals with disabilities should notify the superintendent or building principal if they have a disability that will require special assistance or services and, if so, what services are required. This notification should occur as far in advance as possible of the school-sponsored function, program, or meeting.

#### SPECIAL EDUCATION: IEP Service Log

For a child with an individualized education program (IEP), the school district must create related service logs that

record the type of related services administered under the child's IEP and the minutes of each type of related service that has been administered. These related service logs will be available to parents/guardians at a student's annual review IEP meeting. Parents/guardians may also request a copy of any IEP related service log maintained for their child. ## STUDENT BEHAVIOR GUIDELINES

Students are expected to conduct themselves in a manner which reflects respect for each other, for their teachers, staff members, and school facilities. Students may be disciplined for misconduct which occurs on school buses, in school buildings, or on school grounds at any time, on the way to and from school, at bus stops, at school-sponsored activities whether or not held on the grounds of the school district, while being transported to and from school sponsored activities or events. Students may also be disciplined when the misconduct is directed against school employees, their families, or their property because of their status as employees.

The consequences stated are recommended as a guide in determining the disciplinary action for student violations. This in no way implies that these consequences must be followed sequentially, or that other or more severe actions cannot be taken. Each disciplinary case will be handled appropriately at the discretion of the administrator in charge.

EXPULSION or Alternative Placement SUSPENSION ALTERNATIVE CLASSROOM (ACR) DETENTION

#### **Prohibited Student Conduct**

Students may be disciplined for gross disobedience or misconduct, including but not limited to the following: 1. Using, possessing, distributing, purchasing, selling or offering for sale tobacco or nicotine materials, including electronic cigarettes or e-cigarettes. vapes, vape pens, or other vaping related products. 2. Using, possessing, distributing, purchasing, or selling alcoholic beverages. Students who are under the influence of alcoholic beverages are not permitted to attend school or school functions and are treated as though they had alcohol in their possession.

- 3. Using, possessing, distributing, purchasing, selling or offering for sale:
  - a. Any illegal drug, controlled substance, or cannabis (including marijuana, hashish, and medical cannabis unless the student is authorized to be administered a medical cannabis infused product under Ashley's Law). b. Any anabolic steroid unless it is being administered in accordance with a physician's or licensed practitioner's prescription.
  - c. Any performance-enhancing substance on the Illinois High School Association's most current banned substance list unless administered in accordance with a physician or licensed practitioner's prescription. d. Any prescription drug when not prescribed for the student by a physician or licensed practitioner, or when used in a manner inconsistent with the prescription or prescribing physician or licensed practitioner's instructions. The use or possession of medical cannabis, even by a student for whom medical cannabis has been prescribed, is prohibited unless the student is authorized to be administered a medical cannabis infused product under Ashley's I aw
  - e. Any inhalant, regardless of whether it contains an illegal drug or controlled substance: (a) that a student believes is, or represents to be capable of, causing intoxication, hallucination, excitement, or dulling of the brain or nervous system; or (b) about which the student engaged in behavior that would lead a reasonable person to believe that the student intended the inhalant to cause intoxication, hallucination, excitement, or dulling of the brain or nervous system. The prohibition in this section does not apply to a student's use of asthma or other legally prescribed inhalant medications.
  - f. "Look-alike" or counterfeit drugs, including a substance that is not prohibited by this policy, but one: (a) that a student believes to be, or represents to be, an illegal drug, controlled substance, or other substance that is prohibited by this policy; or (b) about which a student engaged in behavior that would lead a reasonable person to believe that the student expressly or impliedly represented to be an illegal drug, controlled substance or other substance that is prohibited by this policy.
  - g. Drug paraphernalia, including devices that are or can be used to: (a) ingest, inhale, or inject cannabis or controlled substances into the body; and (b) grow, process, store, or conceal cannabis or controlled substances. h. Any substance inhaled, injected, smoked, consumed or otherwise ingested or absorbed with the intention of causing a physiological or psychological change in the body, including without limitation, pure caffeine in a tablet or powdered form.
- 4. Students who are under the influence of any prohibited substance are not permitted to attend school or school functions and are treated as though they have the prohibited substance, as applicable, in their possession.
- 5. Using, possessing, controlling or transferring a "weapon" or violating the procedures listed below under the Weapons Prohibition section of this handbook procedure.
- 6. Using or possessing an electronic paging device.
- 7. Using a cellular telephone, smartphone, video recording device, personal digital assistant (PDA), or similar electronic device in any manner that disrupts the educational environment or violates the rights of others, including using the device to take photographs in locker rooms or bathrooms, cheat, or otherwise violate student conduct rules. Prohibited conduct specifically includes, without limitation, creating and sending, sharing, viewing, receiving or possessing an indecent visual depiction of oneself or another person through the use of a computer, electronic communication device or cellular telephone, commonly known as "sexting." Unless otherwise banned under this policy or by the building principal, all cellular phones, smartphones and other electronic devices must be kept powered-off and out-of-sight during the regular school day unless: (a) the supervising teacher grants permission; (b) use of the device is provided in a student's individualized education program (IEP); (c) it is used during the student's lunch period; or (d) it is needed in an emergency that threatens the safety of students, staff, or other individuals.
- 8. Using or possessing a laser pointer unless under a staff member's direct supervision and in the context of instruction.
- 9. Disobeying rules of student conduct or directives from staff members or school officials. Examples of disobeying staff

directives include refusing a staff member's request to stop, present school identification or submit to a search. 10. Engaging in academic dishonesty, including cheating, intentionally plagiarizing, wrongfully giving or receiving help during an academic examination, altering report cards and wrongfully obtaining test copies or scores. 11. Engaging in bullying, hazing or any kind of aggressive behavior that does physical or psychological harm to a staff person or another student or encouraging other students to engage in such behavior. Prohibited conduct specifically includes, without limitation, any use of violence, intimidation, force, noise, coercion, threats, stalking, harassment, sexual harassment, public humiliation, theft or destruction of property, retaliation, hazing, bullying, bullying using a school computer or a school computer network or other comparable conduct. 12. Engaging in any sexual activity, including without limitation, offensive touching, sexual harassment, indecent exposure (including mooning) and sexual assault.

- 13. Engaging in teen dating violence.
- 14. Causing or attempting to cause damage to, stealing, or attempting to steal, school property or another person's personal property.
- 15. Entering school property or a school facility without proper authorization.
- 16. In the absence of a reasonable belief that an emergency exists, calling emergency responders (calling 9-1-1); signaling or setting off alarms or signals indicating the presence of an emergency; or indicating the presence of a bomb or explosive device on school grounds, school bus or at any school activity.
- 17. Being absent without a recognized excuse.
- 18. Being involved with any public school fraternity, sorority, or secret society.
- 19. Being involved in a gang or engaging in gang-like activities, including displaying gang symbols or paraphernalia. 20. Violating any criminal law, including but not limited to, assault, battery, arson, theft, gambling, eavesdropping, vandalism and hazing.
- 21. Engaging in any activity, on or off campus, that interferes with, disrupts, or adversely affects the school environment, school operations, or an educational function, including but not limited to, conduct that may reasonably be considered to: (a) be a threat or an attempted intimidation of a staff member; or (b) endanger the health or safety of students, staff, or school property.
- 22. Making an explicit threat on an Internet website against a school employee, a student, or any school-related personnel if the Internet website through which the threat was made is a site that was accessible within the school at the time the threat was made or was available to third parties who worked or studied within the school grounds at the time the threat was made, and the threat could be reasonably interpreted as threatening to the safety and security of the threatened individual because of his or her duties or employment status or status as a student inside the school.
- 23. Operating an unarmed aircraft system (AUS) or drone for any purpose on school grounds or at any school event unless granted permission by the building principal.

For purposes of these rules, the term "possession" includes having control, custody, or care, currently or in the past, of an object or substance, including situations in which the item is: (a) on the student's person; (b) contained in another item belonging to, or under the control of the student, such as in the student's clothing, backpack, or automobile; (c) in a school's student lockers, desks, or other school property; (d) at any location on school property or at a school-sponsored event; or (e) in the case of drugs and alcohol, substances ingested by the person.

Efforts, including the use of positive interventions and supports shall be made to deter students, while at school or a school-related event, from engaging in aggressive behavior that may reasonably produce physical or psychological harm to someone else.

No disciplinary action shall be taken against any student that is based totally or in part on the refusal of the student's parent/guardian to administer or consent to the administration of psychotropic or psychostimulant medication to the student.

#### When and Where Conduct Rules Apply

The grounds for disciplinary action also apply whenever the student's conduct is reasonably related to school or school activities, including but not limited to:

- 1. On, or within sight of, school grounds before, during, or after school hours or at any time;
- 2. Off school grounds at a school-sponsored activity or event, or any activity or event that bears a reasonable relationship to school;
- 3. Traveling to or from school or a school activity, function, or event; or
- 4. Anywhere, if the conduct interferes with, disrupts, or adversely affects the school environment, school operations, or an educational function, including but not limited to, conduct that may reasonably be considered to: (a) be a threat or an attempted intimidation of a staff member; or (b) endanger the health or safety of students, staff,or school property or
- 5. During periods of remote learning.

#### Disciplinary Measures

School officials shall limit the number and duration of expulsions and out-of-school suspensions to the greatest extent

practicable, and, where practicable and reasonable, shall consider forms of non-exclusionary discipline before using out-of-school suspensions or expulsions. School personnel shall not advise or encourage students to drop out of school voluntarily due to behavioral or academic difficulties. Potential disciplinary measures include, without limitation, any of the following measures:

- 1. Notifying parents/guardians.
- 2. Disciplinary conference.
- 3. Withholding of privileges.
- 4. Temporary removal from the classroom.
- 5. Return of property or restitution for lost, stolen or damaged property.
- 6. In-school suspension.
- 7. After-school study or Saturday study provided the student's parent/guardian has been notified. (If transportation arrangements can not be made in advance, an alternative disciplinary measure will be assigned to the student.
- 8. Community service.
- 9. Seizure of contraband; confiscation and temporary retention of the personal property that was used to violate school rules.
- 10. Suspension of bus riding privileges.
- 11.Suspension from school and all school activities for up to 10 days. A suspended student is prohibited from being on school grounds.
- 12. Expulsion from school and all school activities for a definite time period not to exceed 2 calendar years. An expelled student is prohibited from being on school grounds.
- 13. Transfer to an alternative program if the student is expelled or otherwise qualifies for transfer under State law.
- 14. Notifying juvenile authorities or other law enforcement whenever the conduct involves criminal activity, such as, illegal drugs (controlled substances), "look-alikes," alcohol or weapons or in other circumstances as authorized by the reciprocal reporting agreement between the District and local law enforcement agencies.

The above list of disciplinary measures is a range of options that will not always be applicable in every case. In some circumstances, it may not be possible to avoid suspending or expelling a student because behavioral interventions, other than a suspension or expulsion, will not be appropriate and available, and the only

reasonable and practical way to resolve the threat and/or address the disruption is a suspension or expulsion.

#### Isolated Time Out, Time Out and Physical Restraint

Isolated time out, time out, and physical restraint shall only be used if the student's behavior presents an imminent danger of serious physical harm to the student or others and other less restrictive and intrusive measures were tried and proven ineffective in stopping it. The school may not use isolated time out, time out, and physical restraint as discipline or punishment, convenience for staff, retaliation, a substitute for appropriate educational or behavioral support, a routine safety matter, or to prevent property damage in the absence of imminent danger of serious physical harm to the student or others.

#### Corporal Punishment

Corporal punishment is illegal and will not be used. Corporal punishment is defined as slapping, paddling, or prolonged maintenance of students in physically painful positions, or intentional infliction of bodily harm. Corporal punishment does not include reasonable force as needed to maintain safety for students, staff, or other persons, or for the purpose of self-defense or defense of property.

#### Weapons Prohibition

A student who is determined to have brought one of the following objects to school, any school-sponsored activity or event, or any activity or event that bears a reasonable relationship to school shall be expelled for a period of not less than one year but not more than 2 calendar years:

A student who is determined to have brought one of the following objects to school, any school-sponsored activity or event, or any activity or event that bears a reasonable relationship to school shall be expelled for a period of not less than one year but not more than 2 calendar years:

- (1) A firearm, meaning any gun, rifle, shotgun, a weapon as defined by Section 921 of Title 18 of the United States Code, firearm as defined in Section 1.1 of the Firearm Owners Identification Card Act, or firearm as defined in Section 24-1 of the Criminal Code of 1961. The expulsion period may be modified by the superintendent, and the superintendent's determination may be modified by the board on a case-by-case basis.
- (2) A knife, brass knuckles or other knuckle weapon regardless of its composition, a billy club, or any other object if used

or attempted to be used to cause bodily harm, including "look alikes" of any firearm as defined above.

The expulsion requirement may be modified by the superintendent, and the superintendent's determination may be modified by the board on a case-by-case basis.

# **Gang & Gang Activity Prohibited**

"Gang" is defined as any group, club or organization of two or more persons whose purposes include the commission of illegal acts. No student on or about school property or at any school activity or whenever the student's conduct is reasonably related to a school activity, shall: (1) wear, possess, use, distribute, display, or sell any clothing, jewelry, paraphernalia or other items which reasonably could be regarded as gang symbols; commit any act or omission, or use either verbal or non-verbal gestures, or handshakes showing membership or affiliation in a gang; or (2) use any speech or commit any act or omission in furtherance of the interest of any gang or gang activity, including, but not limited to, soliciting others for membership in any gangs; (3) request any person to pay protection or otherwise intimidate, harass or threaten any person; (4) commit any other illegal act or other violation of district policies, (5) or incite other students to act with physical violence upon any other person.

## Re-Engagement of Returning Students

The building principal or designee shall meet with a student returning to school from an out-of-school suspension, expulsion or alternative school setting. The goal of this meeting shall be to support the student's ability to be successful in school following a period of exclusion and shall include an opportunity for students who have been suspended to complete or make-up missed work for equivalent academic credit.

#### STUDENT COUNCIL

Students may be appointed to the Student Council if deemed worthy by the principal.

#### STUDENT GRIEVANCE PROCEDURE

A grievance is a difference of opinion raised by a student or group of students involving: (1) the meaning, interpretation or application of established policies; (2) difference of treatment; or (3) application of the legal requirements of civil rights legislation.

This procedure is not intended to limit the option of the district and a grievant(s) to resolve any grievance mutually and informally. Hearing and conferences under this procedure shall be conducted at a time and place which will afford a fair and equitable opportunity for all persons.

The following grievance procedure is not required if the grievant(s) prefers other alternatives such as the Office of Civil Rights (OCR) or the courts. Due process shall exist throughout the procedure with the right to: (1) representation; (2) present witnesses and evidence; (3) confidentiality; (4) review relevant records; and (5) proceed without harassment and/or retaliation. More detailed information is available in the office of the superintendent and the building principal. Time limits refer to days when school is in session.

STEP I: The student(s) and/or parent(s) should discuss the matter with the person(s) directly responsible for the grievance issue within fourteen (14) days of the time when a reasonably alert person should have been aware of the event giving rise to a grievance. An oral response must be made within five (5) days.

STEP II: If the grievance is not resolved, it should be submitted in writing within five (5) days to the building principal. The grievance should be described as specifically and completely as possible. A thorough investigation of the issue will be documented. Extra investigation of the issue will be held between the grievant and district representative within ten (10) days and a written response made within five (5) days.

STEP III: If a satisfactory solution is not reached, the grievant(s) may appeal the issue in writing to the office of the superintendent of designer within five (5) days from the receipt of the response of Step II. A meeting between the parties will be held within ten (10) days and a written response made within five (5) days. A complete record of this meeting shall be kept and signed by both parties for possible future reference.

STEP IV: If the issue is not satisfactorily resolved on Step III, the grievant(s) may appeal the grievance in writing to the school board within five (5) days from the receipt of the written response. The board shall consider the appeal within sixty (60) days and a written response shall be given within five (5) days.

## REPORTING CONCERNS

If a parent/guardian should have a problem regarding a teacher or the school we ask that the following school

#### procedure be followed:

First, approach the teacher. Often, a simple misunderstanding can be cleared up quickly and easily. If the matter cannot be resolved through a meeting with the Teacher, the Principal is the next point of contact. Then, if the matter needs to be taken further, parents/guardians can go to the District Superintendent. If no resolve parents may choose to fill out the required paperwork with the Superintendent's office and be added to the public comment section of the next regularly scheduled school board meeting. Venting on social media is never recommended and will only exacerbate the situation. Remember a negative comment about a teacher or school posted on social media can prove very costly if legal action would be taken. The teacher or school does not have to be named if the comments can be pieced together to work out who is being spoken about; that is sufficient evidence of defamation. When posting on social media during or at the end of the day, it really is all about respect, and teaching our children that adults do not always have to agree, however, adults need to be able to show respect to one another, failing to do so will prove detrimental to everyone involved. Parents/guardians and teachers need to lead by example.

# STUDENT MESSAGES/ARRANGEMENTS

Phone messages from parents will be given to students by the office staff in emergencies. Parents should make every attempt to instruct students about where to go or what to do after school before the students leave home each morning. Please do not expect the office staff to deliver unnecessary messages that should have or could have been given to the student before he/she left home. Parents and guardians are reminded that they must send a note in the morning on the day their child will be riding a different bus. Unless it is an emergency, please do not call the school with a bus pass request. Emergency arrangements should be made before 1:00 p.m. The Jr. High office will be serving approximately 210 students so your cooperation is both needed and sincerely appreciated.

#### STUDENT PARKING LOT REGULATIONS

The following parking lot regulations will be strictly adhered to:

- 1. Parking is strictly limited to the student parking area.
- 2. Students are not to loiter in the parking lot. Students are not to sit in parked cars. Upon arrival at school, students are to leave their vehicles and enter the building to their designated areas. 3. The parking lot and vehicles are off-limits until school is dismissed at the end of the day. 4. All vehicles must be covered by insurance. The school is not responsible for automobiles and their contents.
- 5. Students vehicles are subject to search if there are reasonable grounds to believe that drugs, alcohol, weapons, stolen property or other contraband might be present in a vehicle.
- 6. Parking regulations are enforced. <u>IT IS CONSIDERED A PRIVILEGE TO DRIVE AND PARK ON SCHOOL GROUNDS! IT IS NOT A RIGHT!</u> Any violation of the above guidelines may result in the suspension of driving privileges, towing of vehicles, and/or suspension from school. 7. Junior High students will not drive vehicles to school.

#### STUDENT'S RIGHT AND RESPONSIBILITIES

#### **RIGHTS**

- 1. Each student has the right to pursue an education.
- 2. Each student has the right to express opinions verbally or in writing.
- 3. Each student has the right to dress in such a way as to express the student's personality. 4. Each student has the right to expect that the school will be a safe place for all students to gain an education.
- 5. Each student has the right to expect to assist in making decisions concerning his own educational goals.
- 6. In case of suspensions and expulsions, the student who is disciplined has the rights provided by the School Code, Constitutional due process, and the policies adopted by Unit #7.

#### RESPONSIBILITIES

- 1. Each student must not hamper any other student from pursuing an education.
- 2. Express opinions and ideas in a respectful manner so as not to offend or slander others. 3. Dress so as to meet recognized standards of health and safety and not to the detriment of the educational process.
- 4. Be aware of all rules and expectations regulating student behavior and conduct and to follow the guidelines established in this code.
- 5. Participating positively in learning situations.
- 6. Be willing to volunteer information in disciplinary cases should the student have knowledge of importance in such a case.

### SUSPENSION AND EXPULSION

### I. GENERAL

- A. Students committing acts of gross disobedience or misconduct may be suspended or expelled from school. Any student suspended from school or riding the bus shall have the opportunity to complete or make up work for equivalent academic credit.
- B. Authority to suspend a student is delegated to the superintendent and principals.
- C. Suspension is defined to mean an exclusion of a student from school or from riding the bus for a period of time not to exceed the (10) school days by summary action of the superintendent or principals. D. Expulsion is defined to mean exclusion of a student from school or from riding the bus for a period of time, up to a maximum of two schools years by the Board of Education. Expulsion may be preceded by suspension. E. School personnel includes employees, teachers, administrators, school board members, school bus drivers, and other school district employees and students where the term is appropriate.

### II. DEFINITION OF GROSS DISOBEDIENCE OR MISCONDUCT

Gross disobedience or misconduct may be grounds for suspension or expulsion. Such conduct may occur on school grounds, on a school bus or at a school function. Such conduct may also occur outside the school grounds provided there is a direct relationship between the conduct and the school's education function. Gross disobedience or misconduct shall include any conduct, behavior, or activity which causes or may reasonably lead school authorities to forecast substantial disruption or material interference with school activities or the rights of others. It shall be further defined to include but is not limited to the following types of conduct, behavior or activity or any other activity or behavior which may be prescribed by the school board from time to time:

- A. Possession of, use of, or distribution of any dangerous substance or weapon or look-alike.
- 1. The Gun-Free Act of 1994 (20U.S.C.8001): This Act requires all public schools to expel for a period of not less than one year any student who brings a weapon to school. This is mandatory expulsion. B. Unexcused absences from school or from any class.
- C. Insubordination to any school personnel which includes failure to follow directions or produce student identification, passes, etc.
- D. Intimidating or attempting to intimidate school personnel.
- E. Fighting with or assaulting school personnel or students.
- F. Intentional damage to or destruction of school property, or property of school personnel. G.

Verbal abuse or use of profanity or obscenity to school personnel.

- H. Endangering the physical well being of the school population by acts such as:
  - 1. Improper release of a school fire alarm or tampering with fire extinguishers.
  - 2. Calling emergency responders (911), in the absence of a reasonable belief that an emergency exists. 3. Indicating the presence of a bomb or explosive device on school grounds, school buses, or at any school activity. A bomb threat is a felony punishable by 2-5 years in prison and expulsion from school. 4. Starting a fire in or to school property or attempting to do so.
- I. Repeated incidents of misbehavior including the repeated refusal to comply with school rules. J. Other acts which directly or indirectly jeopardize the health, safety, and welfare of school personnel. K. Other behavior or conduct which is of such gross nature as to constitute a violation of the spirit or intent of these rules though not explicitly stated above or which in itself is so gross as to constitute on its face gross disobedience or misconduct.
- L. Creating or attempting to create a classroom disturbance.
- M. Smoking or use of tobacco in or on school property or look-alike.
- N. Possessing or consuming any alcoholic beverage, a controlled substance/illegal drug, a look-alike/counterfeit drug or any other substances which cause a physiological or psychological change.
- O. Any form of harassment will not be tolerated.

### **DUE PROCESS**

Due Process will be accord to all students. This means that students:

- 1. Must have had the opportunity to become informed of the school regulations and procedures. 2. Must be informed of the provisions allegedly violated.
- 3. Must be given an opportunity to give their version of the alleged violation.

Levels of authority:

- 1. Teacher or other school personnel
- 2. Principal or assistant principal.
- 3. Superintendent
- 4. Board of Education

#### III. PROCEDURE FOR SUSPENSION

A. Pre-suspension Procedure

1. The superintendent or principal shall confer with the student who is under consideration for suspension. The student shall be adequately advised of the reasons for the proposed suspension, and ask for his version of the

incident that gave the proposed suspension.

- 2. If the student denies his/her guilt, he/she shall be advised as to the evidence upon which the suspension may be predicated.
  - 3. The student shall be given an opportunity to respond to the evidence.
- 4. If the conference does not cause the charges to be dropped, the suspension procedure set forth below shall be followed.
  - 5. The person conferring with the student shall make anecdotal record of the conference. 6. When, in the opinion of the persons empowered to suspend, the student poses an immediate threat to school personnel or property or an ongoing threat for disruption of the educational process, the student may be summarily removed from the school without following the pre-suspension conference within that time if at all possible. If the student's presence poses a continuing danger to persons or property, a pre-suspension conference is not required and the student can be immediately suspended.

#### B. Notification

- 1. Immediately following the pre-suspension conference, if it results in a decision to suspend, the parents or guardian of the student and the student shall be advised of the decision to suspend by certified mail, return receipt requested:
  - a. The notice shall state the reasons for the suspension and the duration of the suspension. b. The notice shall inform the parents or guardian of the student that they may request a review of such

suspension and that their failure to request such review within five days after receipt of the notice shall constitute a waiver of the right to such review.

- c. The request for review must be in writing directed to the superintendent's office.
- 2. The school board shall be notified of each suspension by a notice sent to each member of the school board. 3. Where the suspension is ordered by a principal, a copy of the notice of suspension shall be immediately furnished to the superintendent.
- C. Suspension Review
- 1. If a request for review of the suspension is made by the student, parents, or guardian, written notification of the time and place of such review shall be given at least one week prior to the review. The letter shall also set forth the review hearing procedure.
  - 2. The review hearing shall be conducted by the school board.
- D. School Board Review of Contested Suspension
  - 1. The review of a contested suspension shall be conducted by the school board in executive session within thirty (30) days of the notice of suspension or the review hearing, whichever is later.
  - 2. The school board shall take such action as it deems appropriate including affirming or overruling the suspension.
  - 3. The decision of the school board shall be final and shall be made in public session except that the name of the student shall not be announced.
  - 4. If the school board shall determine that the suspension was not justified, the student's records shall be marked "excused". The student will be allowed to make up missed work.
- 5. Written notification of the school boards decision on the suspension review shall be mailed to the parents or guardian within 48 hours after the school board meeting.

### IV. EXPULSION PROCEDURE

A. If a student is to be recommended for expulsion, the superintendent shall send a letter by certified mail (return receipt requested) to the parents or guardian of the student notifying them of the proposed expulsion. If the expulsion is preceded by a removal from school the pre-suspension procedure must be followed.

- B. The superintendent may elect after a suspension initiated, to move to expel, in which event the suspension review shall be combined with the expulsion hearing.
- C. The notification of expulsion letter shall include:
  - 1. The reasons for the proposed expulsion.
  - 2. The time and place of the expulsion hearing which shall be at least one week after the notification is sent. 3. The hearing procedure.
- D. Expulsion hearings will be conducted by the school board.
- E. The penalty imposed by the board may be expulsion for a period up to a maximum of two school years.

### V. PROCEDURE FOR SUSPENSION AND EXPULSION HEARINGS

- A. The hearing shall be held in executive session.
- B. The student may attend the hearing and be represented by a representative of his choice. C. Presentation of evidence.
  - 1. The school officials shall present their evidence first. Such evidence may be in oral or written form. The school officials need not present their witnesses for confrontation if the school officials determine the such witnesses would be subject to physical or mental harassment. In such cases, a summary of the witness' testimony must be presented to the student at the hearing.
  - 2. The student may present evidence to refute the charges either orally or in writing. He shall be afforded an opportunity for cross-examination of any written evidence presented.

- 3. Pertinent and relevant evidence shall be received without regard to the rules of evidence in such a manner as is appropriate to the circumstances.
- 4. The hearing may be recorded stenographically or by tape. If either party cause a recordation to be made, the other party shall be offered an opportunity to purchase a copy of the transcript of the tape. 5. The parties may make a short opening statement as to their position on the issues at the commencement of the hearing.
- 6. There may be short closing arguments by the parties at the conclusion of the hearing. 7. A motion to exclude witnesses may be made by either party.
- D. The Department of Mental Health shall be invited to send a representative to the hearing to consult with the board whenever there is evidence that mental illness may be the cause for the suspension or expulsion.

### SCHOOL OPERATIONS DURING A PANDEMIC OR OTHER HEALTH EMERGENCY

A pandemic is a global outbreak of disease. Pandemics happen when a new virus emerges to infect individuals and, because there is little to no pre-existing immunity against the new virus, it spreads sustainably. Your child's school and district play an essential role, along with the local health department and emergency management agencies, in protecting the public's health and safety during a pandemic or other health emergency.

During a pandemic or other health emergency, you will be notified in a timely manner of all changes to the school environment and schedule that impact your child. Please be assured that even if school is not physically in session, it is the goal of the school and district to provide your child with the best educational opportunities possible.

### Additionally, please note the following:

- 1. All decisions regarding changes to the school environment and schedule, including a possible interruption of in-person learning, will be made by the superintendent in consultation with and, if necessary, at the direction of the Governor, Illinois Department of Public Health, local health department, emergency management agencies, and/or Regional Office of Education.
- 2. Available learning opportunities may include remote and/or blended learning. Blended learning may require your child to attend school on a modified schedule.
- Students will be expected to participate in blended and remote instruction as required by the school and district.
   Parents are responsible for assuring the participation of their child. Students who do not participate in blended or remote learning will be considered truant.
- 4. All school disciplinary rules remain in effect during the interruption of in-person learning. Students are subject to discipline for disrupting the remote learning environment to the same extent that discipline would be imposed for disruption of the traditional classroom.
- 5. Students and parents will be required to observe all public health and safety measures implemented by the school and district in conjunction with state and local requirements.
- 6. During a pandemic or other health emergency, the school and district will ensure that educational opportunities are available to all students.
- 7. School personnel will work closely with students with disabilities and other vulnerable student populations to minimize the impact of any educational disruption.
- 8. Students who have a compromised immune system, live with an individual with a compromised immune system, or have a medical condition that may impact their ability to attend school during a pandemic or other public health emergency should contact school officials.
- 9. During a pandemic or other health emergency, teachers and school staff will receive additional training on health and safety measures.
- 10. In accordance with school district or state mandates, the school may need to conduct a daily health assessment of your child. Parents and students will be notified of the exact assessment procedures if this becomes necessary.
- 11. Parents should not send their child to school if their child exhibits any symptoms consistent with the pandemic or other health emergency.
- 12. Please do not hesitate to contact school or district officials if you have any concerns regarding your child's education, health or safety.

### TEEN DATING VIOLENCE

Teen dating violence that takes place at school, on school property, at school-sponsored activities, or in vehicles

used for school-provided transportation is prohibited. Teen dating violence occurs whenever a student who is 13 to 19 years of age uses or threatens to use physical, mental, or emotional abuse to control an individual in the dating relationship; or uses or threatens to use sexual violence in the dating relationship. Anyone with information about incidents of teen dating violence is encouraged to report them to any school staff members (teacher, administrator, social worker, etc). School staff shall respond to incidents of teen dating violence by following the District's established procedures for prevention, identification, investigation, and response to bullying and school violence. Parents/guardians will be notified. Complaints will be kept confidential to the extent possible given the need to investigate. Engaging in teen dating violence that takes place at school, on school property, at school-sponsored activities, or in vehicles used for school-provided transportation is prohibited. For purposes of this policy, the term *teen dating violence* occurs whenever a student who is 13 to 19 years of age uses or threatens to use physical, mental, or emotional abuse to control an individual in the dating relationship; or uses or threatens to use sexual violence in the dating relationship.

### **TOBACCO PRODUCTS**

**NO** tobacco products, electronic cigarettes or e-cigarettes will be permitted on school grounds. If brought to school, they will be confiscated and appropriate disciplinary procedures will result. Students who <a href="https://www.nobelen.com/have-tobacco">have-tobacco</a> products at school will receive a <a href="minimum">minimum</a> of <a href="two-days">two-days</a> of suspension.

### VIOLENT OFFENDER COMMUNITY NOTIFICATION

State law requires that all school districts provide parents/guardians with information about sex offenders and violent offenders against youth.

### **VISITORS**

The school policy is to accept only those visitors who have legitimate business to attend to at the school. Guest and visitors must register in the office. Parents are always welcome, but students are not permitted to bring guests. Visitors are expected to leave promptly when their business is completed.

Visitors are expected to abide by all school rules during their time on school property. A visitor who fails to conduct himself or herself in a manner that is appropriate will be asked to leave and may be subject to criminal penalties for trespass and/or disruptive behavior.

All visitors, including parents and siblings, are required to enter through the front door of the building and proceed immediately to the main office. Visitors should identify themselves and inform office personnel of their reason for being at school.

Visitors must sign in, identifying their name, the date and time of arrival, and the classroom or location they are visiting. Approved visitors must take a tag identifying themselves as a guest and place the tag to their outer clothing in a clearly visible location. Visitors are required to proceed immediately to their location in a quiet manner. All visitors must return to the main office and sign out before leaving the school.

Any person wishing to confer with a staff member should contact that staff member to make an appointment. Conferences with teachers are held, to the extent possible, outside school hours or during the teacher's conference/preparation period.

Visitors are expected to abide by all school rules during their time on school property. A visitor who fails to conduct himself or herself in a manner that is appropriate will be asked to leave and may be subject to criminal penalties for trespass and/or disruptive behavior.

No person on school property or at a school event shall perform any of the following acts:

Strike, injure, threaten, harass, or intimidate a staff member, board member, sports official or coach, or any other person.	
Behave in an unsportsmanlike manner or use vulgar or obscene language.	
Unless specifically permitted by State law, possess a weapon, any object that can reasonably be considered a	ì
weapon or looks like a weapon, or any dangerous device.	
Damage or threaten to damage another's property.	

	Damage or deface school property.
	Violate any Illinois law or municipal, local or county ordinance.
	Smoke or otherwise use tobacco products.
	Distribute, consume, use, possess, or be impaired by or under the influence of an alcoholic beverage, cannabis, other lawful product, or illegal drug.
	Be present when the person's alcoholic beverage, cannabis, other lawful product, or illegal drug consumption is detectible, regardless of when and/or where the use occurred.
	Use or possess medical cannabis, unless he or she has complied Illinois' Compassionate Use of Medical Cannabis Act and district policies.
	Impede, delay, disrupt, or otherwise interfere with any school activity or function (including using cellular phones in a disruptive manner).
	Enter upon any portion of school premises at any time for purposes other than those that are lawful and authorized by the board.
	Operate a motor vehicle: (a) in a risky manner, (b) in excess of 20 miles per hour, or (c) in violation of an authorized district employee's directive.
	Engage in any risky behavior, including roller-blading, roller-skating, or skateboarding.
	Violate other district policies or regulations, or a directive from an authorized security officer or district employee.
Engage in any	conduct that interferes with, disrupts, or adversely affects the district or a school function.

### **WEAPONS**

Any student who brings a weapon to school or any school sponsored activity or event, or any event that "bears a reasonable relationship" to school shall be expelled. The term weapon refers to the possession, use, control, or transfer of any object that may be used to cause bodily harm. Any student caught with a weapon will be referred to the criminal justice system.

### **WEATHER NOTE**

When students and parents are in doubt about school closings due to the weather, they should listen to radio stations WEBQ-Harrisburg, WROY-WRUL Carmi, or TV stations WSIL-Marion, WTVW, Fox 7, Evansville, and WPSD Paducah and the automated school phone system. If no report is heard, it can be assumed that school will be in session. **PLEASE DO NO CALL THE ADMINISTRATORS**. Telephone lines must be kept open for emergencies. In order to be informed by phone of school closings, please remember to complete the emergency alert page and return to school.

### WEBSITE/TECHNOLOGY

Annual Notice to Parents about Educational Technology
Vendors Under the Student Online Personal Protection Act

School districts throughout the State of Illinois contract with different educational technology vendors for beneficial K-12 purposes such as providing personalized learning and innovative educational technologies, and increasing efficiency in school operations.

Under Illinois' Student Online Personal Protection Act, or SOPPA (105 ILCS 85/), educational technology vendors and other entities that operate Internet websites, online services, online applications, or mobile applications that are designed, marketed, and primarily used for K-12 school purposes are referred to in SOPPA as operators. SOPPA is intended to ensure that student data collected by operators is protected, and it requires those vendors, as well as school districts and the III. State Board of Education, to take a number of actions to protect online student data.

Depending upon the particular educational technology being used, our District may need to collect different types of student data, which is then shared with educational technology vendors through their online sites, services, and/or applications. Under SOPPA, educational technology vendors are prohibited from selling or renting a student's information or from engaging in targeted advertising using a student's information. Such vendors may only disclose student data for K-12 school purposes and other limited purposes permitted under the law.

In general terms, the types of student data that may be collected and shared include personally identifiable information (PII) about students or information that can be linked to PII about students, such as:

- Basic identifying information, including student or parent/guardian name and student or parent/guardian contact information, username/password, student ID number
- Demographic information
- · Enrollment information
- · Assessment data, grades, and transcripts
- · Attendance and class schedule
- Academic/extracurricular activities
- Special indicators (e.g., disability information, English language learner, free/reduced meals or homeless/foster care status)
- · Conduct/behavioral data
- Health information
- Food purchases
- · Transportation information
- In-application performance data
- Student-generated work
- Online communications
- Application metadata and application use statistics
- · Permanent and temporary school student record information

Operators may collect and use student data only for K-12 purposes, which are purposes that aid in the administration of school activities, such as:

- Instruction in the classroom or at home (including remote learning)
- · Administrative activities
- Collaboration between students, school personnel, and/or parents/guardians
- Other activities that are for the use and benefit of the school district

### WEBSITES/TECHNOLOGY

Websites created by student(s) away from school and on the student's own time and personal computer that directly relates to school and/or school personnel may be disciplined because of its content.

### **Technology**

Student Use of Technology Resources Students will have access to web-based tools, digital resources and applications that support curricular objectives, and these online services may collect, use and disclose personal information (such as student names and email addresses). These online services are only permitted for the use and benefit of the school for the purpose of student learning. In accordance with Board policies and regulations, students will be strongly discouraged from providing any other personal information. Parents and guardians should contact their child's teacher if additional information is needed about websites and online services being used for learning in their child's classes.

### Computer/Electronic Devices, Unauthorized Use:

Law enforcement may be notified depending on the infraction. The unauthorized use of a computer/electronic device is defined as the following:

**A.** Use of district device or technology resource or personal device on any district property, school bus or at a school related event, to download or review data or other materials from a database, computer network or computer system, with or without authorization, when accessing or downloading such data is prohibited, is pornographic, advocates violence or civil disobedience, or will cause the commission of unlawful acts or the violation of lawful district policies and procedures; or

- **B.** Use of any district technology resources to access, view, disseminate or create information or digital media/material that constitutes insulting or fighting words, the very expression of which injures or harasses other people (e.g. threats of violence, defamation of character or of a person's race, religion or ethnic origin); presents a clear and present likelihood that, because of their content or their manner of distribution, they will cause a material and substantial disruption of the proper and orderly operation and discipline of the school or school activities; or will cause the commission of unlawful acts or the violation of lawful district policies and procedures; or
- **C.** Use of district device, mobile device or any technology resource to do, or attempt to do, any of the following items is prohibited (whether or not they are blocked by the district web filter): Access unauthorized files from district servers Access a proxy server
- Access, view, disseminate or create information or material/digital media that is pornographic, obscene, child pornography, harmful, obscene, libelous or pervasively indecent or vulgar
- · Access fee services without permission from an administrator
- · Attempt to read, delete, copy or modify electronic messages of other users
- · Bypass the district web filter
- Download or install unlicensed or unauthorized executable file, software and audio or video media files on district servers or computer without authorization
- · Send unsolicited mass email or other electronic messages
- Use of another user's ID, password or personal identification number
- Use of any district technology resource for individual profit or gain (e.g. product advertisement, political activities or excessive personal use)
- Engage in a pattern of unacceptable tech-related behavior which violates school rules and/or district policy, to include but not limited to, use of district technology resources to access non-academic content without prior authorization

### **Technology Administration**

The technology director will maintain the district's technology in a manner that will protect the district from liability and will protect confidential student and employee information retained on or accessible through district technology resources. Administrators of district technology resources may suspend access to and/or availability of the district's technology resources to diagnose and investigate network problems or potential violations of the law or district policies and procedures. All district technology resources are considered district property. The district may remove, change or exchange hardware or other technology between buildings, classrooms or users at any time without prior notice. Authorized district personnel may install or remove programs or information, install equipment, upgrade any system or enter any system at any time.

### **Content Filtering and Monitoring**

The district will monitor the online activities of users and operate a technology protection measure (content filter) on the network and district technology with Internet access, as required by law. In accordance with law, the content filter will be used to protect against access to visual depictions that are obscene or harmful to minors or are child pornography. Content filters are not foolproof, and the district cannot guarantee that users will never be able to access offensive materials using district equipment. Evading or disabling, or attempting to evade or disable, a content filter installed by the district is prohibited.

The district's technology director may fully or partially disable the district's content filter to enable access for an adult for bona fide research or for other lawful purposes. In making decisions to fully or partially disable the district's content filter,

the school administrator shall consider whether the use will serve a legitimate educational purpose or otherwise benefit the district.

### Online Safety, Security and Confidentiality

In addition to the use of a content filter, the district will take measures to prevent minors from using district technology to access inappropriate matter or materials harmful to minors on the Internet. Such measures shall include, but are not limited to, supervising and monitoring student technology use, careful planning when using technology in the curriculum and instructing on appropriate materials. The district's technology director will develop procedures to provide users guidance on which materials and uses are inappropriate, including network etiquette guidelines. All minor students will be instructed on safety and security issues, including instruction on the dangers of sharing personal information about themselves or others when using email, social media, chat rooms or other forms of direct electronic communication. Instruction will also address cyberbullying awareness and response and appropriate online behavior, including interacting with other individuals on social networking websites and in chat rooms.

The instruction will occur in computer courses, courses in which students are introduced to the computer and the Internet, or courses that use the Internet in instruction. Students are required to follow all district rules when using district technology resources and are prohibited from sharing personal information online unless authorized by the district.

All district employees must abide by state and federal laws and Board policies and procedures when using district technology resources to communicate information about personally identifiable students to prevent unlawful disclosure of student information or records.

All users are prohibited from using district technology to gain unauthorized access to a technology system or information; connect to other systems in evasion of the physical limitations of the remote system; to copy district files without authorization; interfere with the ability of others to utilize technology; secure higher level of privilege without authorization; introduce computer viruses, hacking tools or other disruptive/ destructive programs onto district technology; or to evade or disable a content filter.

### Access to Student Social Networking Passwords & Websites

School officials may conduct an investigation or require a student to cooperate in an investigation if there is specific information about activity on the student's account on a social networking website that violates a school disciplinary rule or policy. In the course of an investigation, the student may be required to share the content that is reported in order to allow school officials to make a factual determination.

# **Gallatin County School Electronic-Learning Mission Statement**

The mission of the electronic-Learning program in the Gallatin County School is to help propel our personalized learning initiatives and establish the foundation for a seamless program that supports individualized instruction in our classrooms. It supports anytime access to online resources for learning by providing portable devices for each student for use at school and possibly at home at the discretion of school administration. The device ensures that students can access educational resources throughout the school day. Every student that has a device that provides real-time data to a reporting dashboard providing an interactive interface for students where they can access tools and resources, post their current work, track their progress, and interact with teachers and other students around their projects. Gallatin County School prepares students for an ever-changing world that sees technological advancements happening at a rapid rate and is committed to preparing students for whatever path they choose after high school. Gallatin County School schools demonstrate that with a rigorous, high-quality program and the right social and emotional supports in place, all students, regardless of racial or economic background, can achieve outstanding results. One goal is for students to consistently outperform regional and state performance in all core subject areas and to make great progress in closing the achievement gap for minority and low-income students. Finally, the device further prepares students for the use of technology in college/careers.

### **Use of Technology**

All students in grades K-12 will have access to Google Chromebooks for educational use in school. This document provides students and parents/guardians with information about the general use of technology, ownership of the devices, rights and responsibilities for possession of the device, educational use, care of the Chromebook and being a good digital citizen. Additionally, the last page is a Chromebook Agreement form for parents to complete. Students and their parents/guardians are reminded that use of School Technology is a privilege and not a right and that everything done on any school owned computer, network, or electronic communication device may be monitored by school authorities. Inappropriate use of school technology can result in limited or banned computer use, disciplinary consequences, removal from courses, loss of credit, receiving a failing grade, and/or legal action as stated in district's Student/Parent Handbook.

To understand the technology use expectations, students and their parents/guardians are responsible for reviewing the Gallatin County School Acceptable Use Policy.

## **Ownership of the Chromebook**

Gallatin County School retains sole right of possession of the Chromebook. Gallatin County School lends the Chromebook to the students for educational purposes only for the academic year. Additionally, Gallatin County School administrative staff and faculty retain the right to collect and/or inspect Chromebooks at any time, including via electronic remote access and to alter, add or delete installed software or hardware.

## **Returning Your Chromebook**

### **End of Year**

At the end of the school year, students may be asked to turn in their Chromebooks and any peripherals and accessories. Failure to turn in a Chromebook will result in the student being charged the full \$229.00 replacement cost. Additionally, a report of stolen property with the local law enforcement agency will be filed by the school or school designee.

# **Transferring/Withdrawing Students**

Students that transfer out of or withdraw from Gallatin County School must turn in their Chromebooks and peripherals and accessories to campus office personnel on their last day of attendance. Failure to turn in the Chromebook will result in the student being charged the full \$500.00 replacement cost. Unpaid fines and fees of students leaving Gallatin County School may be turned over to a collection agency. Additionally, a report of stolen property with the local law

enforcement agency will be filed by the school or school designee.

### Rights and Responsibilities

# **Responsibility for Electronic Data**

The students are solely responsible for any apps or extensions on their Chromebooks that are not installed by a member of the Gallatin County School technology staff. Students are responsible for backing up their data to protect from loss. Users of school technology have no rights, ownership, or expectations of privacy to any data that is, or was, stored on the Chromebook, school network, or any school issued applications and are given no guarantees that data will be retained or destroyed.

# **Operating System and Security**

Students may not use or install any operating system on their Chromebook other than the current version of Chrome OS that is supported and managed by the school.

### Virus Protection

### **Content Filter**

The school utilizes an Internet content filter that is in compliance with the federally mandated Children's Internet Protection Act (CIPA). All Chromebooks will have all Internet activity protected and monitored by the school. If an educationally valuable site is blocked, students should contact their teachers to request the site be unblocked. Parents/guardians are responsible for filtering and monitoring any Internet connection students receive that is not provided by the school.

# **Warranty and Insurance**

The school will repair or replace damaged equipment resulting from normal use and accidents. The school will make its best attempt to purchase replacement parts at the best possible price. Abuse or neglect may result in damages. In case of theft, vandalism, or other criminal acts, a police report MUST be filed with the local police department and a copy submitted to the office.

# No Expectation of Privacy

Students have no expectation of confidentiality or privacy with respect to any usage of a Chromebook, regardless of whether that use is for school-related or personal purposes, other than as specifically provided by law. The school may, without prior notice or consent, log, supervise, access, view, monitor, and record use of student Chromebooks at any time for any reason related to the operation of the school. By using a Chromebook, students agree to such access, monitoring, and recording of their use.

### **Monitoring Software**

Teachers, school administrators, and the technology department staff may use monitoring software that allows them to view the screens and activity on student Chromebooks.

### **Educational Use**

School-issued Chromebooks should be used for educational purposes and students are to adhere to the Acceptable Use Policy and all of its corresponding administrative procedures at all times.

# **Using Your Chromebook at School**

Students are expected to bring a fully charged Chromebook to school every day and bring their Chromebooks to all classes unless specifically advised not to do so by their teacher.

### **Chromebooks Left at Home**

Students are required to bring their Chromebook to school every day. Repeat offenders who leave their device at home may receive a disciplinary action.

# Chromebooks being REPAIRED or FORGOTTEN at home

- Chromebooks on loan to students having their devices repaired or forgotten may not be taken home, unless permitted by the school administration.
- Loaner Chromebooks MUST NOT BE TAKEN from the school and MUST BE RETURNED on the same day borrowed.
- Students should NOT borrow a chromebook which has been assigned to another student. Loaner Chromebooks may be issued to students when they leave their school-issued Chromebook for repair or forgotten at home.
- A student borrowing a Chromebook from the technology department will be responsible for any damage to or loss of the loaned device. Student and their parent/guardian is responsible for its safe return.

☐ Students should have their own personal set of headphones for sanitary reasons.

# **Printing**

> Students will be encouraged to digitally publish and share their work with their teachers and peers when appropriate.
➤ All student work should be stored in an Internet/cloud application.
Logging into a Chromebook
☐ Students will log into their Chromebooks using their school issued Google Apps for Education/G Suite account. Students should never share their account passwords with others.
Managing and Saving Your Digital Work with a Chromebook
☐ The majority of student work will be stored in Internet/cloud based applications and can be accessed from any computer with an Internet connection and most mobile Internet devices.
☐ Students should always remember to save frequently when working on digital media.
☐ The school will not be responsible for the loss of any student work.
□ Students are encouraged to maintain backups of their important work on a portable storage device or by having multiple copies stored in different Internet storage solutions.

**Using Your Chromebook Outside of School** 

Students are encouraged to use their Chromebooks at home and other locations outside of school. A WiFi Internet connection will be required for the majority of Chromebook use, however, some applications can be used while not connected to the Internet. Students are bound by the Gallatin County School Acceptable Use Policy, Administrative Procedures, and all other guidelines in this document wherever they use their Chromebooks.

### **Chromebook Care**

# **Taking Care of Your Chromebook**

Students are responsible for the general care of the Chromebook they have been issued by the school. Chromebooks that are broken or fail to work properly must be reported to a teacher or administrator as soon as possible so that they can be taken care of properly. School-owned Chromebooks should NEVER be taken to an outside computer service for any type of repairs or maintenance. Students should never leave their Chromebook unattended except locked in their hallway locker.

### **General Precautions**

□ No food or drink should be next to a Chromebook; however, the school may designat acceptable use area(s).
□ Cords, cables, and removable storage devices must be inserted carefully into Chromebooks.
☐ Chromebooks should not be used or stored near pets.
□ Chromebooks should not be used with the power cord plugged in when the cord may be a tripping hazard.
□ Chromebooks must remain free of any writing, drawing, stickers, and labels. • Heavy objects should never be placed on top of Chromebooks.
□ Always transport Chromebooks with care and with the screen closed. Failure to do so may result in disciplinary action.
□ Never lift Chromebooks by the screen.
□ Never carry Chromebooks with the screen open.

# Screen Care

The Chromebook screen can be damaged if subjected to heavy objects, rough treatment, some cleaning solvents, and other liquids. The screens are particularly sensitive to damage from excessive pressure, heat, and light.
□ Do not store a Chromebook with the screen open.
□ Make sure there is nothing on the keyboard before closing the lid (e.g. pens, pencils, or disks).
☐ Only clean the screen with a soft, dry microfiber cloth or anti-static cloth.
☐ Do not put pressure on the top of a Chromebook when it is closed.
Asset Tags and Logos
☐ All Chromebooks are labeled with a Gallatin County School asset tag.
☐ Asset tags and logos may not be modified or tampered with in any way.
Students may be charged up to the full replacement cost of a Chromebook for tampering with a school asset tag logo or turning in a Chromebook without a school asset tag or logo. Chromebooks left unattended Under no circumstances should Chromebooks be left in unsupervised areas. Unsupervised areas include the school grounds, the lunchroom, vehicles, pathrooms, computer labs, library, unlocked classrooms, stairways and hallways. Any Chromebook left in these areas is in danger of being stolen. If a Chromebook is found in an unsupervised area, it should be taken immediately to the office. Multiple offenses will result in disciplinary action.
Proper Care and Handling of Chromebooks in the
Classroom Chargers
☐ Avoid bending the charger cord at sharp angles.
□ Don't strain the power cord at right angles to the power port. This can damage the charger

# cord, and the computer itself.

□ Position your charger so that you wont roll over the cord with a chair, or catch the cord in the sharp edges of desk drawers.
☐ Disconnect all connected cords, USB memory and any adapters before putting your
Chromebook into a carrying case, bag or slot in a mobile cart.
☐ Be careful and gentle as you connect and disconnect the power cord.
Heat
☐ Always place your Chromebook on a flat, stable surface.
□ Do not place it on top of stacks of paper, blanket, upholstery, or anything else that is an insulator.
☐ The bottom of your Chromebook is a cooling surface. Excessive heat buildup will lead to premature failure. The computer needs proper airflow to operate correctly. Gravity - The
Enemy of a Chromebook
☐ Dont drop them. A drop can break the hinge, latch, or worse.
☐ Keep your Chromebook away from the edges of tables and desks.
Liquids
□ Keep liquids away from your Chromebook. Liquids damage the electronic components quickly and easily.
$\ \square$ Always put water bottles or any other liquids on the floor while using these devices.

# The Screen

□ Your Chromebook's LCD Display is a very expensive component, and physical damage to it is not covered by warranty. If you drop your Chromebook or slam the lid shut, it may crack. Make sure you dont have anything between the screen and keyboard as you close the case such as a pencil or earbuds.
□ If you open the screen beyond its hinge limitation, it will break and be very costly to repair. It is not designed to open to a flat position. Keep Chromebook free from papers and other objects before closing it
□ Do not pick it up by the screen.
□ Dont place items on top of your Chromebook as the weight can cause damage to the screen.
☐ Always keep magnetic devices away from your Chromebook.
Keep It Clean; Refreshed
□ Dont use your Chromebook while you eat. Make sure your hands are clean when using your Chromebook.
☐ Dont use aerosol sprays, solvents, or abrasives.
□ To refresh the device, shutdown your Chromebook and disconnect the power adapter. Use a damp, soft, lint- free cloth to clean the computers exterior. Avoid getting moisture in any openings. Do not spray liquid directly on the computer.
□ Run UPDATES anytime a gray upward pointing arrow appears in the lower right corner of the screen.
Proper way to carry your Chromebook
☐ Be sure to use both hands if you are moving your Chromebook.
□ Never lift or carry by the screen as you can either break the screen or damage the hinge. It is

### safer to close the Chromebook before moving.

### **Authorized users**

□ The school Chromebook is assigned to you for your use alone. Please dont allow others to use your device while in use. Remember you are responsible for any damage or misuse. Additionally, using someone else's account is subject to discipline.
Keep your Chromebook secure
□ Please keep Chromebook in a secure area when not in use. Do not leave your Chromebook sitting in an empty classroom or any other area without adult supervision. If using Chromebook cart, replace the Chromebook back to the assigned slot.
Stay out of the inside
☐ Under no circumstances should you open (or attempt to open) your school computers case.
□ Touching the wrong components may not only damage the computer, it may seriously hurt you Report the failure to your teacher or IT person in your school. Let a district technician handle any repairs that require the case to be opened.
Digital Citizenship

## **Appropriate Uses and Digital Citizenship**

While working in a digital and collaborative environment, students should always conduct themselves as good digital citizens by adhering to the following:

- 1. Respect Yourself-I will show respect for myself through my actions. I will select online names that are appropriate. I will use caution with the information, images, and other media that I post online. I will carefully consider what personal information about my life, experiences, or relationships I post. I will not be obscene. I will act with integrity.
- 2. Protect Yourself-I will ensure that the information, images, and materials I post online will not put me at risk. I will not publish my personal details, contact details, or a schedule of my activities. I will report any attacks or inappropriate behavior directed at me while online. I will

### protect passwords, accounts, and resources.

- 3. Respect Others- I will show respect to others. I will not use electronic mediums to antagonize, bully, harass, or stalk people. I will show respect for other people in my choice of websites. I will not visit sites that are degrading to others, pornographic, racist, or inappropriate. I will not enter other peoples private spaces or areas.
  - 4. Protect Others-I will protect others by reporting abuse and not forwarding inappropriate materials or communications. I will avoid unacceptable materials and conversations.
- 5. Respect Intellectual Property- I will request permission to use copyrighted or otherwise protected materials. I will suitably cite all use of websites, books, media, etc. I will acknowledge all primary sources. I will validate information. I will use and abide by the fair use rules.
- 6. Protect Intellectual Property- I will request to use the software and media others produce. I will purchase, license, and register all software or use available free and open source alternatives rather than pirating software.

# Copyright and File Sharing

Students are required to follow all copyright laws around all media including text, images, programs, music, and video. Downloading, sharing, and posting online illegally obtained media is against the Acceptable Use Policy.

### **Keeping Safe on Social Networks**

## The quick tips for teens:

- · Put everything behind password protected walls, that only friends can see.
- Protect your password and make sure you really know who someone is before you allow them onto your friend's list.
  - · Blur or morph your photos a bit so they won't be abused by cyber bullies or predators.
    - · Don't post anything your parents, principal or a predator couldn't see.

- · What you post online stays online forever!!!! So ThinkB4U Click!
  - · Don't do or say anything online you wouldn't say offline.
- · Protect your privacy and your friends' privacy too...get their okay before posting something about them or their pics online.
- · Check what your friends are posting/saying about you. Even if you are careful, they may not be and may be putting you at risk.
  - That cute 14-year old boy may not be cute, may not be 14 and may not be a boy! You never know!
- · And, unless you're prepared to attach your blog to your college/job/internship/scholarship or sports team application...don't post it publicly!
- · Stop, Block and Tell! (don't respond to any cyber bullying message, block the person sending it to you tell a trusted adult).
  - · R-E-S-P-E-C-T! (use good etiquette and respect the feelings and bandwidth of others).
  - · Keep personal information private (the more information someone has about you, the more easily they can bully you).
- Google yourself! (conduct frequent searches for your own personal information online and set alerts ... to spot cyberbullying early).
- Take 5! (walk away from the computer for 5 minutes when something upsets you, so you don't do something you will later regret).

### And for parents:

- Talk to your kids ask questions (and then confirm to make sure they are telling you the truth!)
  - · Don't panic...there are ways of keeping your kids safe online. It's easier than you think!

- · Most kids really do use social networks just to communicate with their friends. Take a breath, gather your thoughts and get help when you need it. (You can reach out to WiredSafety.org.)
- · It's not an invasion of their privacy if strangers can see it. There is a difference between reading their paper diary that is tucked away in their sock drawer...and reading their blog. One is between them and the paper it's written on; the other between them and 700 million people online!
  - · Don't believe everything you read online especially if your teen posts it on her blog!

### **Authorization for Electronic Network Access**

In order to educate students in the most recent uses of technology, the District has implemented a number of ways for exploring information other than that found in traditional printform. The District believes it is in the student's best interest to enhance their ability to explore as many options as possible for obtaining information. Some of these methods of exploration unfortunately can lead to materials that may be contrary to one's beliefs and may be offensive in nature. Although the District cannot guarantee students will not be able to access this type of material, the District in no way condones or encourages access to this information. In an effort to control access of these materials, the following guidelines have been developed to help control access to offensive materials that may be found through the use of technology.

- 1. The District expects that instruction in the proper use of technology will enhance curriculum objectives and be an integral part of the instructional program, and therefore teachers and administration will monitor the proper use of all technology.
  - 2. Students utilizing online services must have the permission of and be supervised by the District professional staff.
- 3. Access to technology is a student privilege and the misuse of it can be punishable as any other offense against rules of proper conduct.
  - 4. Vandalism, damage, or disabling the property of the District or of another person is strictly forbidden.
- 5. To access or impersonate another person's materials, information, or files is strictly forbidden.
  - 6. All software to be permanently installed on computers must have the prior approval of the administration who will make sure proper license exists for its use.

- 7. Privately owned software cannot be permanently installed on hard drives.
- 8. Personnel are not to change the configuration of computers without the permission of the administration.
- 9. District owned software cannot be taken off the school premises without the approval of the administration.
  - 10. District owned software may not be copied or manuals may not be reproduced unless permitted or allowed by law.

### **Access to Electronic Networks**

Electronic networks & amp; associated accounts, including the Internet, are a part of the District's instructional program in order to promote educational excellence by facilitating resource sharing, innovation, and communication.

The School District is not responsible for any information that may be lost, damaged, or unavailable when using the network, or for any information that is retrieved or transmitted via the

### Internet.

Furthermore, the District will not be responsible for any unauthorized charges or fees resulting from access to the Internet.

### **Curriculum and Appropriate Online Behavior**

The use of the District's electronic networks shall: (1) be consistent with the curriculum adopted by the District as well as the varied instructional needs, learning styles, abilities, and developmental levels of the students, and (2) comply with the selection criteria for instructional materials and library resource center materials. As required by federal law and Board policy 6:60 Curriculum Content, students will be educated about appropriate online behavior, including but not limited to: (1) interacting with other individuals on social networking websites and in chat rooms, and (2) cyber-bullying awareness and response. Staff members may, consistent with the Superintendent's implementation plan, use the Internet throughout the curriculum. The District's electronic network is part of the curriculum and is not a public forum for general use.

# **Acceptable Use**

All use of the Districts electronic network must be: (1) in support of education and/or research, and be in furtherance of the Board of Educations stated goal, or (2) for a legitimate school business purpose. Use is a privilege, not a right. Students and staff members have no expectation of privacy in any material that is stored, transmitted, or received via the District's electronic network or District computers. General rules for behavior and communications apply when using electronic networks. Electronic communications and downloaded material, including files deleted from a users account but not erased, may be monitored or read by school officials.

### **Internet Safety**

Technology protection measures shall be used on each District computer with Internet access. They shall include a filtering device that protects against Internet access by both adults and minors to visual depictions that are: (1) obscene, (2) pornographic, or (3) harmful or inappropriate for students, as defined by the Children's Internet Protection Act and as determined by the Superintendent or designee shall enforce the use of such filtering devices. The Superintendent or designee shall include measures in this policy's implementation plan to address the following:

- 1. Ensure staff supervision of student access to online electronic networks,
- 2. Restrict student access to inappropriate matter as well as restricting access to harmful materials.
- 3. Ensure student and staff privacy, safety, and security when using electronic communications,
  - 4. Restrict unauthorized access, including "hacking" and other unlawful activities, and
- 5. Restrict unauthorized disclosure, use, and dissemination of personal identification information, such as, names and addresses.

### **Authorization for Electronic Network Access**

All users of the District's computers to access the Internet shall maintain the confidentiality of student records. Reasonable measures to protect against unreasonable access shall be taken before confidential student information is loaded onto the network. The failure of any student to follow the terms of the Authorization for Electronic Network Access, or this policy, will result in the loss of privileges, disciplinary action, and/or appropriate legal action.

# Prevention of and Response to Bullying, Intimidation, and Harassment

Bullying, intimidation, and harassment diminish a student's ability to learn and a school's ability to educate. Preventing students from engaging in these disruptive behaviors and providing all students equal access to a safe, non-hostile learning environment are important District goals. Bullying on the basis of actual or perceived race, color, national origin, military status, unfavorable discharge status from the military service, sex, sexual orientation, gender identity, gender-related identity or expression, ancestry, age, religion, physical or mental disability, order of protection status, status of being homeless, or actual or potential marital or parental status,

gender-related identity or expression, ancestry, age, religion, physical or mental disability, order of protection status, status of being homeless, or actual or potential marital or parental status, including pregnancy, association with a person or group with one or more of the aforementioned actual or perceived characteristics, or any other distinguishing characteristic is prohibited in each of the following situations:

- 1. During any school-sponsored education program or activity.
- 2. While in school, on school property, on school buses or other school vehicles, at designate school bus stops waiting for the school bus, or at school-sponsored or school-sanctioned events or activities.
- 3. Through the transmission of information from a school computer, a school computer network, or other similar electronic school equipment.
- 4. Through the transmission of information from a computer that is accessed at a non-school-related location, activity, function, or program or from the use of technology or an electronic device that is not owned, leased, or used by a school district or school if the bullying causes a substantial disruption to the educational process or orderly operation of a school. This item (4) applies only in cases in which a school administrator or teacher receives a report that bullying through this means has occurred and it does not require a district or school to staff or monitor any non-school-related activity, function, or program.

# **Bullying Prevention and Response Plan**

The Superintendent or designee shall develop and maintain a bullying prevention and response plan that advances the District's goal of providing all students with a safe learning environment free of bullying and harassment. This plan must be consistent with the following requirements:

1. The District uses the definition of bullying as provided in this policy.

- 2. Bullying is contrary to State law and the policy of this District. However, nothing in the District's bullying prevention and response plan is intended to infringe upon any right to exercise free expression or the free exercise of religion or religiously based views protected under the First Amendment to the U.S. Constitution or under Section 3 of Article I of the Illinois Constitution.
- 3. Students are encouraged to immediately report bullying. A report may be made orally or in writing to the District Complaint Manager or any staff member with whom the student is comfortable speaking. Anyone, including staff members and parents/guardians, who has information about actual or threatened bullying is encouraged to report it to the District Complaint Manager or any staff member. Anonymous reports are also accepted.

# **Gallatin County School Chromebook Agreement**

- If the student ceases to be enrolled in Gallatin County School, the student/parents will return the Chromebook in good working order or pay the full \$229.00 replacement cost of the computer. Also, a report of stolen property with the local law enforcement agency will be filed by the school or school designee. The student/parent will also return the Chromebook, software and issued peripherals immediately to Gallatin County School upon school representatives asking for their return. In no event shall Gallatin County School be held liable to any claim of damage, negligence, or breach of duty.
- I understand that identification labels have been placed on the Chromebook. These labels are not to be removed or modified. Additional stickers, labels, tags, or markings of any kind are NOT to be added to the machine. Students are not permitted to personalize their case, they cannot deface school property.

### Website and Social Media Guidelines

Think before you act because your virtual actions are real and permanent! • Be aware of what you post online. Website and social media venues are very public. What you contribute leaves a digital footprint for all to see. Do not post anything you wouldn't want friends, enemies, parents, teachers, future colleges or employers to see. • Follow the school's code of conduct when writing online. It is acceptable to disagree with other's opinions; however, do it in a respectful way. Make sure that criticism is constructive and not hurtful. What is inappropriate in the classroom is inappropriate online.

- Be safe online. Never give out personal information, including, but not limited to, last names, phone numbers, addresses, exact birth dates, and pictures. Do not share your password with anyone besides your teachers and parents.
- Linking to other websites to support your thoughts and ideas is recommended. However, be sure to read and review the entire website prior to linking to ensure that all information is appropriate for a school setting.
- Do your own work! Do not use other people's intellectual property without their permission. Be aware that it is a violation of copyright law to copy and paste other's thoughts. It is good practice to hyperlink to your sources.
  - Be aware that pictures may also be protected under copyright laws. Verify that you have permission to use the image or that it is under Creative Commons attribution.
- How you represent yourself online is an extension of yourself. Do not misrepresent yourself by using someone else's identity.
  - Online work should be well written. Follow writing conventions including proper grammar, capitalization, and punctuation. If you edit someone else's work, be sure it is in the spirit of improving the writing.

• If you run across inappropriate material that makes you feel uncomfortable or is not respectful, tell your teacher right away. Everyone should work together to make our digital environment safe.

### PARENT NOTICES REQUIRED BY THE EVERY STUDENT SUCCEEDS ACT

### I. Teacher Qualifications

A parent/guardian may request, and the District will provide in a timely manner, the professional qualifications of your student's classroom teachers, including, at a minimum, whether:

- a. The teacher has met the State qualifications and licensing criteria for the grade levels and subject areas in which the teacher provides instruction.
- b. The teacher is teaching under emergency or other provisional status.
- c. The teacher is teaching in the field of discipline of the certification of the teacher.
- d. Paraprofessionals provide services to the student and, if so, their qualifications.

### II. Testing Transparency

### STUDENT PRIVACY PROTECTIONS

<u>Surveys by Third Parties</u>: Before a school official or staff member administers or distributes a survey or evaluation created by a third party to a student, the student's parent/guardian may inspect the survey or evaluation, upon their request and within a reasonable time of their request. This applies to every survey: (1) that is created by a person or entity other than a district official, staff member, or student, (2) regardless of whether the student answering the questions can be identified, and (3) regardless of the subject matter of the questions.

Parents who object to disclosure of information concerning their child to a third party may do so in writing to the building principal.

Surveys Requesting Personal Information: School officials and staff members will not request, nor disclose, the identity of any student who completes any survey or evaluation (created by any person or entity, including the school or district) containing one or more of the following items:

- 1. Political affiliations or beliefs of the student or the student's parent/guardian. 2. Mental or psychological problems of the student or the student's family.
  - 3. Behavior or attitudes about sex.
  - 4. Illegal, anti-social, self-incriminating, or demeaning behavior.
  - 5. Critical appraisals of other individuals with whom students have close family relationships. 6. Legally recognized privileged or analogous relationships, such as those with lawyers, physicians, and ministers.
  - 7. Religious practices, affiliations, or beliefs of the student or the student's parent/guardian. 8. Income other than that required by law to determine program eligibility for participation in a program or for receiving financial assistance under such program.

The student's parent/guardian may: (1) inspect the survey or evaluation upon, and within a reasonable time of, their request, and/or (2) refuse to allow their child to participate in the survey. The school will not penalize any student whose parent/guardian exercised this option.

### **Instructional Material**

A student's parent/guardian may inspect, upon their request, any instructional material used as part of their child's educational curriculum within a reasonable time of their request.

Selling or Marketing Students' Personal Information Is Prohibited

No school official or staff member may market or sell personal information concerning students (or otherwise provide that information to others for that purpose). The term *personal information* means individually identifiable information including: (1) a student or parent's first and last name, (2) a home or other physical address (including street name and the name of the city or town), (3) a telephone number, (4) a Social Security identification number or (5) driver's license number or State identification card.

The above paragraph does not apply: (1) if the student's parent/guardian have consented; or (2) to the collection, disclosure or, use of personal information collected from students for the exclusive purpose of developing, evaluating or providing educational products or services for, or to, students or educational institutions.

**AGGRESSIVE BEHAVIOR REPORTING** 

**LETTER & FORM - To Parent/Legal Guardian** 

Illinois requires a parent be notified of a child who engages in aggressive behavior, including such behaviors as bullying (105ILCS5/10-20.14)The School Board policy prohibits a student while at school from engaging in aggressive behavior that causes physical or psychological harm to someone else and/or urging other students to engage in such conduct. Prohibited aggressive behavior includes, without limitation, the use of violence, force, noise, coercion, threats, intimidation, fear, bullying, or other comparable conduct. This early notification is intended to help all of us work together to avoid repetition of the behavior.

# Awareness and Prevention of Child Sexual Abuse, Grooming Behaviors, and Boundary Violations

Child sexual abuse, grooming behaviors, and boundary violations harm students, their parent/guardian, the District's environment, its school communities, and the community at large, while diminishing a student's ability to learn.

Warning Signs of Child Sexual Abuse

Warning signs of child sexual abuse include the following.

Physical signs:

Sexually transmitted infections (STIs) or other genital infections

Signs of trauma to the genital area, such as unexplained bleeding, bruising, or

blood on the sheets, underwear, or other clothing

Unusual weight gain or loss

Behavioral signs:

Excessive talk about or knowledge of sexual topics

Keeping secrets

Not talking as much as usual

Not wanting to be left alone with certain people or being afraid to be away from primary caregivers

Regressive behaviors or resuming behaviors that the child had grown out of, such as thumb sucking or bedwetting

Overly compliant behavior

Sexual behavior that is inappropriate for the child's age

Spending an unusual amount of time alone

Trying to avoid removing clothing to change or bathe

**Emotional signs:** 

Change in eating habits or unhealthy eating patterns, like loss of appetite or excessive eating

Signs of depression, such as persistent sadness, lack of energy, changes in sleep or appetite, withdrawing from normal activities, or feeling "down"

Change in mood or personality, such as increased aggression

Decrease in confidence or self-image

Anxiety, excessive worry, or fearfulness

Increase in unexplained health problems such as stomach aches and headaches

Loss or decrease in interest in school, activities, and friends

Nightmares or fear of being alone at night

Self-harming behaviors or expressing thoughts of suicide or suicidal behavior

Failing grades

Drug or alcohol use

Warning Signs of Grooming Behaviors

School and District employees are expected to maintain professional and appropriate relationships with students based upon students' ages, grade levels, and developmental levels.

Prohibited grooming is defined as (i) any act, including but not limited to, any verbal, nonverbal, written, or electronic communication or physical activity, (ii) by an employee with direct contact with a student, (iii) that is directed toward or with a student to establish a romantic or sexual relationship with the student. Examples of grooming behaviors include, but are not limited to, the following behaviors:

Sexual or romantic invitations to a student

Dating or soliciting a date from a student

Engaging in sexualized or romantic dialog with a student

Making sexually suggestive comments that are directed toward or with a student Self-disclosure or physical exposure of a sexual, romantic, or erotic nature

Sexual, indecent, romantic, or erotic contact with a student

Failing to respect boundaries or listening when a student says "no"

Engaging in touching that a student or student's parents/guardians have indicated is unwanted

Trying to be a student's friend rather than filling an adult role in the student's life Failing to maintain age-appropriate relationships with students

Talking with students about personal problems or relationships

Spending time alone with a student outside of their role in the student's life or making up excuses to be alone with a student

Expressing unusual interest in a student's sexual development, such as commenting on sexual characteristics or sexualizing normal behaviors

Giving a student gifts without occasion or reason

Spending a lot of time with a student

Restricting a student's access to other adults

Warning Signs of Boundary Violations

School and District employees breach employee-student boundaries when they misuse their position of power over a student in a way that compromises the student's health, safety, or general welfare. Examples of boundary violations include:

Favoring a certain student by inviting the student to "hang out" or by granting special privileges

Engaging in peer-like behavior with a student

Discussing personal issues with a student

Meeting with a student off-campus without parent/guardian knowledge and/or permission

Dating, requesting, or participating in a private meeting with a student (in person or virtually) outside of a professional role

Transporting a student in a school or private vehicle without administrative

authorization

Giving gifts, money, or treats to an individual student

Sending a student on personal errands

Intervening in a serious student problem instead of referring the student to an appropriately trained professional

Sexual or romantic invitations toward or from a student

Taking and using photos/videos of students for non-educational purposes

Initiating or extending contact with a student beyond the school day in a one-onone or non-group setting

Inviting a student to an employee's home

Adding a student on personal social networking sites as contacts when unrelated to a legitimate educational purpose

Privately messaging a student

Maintaining intense eye contact with a student

Making comments about a student's physical attributes, including excessively flattering comments

Engaging in sexualized or romantic dialog

Making sexually suggestive comments directed toward or with a student

Disclosing confidential information

Self-disclosure of a sexual, romantic, or erotic nature

Full frontal hugs

Invading personal space

If you believe you are a victim of child sexual abuse, grooming behaviors, or boundary violations, or you believe that your child is a victim, you should immediately contact the Building Principal, a school counselor, or another trusted adult employee of the School.
