We are pleased to inform you that **Gallatin County School CUSD#7** will be implementing a new option available to schools participating in the National School Lunch and School Breakfast Programs called the Community Eligibility Provision (CEP) for the current school year.

**What does this mean for you and your children attending the school(s) identified above?**

Great news for you and your students! All enrolled students of the Gallatin County School CUSD#7 are eligible to receive a healthy breakfast and lunch at school at no charge to your household each day of the this school year. No further action is required of you. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit an application.

**This is for Breakfast/Lunch ONLY.**

If you would like to have your fees waived, you will need to fill out a waiver form and show proof of one month of income for all family members working out of the home to your building secretary.

If you are Direct Certified, you will **NOT** have to fill out a form.
