Whereas, Taylor School District (the "District") and the Taylor Federation of Teachers (the "Association") have been engaged in collective bargaining regarding a return to in-person learning and the calendar since August, 2020;

Whereas, representatives of the District and the Association have participated in a significant amount of negotiation sessions, including approximately ten (10) related to return to in-person learning and the calendar since September 28, 2020;

Whereas, the District has an obligation to inform parents of the calendar;

Whereas, notwithstanding their numerous collective bargaining negotiation sessions, the parties are at impasse regarding the calendar

Now, therefore, be it resolved by the Board of Education of Taylor School District that:

Subject to the parties' mutual and on-going duty to bargain in good faith, the Board of Education, on behalf of the District, hereby implements and makes operative the following;

The attached calendar will be implemented through January 31, 2021

The Superintendent, or his designee; will provide the Association with a copy of this Resolution; and

The Superintendent or his designee, or District legal counsel, are hereby authorized to take any actions on behalf of the District necessary to effect this Resolution.

All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are hereby rescinded.
