2.03 2018 Assessment Report

 K. Nagi presented the TSD Assessment Report 2018. Her report consisted of Growth vs. Proficiency. Taylor is above the MI State Average for growth in grades 3 – 8 on both Math and ELA. Proficiency continues to be low for TSD.

2.04 Moody WIN (What I Need) Presentation

Moody Elementary School Staff showed a WIN Presentation on the positive results of working daily with the 2nd – 5th graders in Math.

2.05 Superintendent's/Asst. Superintendent's Report

- Leadership Meetings: Last week the Elementary and Secondary Principals met for their monthly
 meeting to discuss RCD, PLC work on the October PD day, the Apple Round Table Conference, and the
 importance of MiStar explicit documentation of behavior.
- TSD/TDC Truancy Pilot: Met with the TSD Security Director, Pupil Accounting Director, Judge Salomone, Taylor Teen Outreach Social Worker to discuss our Taylor School District/Taylor District Court Truancy pilot. We discussed wrap around services and the inclusion of a probation officer for our program.
- Randall Elementary: Thank you to Randall staff and its leadership for the manner in which they handled
 a serious medical issue. Their collaborative work with the Wayne County Healthier Department is
 exemplary
- Parent/Teacher Conferences: This week, schools will be hosting parent/teacher conferences in the
 afternoon and evening. During this time, progress reports were also completed and are being sent
 home. Friday is a half day for students and teachers.
- Ford NGL: On November st, 80 school/community members convened to further the work of NGL. The Ideal Graduate Profile was revised to include new thinking from the group. Tactical Teams were also created based on identified needs of the district. A TSD co-chair was chosen for each team, with the understanding that a business/community partner would also co-chair. Tactic Teams brainstormed how to support the NGL work going on at the high school, making long-range plans to meet on a regular basis. The Ford NGL Executive team will meet next week to brainstorm ways to include more business partners.
- TSD Wellness Committee: The TSD Wellness Committee sponsored C. Sobelton, expert life coach and nutritionist, to present: Back to Balance – Wellness at its Best. During this presentation, Ms. Sobelton addressed the importance of balance for a healthy mind, body and spirit. Approximately 50 staff were in attendance with three staff winning \$50 gift cards from the attendance raffle.
- Also attended the Foundation meeting and gave a very helpful explanation of Ford NGL.
