#### 2.02 Asst. Superintendent's Report

- Special Thank you to Chris Dawson from Tierney Brothers for recognizing the Taylor School District during a recent awards ceremony in which he won Best Project/Showcase for his presentation on the Taylor School District.
- The TSD recently secured two former Coaching 101 directors to provide transformative coaching PD for principals, coaches, coaches on deck, directors, cabinet members, and any interested board members. The two-day coaching sessions will focus on active listening, building relational trust and questioning techniques at all levels.
- Job embedded Journeys' PD continues at the elementary levels with round 2 of the building specific PD with teachers and building coaches.

- The School Improvement Team recently met with Mari Treece, Educational Manager at Wayne RESA. WRESA is looking at Taylor's Coaching Model as the regional model for Wayne County.
- Wall-to-Wall initiative Committees are meeting weekly. This past week, the HS Counselors and principals visited the two middle schools to share a powerpoint with the students and staff. The purpose of this was to help students and staff get a better understanding of the different academies. Students were given a survey to gauge interest in the different academies and to assist in choosing their classes for the following year. The HS Counselors will show the powerpoint at Truman on Monday and Kennedy on Wednesday with the entire staff.
- Testing Preparation's for the Standardized testing has begun with the first official test, WIDA assessment, beginning on February 5<sup>th</sup>. The MSTEP/MI-ACCESS opens on April 9<sup>th</sup> and closes on May 25<sup>th</sup>. All buildings will be testing online. Also, the New Science Assessment Pilot will be administered in the 5<sup>th</sup> grade and 8<sup>th</sup> grade. There is no longer a performance task in ELA on any MSTEP assessment. The High School MME remains paper/pencil for ELA and Math on the SAT. ACT WorkKeys will utilize paper/pencil and science and social studies will be delivered online.
