#### 2 REPORTS/PRESENTATIONS

#### 2.01 Strategic Planning Presentation - Dr. Rod Green

Dr. Rod Green presented the Strategic Planning results to the Board Members. This is a five-year plan for the District.

#### 2.02 Taylor High School Logo and Mascot - Griffin

The Taylor High School logo and Mascot were presented to the Board Members. Thank you to the 2 student artists that submitted a Griffin, strategic planners, counselors, principals, and anyone else involved in the creation of the Mascot and Logo.

# 2.03 Superintendent/Asst. Superintendent's Report Superintendent Williams:

- Count Day Update: Buildings are finalizing rosters and showing we are down 2 students.
   Historically for the last five years, the district has shown an average loss of 57 students.
- Security Update: As a reminder to all TSD students, staff and parents, the Michigan Department of Education's OK2Say was created to help empower students and others to prevent violence and make schools safe by confidentially reporting threatening behavior. The website, <a href="https://www.michigan.gov/ok2say">www.michigan.gov/ok2say</a>, is full of helpful resources.

- ALICE Training Scheduled: Thanks to Tony Armeniak and WCCC for offering to use their facility for training on April 25th. All staff will be trained with 500-600 being able to attend this first training.
- Board Policy Workshop: The allotted 28 hours of support from NEOLA has been used up and any additional assistance is \$125 per hour. With board approval, policy will continue with NEOLA returning for guidance towards the end of completion.
- Exploring Applitrak for the HR Department: Exploring the use of Applitrak with the district's HR office
  in improving and expediting the application procedures. This will be on the Agenda for approval at
  the next regular board meeting.
- Griffin and Athletic TG Logo: Last week, the High School Merger Committee affirmed support for the new Griffin and TG Logo.
- Combining Departments: Working with staff to look at opportunities to improve our efficiency of
  operations and our customer service to our students and parents. The first focus is to merge the
  special education and pupil accounting departments into one location. Food Services and Athletic
  locations are also being reviewed.
- Kindergarten Round-up Shirts have arrived: This year, all of our entering Kindergartners will get a
  welcome to Taylor shirt that says "Future Taylor High School Graduate". We are delivering these to
  all elementary schools and have enough for the entire entering Kindergarten class plus some extras
  for Kindergarten kids who enroll over the summer.

## **Assistant Superintendent Cyr:**

- The job posting for Randall, Myers, and West's Coach on Deck ends at 4:00 pm March 12th
- Every K-5 building will receive Future Taylor High School t-shirts for their incoming kindergarten Roundup students. K-5 schools and Johnson Pre-School have also received Kindergarten brochures to pass out regarding our TSD Kindergarten Curriculum.
- Thanks to a generous sponsor, the district will have a full page ad in an upcoming edition of Taylor
  Today. The ad features photos of our students in action, along with mention of the new high school's
  Wall-to-Wall academies. A TSD priority list, containing such points as being student-centered,
  utilizing engaging curriculum, technology integration, and community/business partnerships, will also
  be featured.
- Job-embedded Journeys' PD continues at the elementary level. Our Journeys' consultants are completing round 2 of the building-specific PD with teachers and building coaches.
- A TSD Team attended the MACUL conference in Grand Rapids. There were many Makerspace type
  activities that will help to drive our summer camp planning. We are also sending a team to the
  Michigan Reading Association Conference (MRA) this weekend, March 17-19 at Cobo Hall in Detroit.
- Tierney asked us to host a Virtual Reality (VR) and Makerspace PD at the Board Office on February 28<sup>th</sup> that was open to other districts. Tierney gave us two free slots for each half-day PD. Staff was sent to learn about both topics.
- The TSD Summer Camp planning continues. The job posting closes on Thursday, March 15<sup>th</sup>. The
  emphasis is on ELA, Math, and Makerspace/STEAM for Grades 1<sup>st</sup>-8<sup>th</sup>. Students will be invited
  based on i-Ready scores and teacher input.
- Early College Mailers for 10<sup>th</sup> grade students and Early College were sent out. The parent meeting is later this month.
- The Curriculum sub-committee continues to meet weekly on Wall-to-Wall academies.
- Testing We are continuing with the preparation for the standardized testing that occurs in the Spring. WIDA began February 5<sup>th</sup> and runs for 6 weeks and is completely online. Building administration has started the pre-identification of students in their building who must be assessed on the MSTEP/MI-ACCESS. The testing window opens on April 9<sup>th</sup> and closes May 25<sup>th</sup>. New for the district is that ALL buildings will be utilizing online assessments. Also, the New Science Assessment Pilot will be administered in the 5<sup>th</sup> grade (no longer in the 4<sup>th</sup> grade) and in the 8<sup>th</sup> grade (no longer in the 7<sup>th</sup> grade). According to the State, the reason for this change is that the science standards have moved from grad-level standards to grade-band standards (K-5 standards and 6-8 Standards). There will no longer be a performance task in ELA on any MSTEP assessment. The High School MME remains Paper/pencil for ELA and Math on the SAT, ACT WorkKeys will also utilize paper/pencil and Science and Social Studies assessment will be delivered online.
