

Dutch Henri Winter Sports Complex Snow Tubing Release of Liability

1. I assume full responsibility for the care of the snow tube while in my possession. I will not allow other individuals to use the tube unless they have signed this waiver, or, in the case of minors under age 18, their legal parent/guardian has signed this waiver.
2. I acknowledge and understand there are inherent risks involved in snow tubing, and that snow tubing is a dangerous activity/sport. The risks include but are not limited to: variations in the snow; steepness of the terrain; ice and icy conditions; variations caused by weather, grooming, and use of the slope by other participants; cables; utility lines; snowmaking equipment and components; natural and manmade obstacles on and off the chutes; as well as collisions with equipment, obstacles, and other people. I acknowledge and understand that the snow tubes cannot be steered and no brakes are on the snow tubes. I acknowledge and understand that snowmaking and snow grooming may be in progress at any time. I acknowledge that snow tubing and related activities are a hazardous activity with inherent risks and the choice to participate is voluntary despite the risks and dangers that these activities present. I acknowledge and understand that serious injury and or death can result from these activities.
3. Per Colorado State Statute Title 33, Article 41 ("Owners of Recreational Areas- Liability") which limits owner liability at no-fee public recreation areas, and in consideration of participating in snow tubing at Dutch Henry Winter Sports Complex and use of its facilities, I release and hold harmless and agree not to bring any action or suit against Lake County or Colorado Mountain College (or their employees or representatives) from any liability resulting from any personal injury to myself (or the minor child/children for whom I am the parent or legal guardian) including death, or damage to my property which is caused by the breach of any express or implied warranty or the negligent act or omission of any Lake County or Colorado Mountain College release in the design, location, construction, inspection, maintenance and repair of the conditions on or about the premises or tubing area or the operations of the tubing area. This release does not apply to claims of intentional or willful and wanton acts by Lake County or Colorado Mountain College.
4. I agree that all disputes arising from my use of the snow tubing and related facilities of Lake County under this contract shall be governed by the laws of the State of Colorado. I, the undersigned, have read, accept, assume and acknowledge the risks of snow tubing and understand the above Release of Liability.
5. Tube must be returned by the **Primary Adult** or **Primary Minor** participant. Renters must obey all fencing, signs, and safety rules posted on hill. A parent/guardian and their child under age 8 may ride the tube together. Otherwise, only one rider per tube at all times, and only one tube down a lane at a time.
