# CA PRELIMINARY CREDENTIAL TUITION REDUCTION SCHOLARSHIP

Traditional requirements to enter a credential program have been suspended due to the COVID-19 pandemic. To further encourage candidates to enter the field of teaching, National University is providing a limited-time scholarship opportunity!

National University is pleased to announce a new **25% tuition reduction scholarship** for California Preliminary Teaching Credential seekers in alignment with [Executive Order N-66/SB 820](#) put in place by Gov. Students must take a course no later than the August term, which begins August 2, 2021. This offer applies to candidates enrolled as of May 1, 2021.

## Suspension of Basic Skills (CBEST) to Enter a Preparation Program

While we strongly encourage our candidates to register and pass the basic skills requirement as soon as available, the requirement has been suspended for those who, between March 19, 2020, and August 31, 2021, were or are unable to complete the basic skills. Candidates will need to pass the basic skills requirement during their program prior to recommendation for their credential.

## Suspension of the Subject Matter Requirement for Intern and Credential Programs

The rule that individuals enrolling in a university Intern credential program must meet the subject matter requirement, and the criterion that the subject matter requirement be met prior to issuance of an Intern credential, has been suspended for candidates who, between March 19, 2020, and August 31, 2021, were or are unable to complete the CSET due to COVID-19-related testing center closures. Candidates for whom the CSET requirement is suspended must complete the CSET prior to being recommended for their credential. Candidates must complete all other requirements, including pre-service hours/coursework, Certificate of Clearance, proof of negative T.B., and Meet the regulations set forth in the U.S. Constitution.

Candidates who, between March 19, 2020, and August 31, 2021, were or are unable to complete the CSET due to COVID-19 related testing center closures will be able to complete all coursework, including methods, and, if eligible, to student teach during the 2020-21 school year.
