





### **Indoor Masking Changes:**

### Changes in Indoor Masking---moved up to March 12th

Governor Jay Inslee announced last Monday that Washington is lifting its statewide indoor mask policy earlier than previously announced.

Washington was set to lift the mandate on March 21, but will now do so at 11:59 p.m. on March  $11^{th}$ .

With no school for students on March 11<sup>th</sup> ,mask "optional" at school becomes effective for students and staff on 3.14.21.





The CDC's requirement for buses was eliminated two weeks ago, however DOH's guidance will continue to require masking on buses until March  $14^{\rm th}$ .

This means that beginning Monday, March 14 (which is now our snow make-up day), barring a new requirement from our local health department, masks will become optional in our school buildings and buses regardless of vaccination status. Staff and students will have the choice to wear a mask at school or on buses, with the expectation that others' choices will be respected. One should not make assumptions regarding someone's beliefs or health status, nor should they comment on them. In order to maintain our inclusive learning environment where all are valued, this choice should not be a topic of conversation as we continue to be resolute about our commitment to excellence in academic and social emotional learning for each and every student.

We are awaiting updated DoH PK-12 school guidance with specifics on contact tracing, testing, physical distancing, etc. The projected release later this week. Once this guidance is released, we will communicate the changes.

Until March 14, masks will continue to be required for all students, staff, and visitors in all Kelso School District buildings AND buses. Masks will continue to be provided for those who do not have them, and students who will not wear masks will be sent home. Kelso School District and our Board of Directors do not have local control over this matter. We are legally required to follow the Governor's directive, which currently requires masks in school buildings and on buses.

### **Vaccination Requirement--Staff**

On August 18, 2021, Governor Inslee announced a directive requiring all employees working for public and private K–12 schools to be vaccinated against COVID-19 or obtain a religious or medical exemption by October 18, 2021.

### **HEARD BUDGET STATUS UPDATE - JANUARY - SCOTT WESTLUND**

Overall, average annual District enrollment (including Running Start) for the 2021/22 school year was budgeted at 4826 FTE. February 1<sup>st</sup> total average enrollment was 4802 FTE or down 24 FTE from budget. We continue to see improving enrollment numbers as we move throughout the school year, particularly in our kinder grade without factoring in the new transitional kinder program.

It appears the same trend occurring last school year continues into this year with kinders showing up throughout the year rather than at the beginning of the school year as normal. We are up about 25 kinders from the beginning of October. If this trend continues we may see a relatively even to slightly below budgeted enrollment for the school year.

Beginning fund balance as of September 1, 2021, is \$6,755,864. This equates into an 8.8% projected ending fund balance of anticipated expenditures and transfers for the 2021/22 school year. Projected ending fund balance for August 31, 2022, is estimated to be in the range of \$6 million.

The budget looks good through the first five months of the school year.

### ACCEPTANCE OF DONATIONS - SCOTT WESTLUND

We have had two recent donations that I am seeking Board approval.

Kelso Youth Basketball through Jon Webb has donated a soccer weather shelter with a cost of \$5,449 plus tax.

Altrusa International's local Longview/Kelso Chapter has also donated \$5,000 of children's books to the Barnes Library.

We continue to appreciate the support that our schools and programs receive from our local community to help operate our schools and support student learning and extra-curricular activities.

I would ask that the Board accept this donation as required under Board Policy 6114. Under Policy 6114, the Board must approve the acceptance any gift to the district, school, department or classroom of money, materials, or equipment having a value of \$5,000.00 or greater.
