Certified P.P.C. Presentation

Mr. Bates shares that the Board should be proud of all the hard work done by the administration to get to this point. He then shared that in the area of Facilities, the Judge compared the Mills High facility to that of Robinson Middle and that the District would need to bring it up to par. Mr. Bates added that a proposal, with input from the Intervenors, approval of the Board and fully funded would have to be submitted to the Court by August 1, 2021. Board members gave suggestions as to how they think the proposal should be developed.

Comments from the Board

Ms. Ward acknowledged the College Station Elementary Appreciation celebration for their community partners on May 7, 2021. She expressed her thanks for the hard work that was done by Ms. Evans, Ms. Nash and Ms. Carpenter for putting the celebration together. Ms. Ward added that each grade level made signs thanking the community for their support and for the increase in support for that school/area. She then thanked Senator Chesterfield for her acknowledgement of the Mills High School Basketball team championship on the Senate floor and gave a shout to Coach Cooper.

Mr. Thomas shared that he had attended the Sylvan Hills High School Student Voice meeting and was impressed with the dialogue and communication between students and school staff. He stated that these students are our future leaders and suggested the Student Voice club be started in all PCSSD schools.

Mr. Maune shared his thoughts concerning the petition from the Robinson area parents regarding the Block scheduling changes. He stated that the families intentions are pure and asked the administration to plan a follow-up with these parents and suggested a community event, a flyer with more details or an in-person meeting.

Mr. Delaney added that the administration should interface directly with the community or figure out how to do so. He stated that he felt that the concerns brought forth were organic and the administration should consider meeting with



the Robinson community and focus on the mechanics of how this block scheduling will work and explain the schedule in a practical way.

Dr. Remele gave kudos to the administration for their hard work and testimony during the Federal Desegregation Court Case this past summer. She also thanked Judge Marshall for acknowledging the District's willingness to make things right.

Superintendent's Comments

Dr. McNulty began by acknowledging the new information that was published regarding COVID-19 vaccines for the 12-15 age group and stated that the District would be reviewing the information to determine if it would be feasible to provide a vaccination clinic for our students. He added that he loves the community responses and believes that the best decision will be made for all PCSSD middle schools and that the decision will not solely be a Robinson Middle School decision. Dr. McNulty appreciated the discussions surrounding Algebra I in middle school and the dialogue with all of the PCSSD communities. He announced each High School graduation schedule and that the events would be livestreamed by KATV, Channel 7. Dr. McNulty also recognized the new employees recommended for hire: Dr. Justin Luttrell, Director of STEM and Blended Learning, Michelle Camp and Teresa Moka, Assistant Principals.
