

**SULLIVAN COMMUNITY UNIT SCHOOL DISTRICT NO. 300
BOARD OF EDUCATION MINUTES**

Reorganizational Meeting

April 28, 2021

The reorganizational meeting of the Board of Education of Sullivan Community Unit School District No. 300 of Moultrie, Shelby, and Coles Counties, Illinois was duly called and held on April 28, 2021 at 7:05 a.m. at the Sullivan High School Media Center within the boundaries of said District.

Superintendent Walk asked the Board to appoint Ted Walk as President Pro Tem and Becky Batman as Secretary Pro Tem. Florey moved and Grooms seconded with all members voting "Aye".

Upon roll being called the following members answered and were found to be present: Justin Florey, Josh Green, Tyson Grooms, Zach Horn, and Jeff White.

Administrators present: Ted Walk

Visitors present: Norm Wood, Erik Stollard, Becky Batman

The Board agreed to appoint new Board members prior to electing Board officers. Two positions are available. Former Board members Erik Stollard and Norm Wood both expressed interest in the two open seats and meet eligibility requirements.

Horn moved that the Board appoint Erik Stollard and Norman Wood to the Board of Education to serve until the 2023 Board election. Grooms seconded. Upon roll call, all voted "aye".

The President Pro Tem asked for nominations from the floor for the office of Board President to serve for a term of two years. Horn nominated Jeff White for the office of President. The President Pro Tem asked for other nominations for President. There were no other nominations. The President Pro Tem instructed the Secretary, Pro Tem to record a unanimous vote for the nominee. The President Pro Tem declared Jeff White President and turned the meeting over to the President.

President White asked for nominations for the office of Vice President to serve for a term of two years. Tyson Grooms nominated Zachary Horn for Vice President. The President asked for other nominations for Vice President. There were no other nominations. The President instructed the Secretary Pro Tem to record a unanimous vote for the nominee. The

President declared Zachary Horn as Vice President.

President White asked for nominations for the office of Secretary to serve for a term of two years. Justin Florey nominated Erik Stollard for Secretary. The President asked for other nominations for Secretary. There were no other nominations. The President instructed the Secretary Pro Tem to record a unanimous vote for the nominee. The President declared Erik Stollard as Secretary.

President White stated that the Board needed to establish a regular time and place for its meetings. It was decided that the Board meeting will be held on the second Monday of each month at 6:30 p.m. in the Sullivan High School Commons with the exception of October, due to Columbus Day.

Stollard moved that the Board of Education continue to meet on the second Monday of each month at 6:30 p.m. in the Sullivan High School Commons with the exception of October due to the Columbus Day holiday. Upon being seconded by Green, the President put the question and the following members voted:
