

**SULLIVAN COMMUNITY UNIT SCHOOL DISTRICT NO. 300  
BOARD OF EDUCATION MINUTES**

February 6, 2021

The special meeting of the Board of Education of Sullivan Community Unit School District No. 300 of Moultrie, Shelby, and Coles Counties, Illinois was duly called and held on February 6, 2021, at 8:04 a.m., at the Sullivan High School Media Center within the boundaries of said District.

The President called the meeting to order and requested roll be called. Upon roll being called the following members answered and were found to be present: Justin Florey, Joshua Green, Tyson Grooms, Erik Stollard, and Jeff White.

Administrators present: Ted Walk, Dan Allen, Leslie Guyot, Nathan Ogle

Visitors present: Kevin Landrus

Superintendent Walk opened the meeting and turned the floor over to Elementary School Principal, Leslie Guyot.

Horn and Wood arrived at 8:05 a.m.

Elementary School Principal, Leslie Guyot, discussed enrollment, class size, staffing, the literacy curriculum, and building needs including the preschool playground, updating playground equipment for the K-2 and 3-4 playgrounds, establishing a memorial for Tyson Mendoza and Janiya Bennett, and temperature regulation throughout the elementary school.

Middle School Principal, Nathan Ogle, discussed middle school enrollment and class sizes. He went on to discuss middle school facility needs including updated restrooms and locker rooms, repairs to stairwells, and HVAC issues.

High School Principal, Dan Allen, discussed enrollment, class size, personnel needs, and building needs including updated bathrooms and gym/auditorium space.

Building principals left the meeting.

Transportation and Maintenance Director Kevin Landrus discussed transportation personnel needs and bus needs. Mr. Landrus also discussed recent

maintenance projects. He also discussed the need to replace the bus garage and press box roofs, door replacement in the middle school and high school, restroom remodeling, kitchen equipment, entrance matting for the middle and high schools, return air units for the science wing, playground surfaces, energy management system, and the lighting grant.

Mr. Landrus left the meeting.

Superintendent Walk discussed the building master plan, ESSER II Funds, extra-curricular activities, academic programs, food service, maintenance and transportation.

Florey moved that the Board adjourn to closed session to discuss appointment, employment, compensation, discipline, performance, dismissal of specific employees; collective negotiations matters; superintendent's evaluation; student disciplinary cases; matters relating to individual students; litigation; and, minutes of meetings lawfully closed pursuant to Statute Sections 5 ILCS 120/2 [c] 1, 2, 9, 10, 11, 14. Upon said motion being seconded by Grooms, the President put the question and the roll being called, the following members voted:

Whereupon, the President declared said motion carried, and the Board adjourned to closed session at 11:28 a.m.
