Mr. Cyle Dibble gave a technology update.

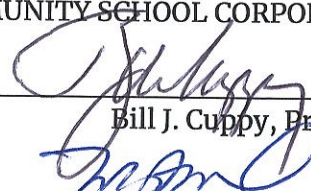
Mrs. Hagerty gave a curriculum update.

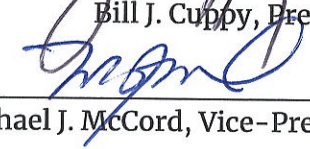
