Re: 2021-22 Budget Adoption

BACKGROUND:

The 2021-22 Preliminary Budget was presented for review at a Public Hearing in conjunction with the Local Control Accountability Plan (LCAP) on June 3, 2021. Subsequently, negotiations with all bargaining units were completed, along with tentative agreements for both the 2020-21 and 2021-22 years. The proposed budget included salary improvement estimates, and will only require minor adjustments to the salary and benefits expenditures as a result of a higher 2020-21 increase. All other budget data and projections remain intact within the budget and estimated actuals financial data and are presented for consideration.

The 4th Budget Revision for 2020-21 indicated adjustments for salary improvements, and estimated actual indicate a narrowing of general fund deficit spending and an increase to restricted ending fund balances, mainly due to a result of In-Person Instruction and Extended Learning Opportunities funding.

2021-22 Revenues

Almost all estimated District revenue increases will be occur in Property Taxes (\$102,298) and Parcel Taxes (\$43,595), but are mitigated by charter school property tax transfers estimates at an increase of \$50,248. Net increases to Revenues is estimated at a net increase of \$95,645.

2021-22 Expenditures

Estimated District expenditures are as follows: Certificated salaries are reduced by \$54,120 due to changes within approved staffing level of 12 FTE. Classified salaries increase \$51,989 as a result of one-time funding positions. Benefits increase \$72,316 due to increases in SUI (\$24,600) and PERS/STRS (\$49,917), and a small decrease in worker's compensation (\$2,201). Supplies are budgeted flat, net of 2020-21 one-time funded supplies purchases. Contracts increase \$158,030 due to increases to NPS placements (\$68,750), County Special Education program 1-1 aides (\$48,690), budgeting of one-time funds (\$28,674), support services for librarians (\$6,850), with the remaining \$5,066 accounting for increases to existing contracts. Transfers are estimated to be flat year over year is \$95,910.

As a result of modifications made between the budget hearing and presentation for adoption, unrestricted deficit spending is estimated at \$18,551 and restricted is estimated at a deficit of \$199,945. Please note that ISI/ELO one-time funding alters this balance, as revenues are recognized in 2020-21 and expenditures in the amount of \$198,528 are budgeted to occur in 2021-22.

As the Budget indicates, based on the assumptions included in the Governor's May Revise and in the School Services of California Dartboard, the Lagunitas School District will be able to meet its financial obligations for the current fiscal year, and two subsequent projection years. This agenda item presents for final Board consideration the proposed 2021-22 Lagunitas School District Budget for approval on June 17, 2021.

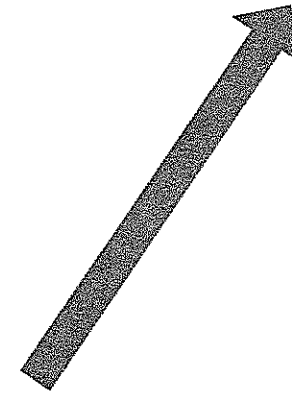
