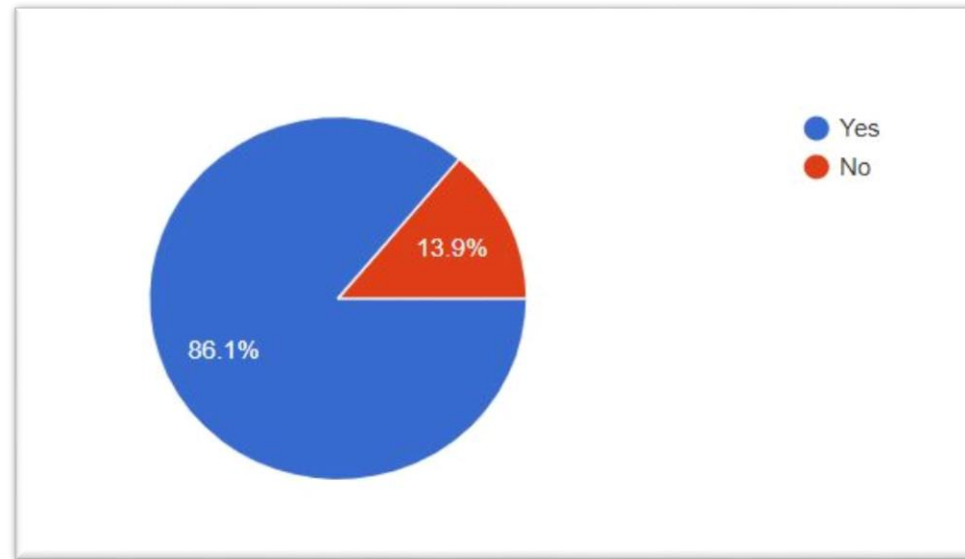


Do you support the school district moving forward with this plan as we "re-open" the school to pre-pandemic operations?
