USD #480 Nutrition Services is soliciting bid prices for the 2021-2022 school year for the attached food/non-food items. Bids must be completed and submitted no later than **Monday July 19th at 12:00 PM.** Bids are awarded by line-item. We require a hard copy as well as an electronic copy of your bid in the <u>same format as the original</u>.

The duration of this bid is from July 31st st 2021 to June 30th 2022. Bids will be awarded via e-mail by 7/30/21. A hard copy will also be mailed upon request.

Bidding requires firm annual pricing

The amount needed is intended only as a useful guide and does not imply a guarantee as to minimum or maximum amounts. Bid prices shall remain firm during the indicated quote period, including the beginning and ending dates.

Midterm cost adjustment: A midterm cost adjustment with proof of a manufacturer increase of 5% or greater may be requested. All proposed price adjustments with supporting documentation must be received by Liberal Public Schools, Director of Child Nutrition and Wellness, by the first Monday in December of the contract year. Approved price increases will go into effect for products ordered on or after January 1 of the following year. The price adjustment requests must state the proposed new price changes; provide a copy of the manufacturer's old and new price list and a letter from the manufacturer stating that there are no special prices available. All proposed price adjustments must be approved by the Liberal CNW in order for any new pricing to take effect. Price decreases will not require any proof from the manufacturer. Liberal CNW reserves the right to solicit other sources for items when increases are proposed, and may change the source of supply if the proposed pricing seems unjustified.

Bidders must guarantee that if they do not currently stock the item being awarded that they will begin stocking the item in time for school ordering (July 2021) and as new items are added to the bid going forward.

If quoting an item that is considered "special order", this must be noted on each item as quoted on the bid specifications sheet.

Termination for cause and for convenience: Valid causes for termination of the bid agreement will include but are not limited to:

- 1) The vendors failure to adhere to any of the provisions of the General Terms and Conditions of the IFB
- 2) The vendor delivering any product(s) that fail to meet Item Specifications included in this IFB relating to the awarded product(s)
- 3) The vendor delivering any substitution(s) different than those originally proposed and awarded without prior written approval of SFA
- 4) The vendors failure to meet the require delivery schedules as defined in the IFP documents
- 5) The vendors violation of any other provision contained within this IFB

Each vendor will indicate the brand name they are bidding, pack size and manufacturer number of each product. Specifications furnished with this bid are intended to establish a quality or performance level which will provide the best product available at the lowest possible price. The Brand/product listed on the bid is the preferred item, all brands will receive **equal** consideration. Lack of any of the required/requested information could result in that item not being accepted.

USD #480 will accept deliveries between the hours of 5:30 AM – 11:00 AM and 12:30 PM – 1:30 PM. Orders outside of these times must be preapproved by Connie Vogts or Carmen Pineda.

All material containers must be free from rust and large dents or sharp cuts. Paper, cardboard, and plastic containers should be free from tears and should not show signs of excessive warehouse deterioration. It is the expectation that all products delivered will be in good condition and free from damage. Any damaged items/products will be refused/returned and credit shall be given to USD #480

Due to USDA requirements:

Only 100% domestically grown and processed products are approved for purchase.

- 1) As required by the "Buy American" provision, all products must be of domestic origin as required by 7 CFR Part 210.21(d)
 - 2) USD #480 participates in the National School Lunch Program and School Breakfast Program and is required to use nonprofit food service funds, to maximum extent practical, to buy domestic commodities or products for Program meals. A "domestic product" is defined as one that is either produced in the U.S. or is processed in the U.S. substantially using agricultural commodities that are produced in the U.S. as provided in 7CFR Part 210.21 (d)
 - 3) An alternative or exception to the "Buy American" may be approved upon request. To be considered for the alternative or exception, the request must be submitted in writing to the Food Service Director five (5) days in advance of the bid submission and a minumum of five (5) days in advance of delivery. The request must include:
 - A. Alternative substitute(s) that are domestic and meet the required specifications
 - i) Price of the domestic food alternative substitute(s): and
 - ii) Availability of the domestic alternative substitute(s) in relation to the quantity ordered.
 - B. Reason for the exception: limited/lack of availability or price (include price):
 - iii) Price of the domestic food Product; and
 - iv) Price of the non-domestic product that meets the required specifications of the domestic product.

Products with multiple countries of origin listed on the label require an attestation statement ensuring that a minimum of 51% of the final processed product consists of agricultural commodities grown domestically.

Vendors <u>must</u> provide <u>signed</u> CN labels for all engineered products. If no CN label is available for the product, vendor must submit a signed Product Formulation Statement from the manufacturer that certifies the creditable componets of the product. Vendor <u>must</u> provide <u>signed</u> Product Formulation Statements for all grain products.

CN labels and Product Formulation Statements must match the item vendor is submitting for bid and be up to date/current information.

Each vendor submitting a bid shall provide USD#480 with a HACCP plan or written statement that their company uses safe food handling practices to ensure the safety and quality of items purchased from them. Be further advised that temperatures will be taken at random on items delivered. Any product that is not at the proper temp will be rejected without exception. In addition, please provide a written statement of how food recalls will be handled for your company and how USD #480 will be notified.

Be advised that the USDA has banned foods containing trans-fats from being served in school meals. Any item that contains trans-fats will be refused or sent back if item is deemed not eligible to serve in the USDA Child Nutrition Programs.

PRODUCT RECALLS Manufacturers and distributors are expected to comply with all federal, state, and local laws and regulations regarding recalls. The Distributor shall have a process in place to effectively respond to a product recall which should include the following objectives:

- 1. Provide accurate and timely communication to the District regarding a recall both verbally and in writing.
- 2. Ensure that unsafe products are removed from school sites in an expedient, effective and efficient manner.
- 3. Streamline the process for reimbursement for recalled products.
- 4. Contractor will be responsible for all cost associated with replacement product, shipping charges, and/or product credit.

LiberalCNW will make final decision whether product needs to be credited or replaced.

USD #480 Nutrition Services will analyze each individual item proposed and determine the award based on pricing, brands desired and what is believed to be in the best interests of the Child Nutrition program. USD #480 Nutrition Services reserves the right to accept or reject any bid in whole or part.
