1. Call to Order

3. Consent Agenda

a. Resignation of Licensed Staff

It was recommended that the Board accept the resignation of Amy Kraus, district band teacher, effective at the end of the 2020-2021 school year.

b. Resignation of Classified Staff

It was recommended that the Board accept the resignation of the following classified staff:

- i) Madison Francis, food service cashier at Prairie Hills Middle School effective January 12, 2021.
- ii) Jessica Carpenter, preschool paraprofessional at Plum Creek Elementary, effective January 18, 2021.

c. Transfer of Staff

It was recommended that the Board approve the transfer of Stacia Weilert from 6th grade science/Badges teacher to Art Teacher at Prairie Hills

Middle School for the 2021-2022 school year. This is a transfer only and will not affect her salary.

d. Employment of Classified Staff

It was recommended that the Board approve the employment of the following classified staff:

- Dave Harmony, bus driver. He will be paid \$25 per hour with a 2-hour daily minimum.
- ii) Blair Hollenbeck, Cares Club aide at Plum Creek Elementary. She will work 3 hours per day at a wage of \$8.65 per hour. She will start on January 19, 2021.

e. Employment of Supplemental Staff

It was recommended that the Board approve the employment of Veronica Brandt as assistant track coach at Prairie Hills Middle School. She will be placed in Column D and Level 1 of the Supplemental Salary Schedule with a salary of \$1,960.

f. Addition of Supplemental Position

It was recommended that the Board approve the addition of a ½ time soccer coach at Prairie Hills Middle School. This position will be privately funded with no additional costs to the district.
