CALL REGULAR BOARD MEETING TO ORDER AND ROLL CALL.

President Chad Ruppert called the regular board meeting to order and roll call was taken with seven board members present. Board members present were Janssen, Ruppert, Kettelkamp, Bauman, Fesser, Tarter, and Gasparich. Also present were Superintendent Doerr, Principal McDowell, Assistant Principal McDonald, and Principal Reedy.

Paul Watson came to the Board asking to add an additional volunteer coach to the football program next week.

SUPERINTENDENT'S REPORT

I think this is about the first in the last 12 years, but the States only owes the District \$28,648.14 in Driver's Education and Early Childhood funding. Driver's Education is behind 2 payments and each of the EC grants are only behind 1 payment. Everything else is paid up-to-date including Transportation and Special Education. As for legislation, the May 31 deadline is coming to an end. The Governor has revised his budget proposal to include additional funds in the Evidence based funding model.

Graduation is set for Saturday, May 29, 2021 at 7:00 p.m.

I have included a copy of the Fuel (RFP) Bid sheet for your review. These will go out next week and an ad placed in the paper per requirements.

As for summer projects, here is some information:

- a. Greenhouse will be delivered and built on or around June 7...
- b. Kitchen plans are in the works and Poettker will start on that when we are ready. The problem here is going to make sure we get all the equipment in before school starts in August. We will keep all of the old equipment for the time being just in case.

- c. The cameras for North School are ready to be installed.
- d. The intercom system at North School will be ready in July.
- e. They will start cleaning all ducts and place the cleaning machines in the AC units starting in July after summer school.
- f. I will be ordering new flooring for the JH and North offices next week as well as the North School Music room.

Summer School Information:

- g. Curriculum for Reading has been ordered.
- h. Curriculum for Math is awaiting final numbers to order.
- i. We have 5-8 high school students that will engage in credit recovery.
- j. We have 0-2 JH students that will need credit recovery.
- k. We have 55 elementary students signed up so far with 20 awaiting parental permission.
- 1. We have approximately 30 students who have been recommended at the JH for summer school.
- m. Flyers for summer school has been posted and awaiting parents to sign other kids up.

The Resolution to deny Taylorville their withdrawal was mailed and return receipts returned. We offered Taylorville a way to keep the FACeS/CBI program in Taylorville by giving them a list of expectations, but the Superintendent denied it. It is likely, with the blessing of our attorney, that we will move the program to both Nokomis/Pana to be split next year. Under the terms of the amended Joint Agreement, Taylorville cannot start her own program, if she tried, legal action can and will likely be taken. Now, they are blaming all the dysfunction on the curriculum. We have a great research-based curriculum, but it is not being taught with fidelity because they will not allow NPT Personnel to supervisor that instruction properly, but also because during remote learning this year, the curriculum was not being utilized properly. Actually, it is just another excuse with incorrect information.
