Executive Session for Sole Purpose of Conducting a Due Process Expulsion Hearing Under 1 MRSA §405(6)(B)

Upon the motion of Wanda St. Peter and second by Amy Bean, in order to preserve the peace and usefulness of the school, members voted to expel Student X from school for deliberate disobedience and disorderly conduct inappropriate for the school setting for an indefinite period of time and to direct the Superintendent of Schools and her designee(s) to work with the student and family to develop a re-entry plan that will include educational services. The student is not permitted to be on District property for the duration of the expulsion. If a re-entry plan is implemented and sufficient evidence is presented to show that the behavior that has caused the need for this expulsion will not recur, the Board of Directors may consider readmission of the student.
