Insurance for the 21-22 School Year: Bushue HR conducted a commercial insurance analysis on behalf of the district. The lowest responsible bidder would be Utica National (James Unland & Company) for the Package and BITCO (Jason Shasteen of Gallagher) for the Worker's Compensation. Motion by Faralli, second by Slack, to approve the lines of insurance in the amount of \$138,606 as presented. Travis Bushue was present to answer questions. Much discussion and questions were answered on how comparisons were made as there were different types of insurance packages. The PSIC (pooled insurance) was explained as there is not as much flexibility in what was separated out to bid on. Dan Kiesewetter (KIA) and Pat Taphorn (Unland) were also present and were able to answer many questions. Also discussed was the added layer of the recommendation to go with two separate companies for the Package and Workman's Compensation. Currently the district utilizes one insurance broker for both -Selective and Accident Fund for workman's comp through Unlands. It is also recommended to review this insurance every three years. Dr. Chatterton reviewed the timeline beginning last year on beginning the renewal process that the insurance committee went through. The Board shared a general desire to keep the district insurance with a local company. After much discussion motion by Deppermann, second by Faralli, to amend the original motion to say

"approve the Utica (Unland) Package bid and the Accident Fund (Unland) for Workman's Compin an amount to not exceed \$145,000. Roll Call Vote: 4-2 Motion carried.

Committee Reports were made by the Curriculum Committee (April 28 and May 6) and the Labor/Management Committee (May 6).

Student Fees: Dr. Chatterton reviewed the outstanding student activity, lunch account, and registration fee balances, the incentives to get payment prior to the beginning of the year, and what steps the district has gone through to recoup this money. Discussion on options included repayment plans, using a collections agency, letters to be sent out, etc.

Dr. Chatterton will start formulating the committee work to align to our strategic statements in the near future.

Dr. Chatterton has also been working on the FY21 Amended Budget for approval at the June 21 meeting. The Board was also advised that next year's budget will be challenging as property tax monies will not be distributed as early. Along with that sales tax revenues are on hold with a possible 50% drop in those funds next year. With the State of Illinois being in bad financial state as well, it would be logical to anticipate those funds will be impacted.

Dr. Chatterton reported that applications have been received for the open two year board seat. In a short amount of time there has been significant interest from a wide range of community members.

Mr. McMillin shared a few highlights of a potential foreign exchange opportunity for the high school. The EF Program has two students and two families willing to host. The next step would be to accept EF as a Foreign Exchange Vendor. Currently the school has taken students through the Rotary Exchange Program.
