Lubbock-Cooper ISD Community and Student Engagement Ratings

Texas Education Code (TEC) 39.0545 requires that school districts annually evaluate Community and Student Engagement (CaSE) for the district and each of the campuses within the district. There are eight reporting categories in CaSE that include: Fine Arts, Wellness and Physical Education, Community and Parent Involvement, 21st Century Workforce Development, Second Language Acquisition, Digital Learning Environment, Dropout Prevention Strategies, and Gifted and Talented Programs.

School districts and their campuses will assign a rating of Exemplary, Recognized, Acceptable, or Unacceptable in each of these eight categories and submit these ratings to the Texas Education Agency (TEA).

Beginning this year with TEC 39.0546, each school district and campus must annually select three of the eight categories and rate itself with a grade of A, B, C, D, or F for academic accountability ratings. The three categories districts and campuses select and the rubric on which the grades are based must be submitted by June 18, 2017. District and campus grades will be submitted in May 2018. TEC 39.0546 is in addition to TEC 39.0545.
