School Nurse

Description:

Provide basic first aid.

Examines students who present probable symptoms of a communicable disease.

Facilitates and administer medication/self-medication.

Provides services to students having special medical needs as ordered by their physician.

Maintain student medical records and forms

Review immunization data on assigned students for accuracy and completeness.

Documents all accidents on the school's accident report form.

Contacts appropriate adult to arrange transportation of sick or injured students.

Conducts height and weight screening for all students in assigned building.

Schedule students for various screening procedures and for medical examinations.

Maintain a complete, accurate health record for all students assigned and initiate a health record for all new students.

Inventory supplies, secure and dispense all necessary supplies to maintain health room standards.

Assist with annual kindergarten registration and medical documentation for student records

Consult with students and families to make appropriate agency referrals.

Schedule and assist with mandated school dental exams and physical exams
