## January 8, 2018

The meeting of the USD 306 Board of Education was held on Monday, January 8, 2018 at 7:00 p.m. in the Board Conference Room.

The meeting was called to order at 7:03 p.m. by President Kenny Costigan.

A motion was made by Brandon Hughes and seconded by Steve Bartholomew to approve the agenda as presented. Carried 5-0

A motion was made by Lori Blake and seconded by Steve Bartholomew to approve the minutes December 11, 2017 monthly meeting and December 20, 2017 special meeting, as presented. Carried 5-0

A motion was made by Steve Bartholomew and seconded by Lori Blake to approve the General Fund Warrants and Vouchers for the month of January 2018 for a total of \$202,198.25, Elementary Activity Funds, High School Activity Funds, and the Food Service Funds. Carried 5-0

## **Presentations:**

### **Audit Report**

Representatives from Varney and Associates, CPAs, LLC, Eric Kientz and Taylor Penick were present. Eric Kientz explained the audit documents which covered the 2016-2017 fiscal year. Eric Kientz stated it was a very clean audit with inhouse financial information matching the state financial information for USD 306.

A motion was made by Lori Blake and seconded by Steve Bartholomew to accept the audit report as presented and the necessary reports be filed with the State of Kansas. Carried 5-0

Recommended Board of Education Policies and Updates

Mr. Mann reported there was only one change being recommended by KASB to board policy, which states the KOMA changes in regards to executive sessions. USD 306 has already adopted the new guidelines.

A motion was made by Lori Blake and seconded by Brandon Hughes to adopt the revised BOE policy BCBK as recommended. Carried 6-0

#### Capital Outlay projects for 2018

Mr. Mann reviewed the proposed capital outlay projects for 2018. Consideration for approval will be in the February Board of Education Meeting.

#### <u>Update on Student Achievement</u>

Roger Stumpf reported on the achievements of secondary students including Senior early release; dual credit courses; Gallup student poll on student involvement; and community care student survey. Cassie Gorman reviewed the winter AIMS Web and Pathways test levels for elementary students.

#### Negotiations: Determine the Board of Education Negotiation Team

Last year's team consisted of Steve Bartholomew, Lori Blake, and Becky Cooper. Mr. Mann stated Kenny Costigan has been/is on committees that have arisen from negotiations and would recommend Kenny Costigan fill the position vacated by Dr. Cooper.

A motion was made by Justin Knopf and seconded by Brandon Hughes to appoint Kenny Costigan, Steve Bartholomew, and Lori Blake as the Board of Education negotiation committee. Carried 7-0
