# **Presentations:**

### **Student Council Request for Outdoor Lunch:**

Student Body President Luke Van Tassel has been in communication with Dr. Ogle and Mr. Stumpf with a basic plan for an outdoor lunch area. Administration will work with the student body to facilitate a plan that works for everyone.

### **Consideration of Bid Specifications:**

Mr. Stumpf shared that updated bid specifications for the parking lot have been shared with the Board of Education. Final drafts will be ready to be approved at the January meeting.

### **Early Childhood Survey:**

Several edits have been completed by Ft. Hays Docking Institute on the Early Childhood Survey. Justin Knopf shared some additional edits which Mr. Stumpf will pass onto the Docking Institute.

A motion was made by Justin Knopf and seconded by Dwight Conley to approve the Early Childhood Survey as amended. Carried 6-0.

### **Board Policy updates:**

Board policy updates from KASB will be reviewed at the January meeting.

### **Capital Projects:**

Mr. Stumpf went over Capital Outlay expenditures from the last year and future projects planned. He also gave an update on the playground project and explained a change to the project since the presentation in November. The committee has found a different playground structure which will meet more needs and has a grant attached to it reducing costs of equipment, instillation and groundwork. The Thomas bus is experiencing problems with the engine. Discussion took place whether to fix the bus or cut losses and replace it with something newer.

A motion was made by Justin Knopf and seconded by Kenny Costigan to authorize the ordering of the proposed playground structure. Carried 6-0

A motion was made by Dwight Conley and seconded by Brandon Hughes to replace the engine in the Thomas. Carried 6-0

## **Communications:**

### **Board of Education**

Board of Education President Lori Blake recognized outgoing Board of Education members Brandon Hughes and Kenny Costigan for their years of service to the students and staff of USD 306. She also congratulated Mr. Stumpf on graduating from Leadership for Tomorrow. Lori and Mr. Stumpf attended KASB Annual Conference this past weekend and updated the rest of the Board of Education on details of the weekend. Mrs. Blake also shared details on upcoming events through KASB & CAPS. Justin Knopf shared questions and concerns he has been hearing from parents about possible plans for the library position and transition with the retirement announcement of Mr. Lynn, and requested some additional follow up discussion and information including library standards.
