#### <u>Summer Food Program:</u>

USDA has extended the Summer Food Program though September 30, 2021 allowing us to provide the breakfast and lunch program as we did for the summer of 2020.

## <u>Transportation Proposal:</u>

James Seidel with the Transportation Department provided a proposal related to the electrical stipend to bus drivers during the winter months.

A motion was made by Jill Ade and seconded by Lori Blake to adopt the new electrical reimbursement rate for transportation as proposed. Carried 6-0

#### **Summer Academic Camps:**

Mr. Stumpf provided a brief overview of plans for a summer academic camp being planned at SES. The intent of the camp is to regain lost learning for students K-6<sup>th</sup> grades due to the pandemic.

#### **Staffing review:**

Mr. Stumpf and the Board of Education discussed the need for an additional Kindergarten Teacher based upon current enrollment projections and how that additional position should be funded.

A motion was made by Jill Ade and seconded by Justin Knopf to add a third Kindergarten section for the 2021-22 school year and pay for the position out of the general fund. Carried 6/0

#### **SEL Curriculum:**

The Counseling and Administrative teams have spent many hours researching Social Emotional programs and have chosen Character Strong as the best fit for Southeast of Saline. The board watched a demonstration and Ms. Wright answered implementation questions.

A motion was made by Lori Blake and seconded by Steve Bartholomew to purchase the Character Strong program and pay for the associated professional development out of ESSER II funds. Carried 5/1

Ms. Wright and Mrs. Gorman provided the Board of Education information on dual credit, ACT and State & Local Accountability Data.

## **Communications:**

#### **Board of Education**

Board President Lori Blake congratulated the Leadership Team on the Kansas Can Star Recognition accomplishments for 2020. She also shared as KASB President, she was able to attend the National School Boards Association virtual conference and received a lot of good information. KASB's Women's Leadership Conference will be held in Manhattan next week with space still available through the virtual option. The Board sponsored Top 10% Leadership event will be held April 2st at 10:00 a.m. Lori shared how important it is to reach out to our legislatures on the decisions they are in the process of making, directly affecting public education. Jill Ade updated the Board on the Gypsum Summer Youth program details.

## **Superintendent:**

Mr. Stumpf echoed Lori Blakes appeal to reach out to our legislature. The Transparency Bill recently passed has put school districts in a huge bind trying to create the budget for next year barely closing out this year. Legislatures have not passed a budget at this point, adding to the difficulty to plan ahead and meet deadlines. Mr. Stumpf also shared a preliminary budget on how we plan to allocate our ESSER II dollars.
