## A MESSAGE FROM THE SUPERINTENDENT

#### GALESBURG-AUGUSTA COMMUNITY SCHOOLS IS PLANNING FOR OUR DISTRICT'S FUTURE...

Did you know.... Most local school districts have a 3-5 year strategic plan to guide their work in educating their community of students. G-A is currently in that process.

Last fall, the Board of Education moved forward with developing the District's next strategic plan. Gartner & Associates who work with many districts throughout Michigan, began helping us collect multiple sets of data that we will use to develop our district's goals. These will serve as our guide to improve our service to our students, our staff, our parents and larger community in preparing each and every child for their futures after graduation.

We are thankful to all those individuals who participated in our November focus groups. 106 juniors and seniors, staff, parents, and community members participated in facilitated conversations that probed what we are proud of and what can be approved.

Over the past month, we invited 8-12 grade students and all staff, parents, and community members to participate in surveys that will provide significant additional data around which to forge goals for the future. We are committed to this process and excited for the future we will bring to our children and G-A Family.

The final step will be completed in June. A stakeholder group of student, community, parent, and district leaders will take the data we will have collected and Dr. Nick Ceglarek, the superintendent from Northwest Education Services (formerly named the Traverse Bay ISD) will facilitate a day long workshop in developing the final plan.

We expect to be able to publish and share our new strategic plan with all stakeholders in the fall of the 2023-2024 school year.



### MULTI-PURPOSE ATHLETIC FACILITY

In November 2021, a committee of 15 individuals began working on plans for the athletic field. Committees are always formed when projects begin their design phase, to be sure stakeholders are involved who do the homework and final design of the projects. When we began planning back in 2019, our community wanted to see a new track and field stadium, after 20 years of not having a track and field available for our athletes. In addition to football, community walks on the track, Physical Education classes, softball and baseball teams will all be able to use this facility. In addition, we have an amazing music program at G-A and we want to increase opportunities for those students. An example of this would be hosting marching band competitions. Turf is a better surface for marching band. Turf also allows multiple groups to utilize the space at the same time without worrying about tearing up the field. Use of the turf field is also less dependent on weather than grass. Safety is always a concern, and the committee did evaluate the safety of turf vs grass.

Because we had interest earnings that were significantly higher than anticipated due to the market and additional funds due to the sale of the bonds, the District is able to pay for the turf. We are looking forward to playing at least one home football game next year and are planning a ribbon cutting ceremony.







#### WHY NAME THE FIELD AFTER COACH MASKILL?

Many younger families will not know about the the legacy of Coach Bill Maskill, both on the field and after his retirement. Listed below are the many accomplishments of his athletes under his leadership. Additionally, after retirement, "Coach" and his entire extended family continued to significantly support the district. Coach touched hundreds of lives, and those individuals and their families continued a strong relationship after his retirement because of his mentorship and friendship until his passing.

G-A was a formidable foe and other districts never looked forward to playing against us during that time. Very few school districts can tout such a legacy. But like those who do have histories of influential coaches, G-A will name the field in his honor:

Home of the Rams Stadium and Maskill Field.



#### GA Primary School "RAMS" Power Packs

On Friday, January 27, 2023, Galesburg-Augusta Primary School re-introduced the "RAMS" Power Packs program. On that day, the first bags of nourishment went home with 44 students. With the help of an Educational Enhancement Grant from the Galesburg-Augusta Community School Foundation, and a monetary donation from the Jim Hemenway Wealth Management Group, enough funding has been secured to operate this program every Friday through June of 2023. A special thank you also to the Galesburg-Augusta Harding's Marketplace for donating the plastic bags to pack the food in.

The program, which was piloted in 2018 at the Primary School by Heather Ludlow and Leslie McCaw, was discontinued during the COVID pandemic as food was provided weekly by the district while students were learning remotely from home. Now re-introduced, Power Packs are meant to be a source of food for students over weekends or breaks away from school.




# MIDDLE SCHOOL



#### NOTIFICATION OF RIGHTS UNDER FERPA

The Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

1. The right to inspect and review the student's education records within 45 days after the day the Galesburg-Augusta Community Schools receives a request for access.

Parents or eligible students who wish to inspect their child's or their education records should submit to the school principal a written request that identifies the records they wish to inspect. The school official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

2. The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.

Parents or eligible students who wish to ask Galesburg-Augusta Community Schools to amend their child's or their education record should write the school principal, clearly identify the part of the record they want changed and specify why it should be changed. If the school decides not to amend the record as requested by the parent or eligible student, the school will notify the parent or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.

3. The right to provide written consent before the school discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent.

One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. The criteria for determining who constitutes a school official and what constitutes a legitimate educational interest must be set forth in the school's or school district's annual notification for FERPA rights. A school official typically includes a person employed by the school or school district as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel) or a person serving on the school board. A school official also may include a volunteer, contractor, or consultant who, while not employed by the school, performs an institutional service or function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of PII from education records, such as an attorney, auditor, medical consultant, or therapist; a parent or student volunteering to serve on an official committee, such as a disciplinary or grievance committee; or a parent, student, or other volunteer assisting another school official in performing his or her tasks. A school official typically has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

4. The right to file a complaint with the U.S. Department of Education concerning alleged failures by the Galesburg-Augusta Community Schools to comply with the requirements of FERPA. The name and address of the Office that administers FERPA are:

[NOTE: In addition, a school may want to include its directory information public notice, as required by § 99.37 of the regulations, with its annual notification of rights under FERPA.]

#### INDIVIDUAL WITH DISABILITIES EDUCATION ACT REQUIREMENTS

The Individual with Disabilities Education Act (IDEA) requires all states to have a "comprehensive Child Find system" to assure all children who are in need of early intervention to special education services are located, identified, and referred.
