**OVERVIEW:** The Revenue/ Expenditure reports for the year-to-date periods ended February 29, 2020 and March 31, 2020 are attached for your review. The following discussion will focus on the March financials as they are the most current and relevant. The COVID-19 related school closure that began on March 16<sup>th</sup> has introduced quite a bit of uncertainty regarding the district's finances. While distance learning continues, many activities have been halted and many district obligations have been reduced or eliminated. It will take time to work through these issues so please keep in mind that any projections contained in this report are preliminary and subject to change.

**REVENUE:** Year to date revenues through March 31, 2020 were \$28,634,473. We expect to see a shortfall in Medicaid Reimbursements for the remainder of the year as reimbursable student services expenditures are reduced or eliminated. Little Compton Tuitions will be below budget due to a lower number of enrolled students but that revenue will be more than offset by a higher than budgeted number of CTE students from other districts. In total, revenues are projected to be below budget by approximately \$35,000 to \$50,000.

**EXPENDITURES:** Year to date expenditures through March 31, 2020 were \$26,970,051. An additional \$8,042,273 was encumbered for the year, primarily related to payroll costs and special education out of district tuitions and related services costs. We are currently reviewing these encumbrances to determine whether or not these obligations still exist given the school closure. While the salaries related obligations are very likely to continue, the other expenditure encumbrances may change due to our review. A preliminary analysis has been preformed and it appears that overall expenditures will likely be reduced by approximately \$1,000,000. Expenditures that will be reduced include Bus Transportation, Spring Athletic Stipends and Transportation costs, and Occupational, Physical Therapy and Contracted Nursing Services for students. These estimates are likely to change as we better understand the school closure impact.

**SUMMARY:** These are challenging times and there are many uncertainties. We will continue to update our projections and inform you of any changes in the district's finances.
