RE: Revenue/Expenditure Reports for September 2019

DATE: October 30, 2019

OVERVIEW: The Revenue/ Expenditure reports for the year-to-date period ended September 30, 2019 are attached for your review.

REVENUE: Revenues through September 30, 2019 were \$9,293,602, representing an increase of \$3,513,790 from August. The monthly revenue primarily consists of the Town Appropriation of \$2,791,177, State Aid of \$618,636 and Group Home Aid of \$98,746.

EXPENDITURES: Net expenditures through September were \$6,885,840, representing an increase of \$2,801,664 from August. An additional \$19,857,396 was encumbered for the year, primarily related to payroll costs and special education out of district tuitions and related services costs. Workers Comp Insurance (52710) is over budget by \$41,721 and Property and Liability Insurance (55201) is over budget for the year by \$8,420. Budget transfers have been proposed to fund these overages.

SUMMARY: At this early point in the school year both Revenues and Expenditures are projected to be on budget. We will continue to monitor all budget lines as the year progresses, especially as we enter into the winter months with the variability that weather introduces.
