OVERVIEW: The Revenue/Expenditure reports for the year-to-date period ended January 31, 2019 are attached for your review.

REVENUE: Revenues through January were \$22,227,186 representing an increase of \$3,844,396 from December. This primarily consists of the Town Appropriation of \$2,737,186, State Aid of \$657,808, Group Home Aid of \$82,566 and Tuition from Other Districts of \$324,302.

For the year, total Revenues are trending about \$240,000 favorable to budget due to increased Tuition and Federal Impact Aid payments and a supplemental State appropriation of Group Home Aid related to the opening of six additional group home beds at Boys Town.

EXPENDITURES: Net expenditures through January were \$19,501,548 representing an increase of \$3,169,247 from December. An additional \$12,447,806 was encumbered for the year, primarily related to payroll costs and special education out of district tuitions and related services costs.

As of January 31, 2019, certain accounts are projected to be over budget for the year. Account 55630 (Tuition to Private Sources) is over budget by \$78,436 as the number of outplaced students is higher than projected. Related Statewide Transportation costs (included in account 55111) are projected to end the year over budget by approximately \$120,000.

SUMMARY: For the full year, I am projecting that the anticipated revenue favorability should offset the overage in special education tuitions and related busing costs.
