SUCCESS STORY

Donation from the family of Rich Lee- On Monday, August 8, 2016 the Pekin Community lost Rich Lee, former District 108 principal who retired in 1992. Rich served in the United States Army and received his Bachelor's Degree from Western Illinois University and a Master's Degree from Illinois State University. Rich was a member of First United Presbyterian

Church and a member of the Tazewell County Retired Teachers' Association.

Rich touched the lives of many students as an educator and as a coach. He was named Outstanding Educator of the year in 1992, and after his passing, many former students and colleagues took to his online memorial page commenting on the positive influence and lessons

he taught over the years.

Rich is survived by his wife of 56 years, Cherie Lee. In honor of her late husband, Cherie established a memorial fund to benefit the less fortunate children of Pekin. Her wish in establishing the fund was to brighten the lives of individuals by letting them know that there was a principal who may no longer be with us, but loved children; and dedicated his life to help make the schools in which he served the best they could be.

Approximately \$3,000.00 has been gifted to the memorial fund and deposited with the Pekin Outreach Initiative (POI) and earmarked for use by the principals and staff of our six primary schools. The money will be used to support programs, services, and initiatives benefiting students at-risk and in need.
