CALL MEETING TO

ORDER

The Board of Education of Pekin Public Schools District 108 held a regular meeting Monday, March 20, 2017 in the Board Room of Washington Intermediate School. President Spanos called the regular meeting to order at 6:45 p.m.

SUCCESS STORY: BJHS PARTNERSHIP WITH SCHRAMM SCHOOL Broadmoor was approached by Schramm School teacher, Crystal Cosentine this past fall to see if students could have the opportunity to visit Schramm and interact with Schramm students. Mr. Goss presented the opportunity to Broadmoor's Service Learning class for consideration.

Schramm administrator, Mr. Tim Kennedy and Ms. Cosentine created an orientation video and conducted a presentation to the 14 Broadmoor Service Learning students. The BJHS students then toured the Schramm facility and visited students in their classrooms. The Broadmoor students completed reflection questionnaires noting what they had experienced and were able to ask specific questions regarding how they could best understand the unique relational, emotional, academic, and social needs of the Schramm students.

The Broadmoor students sacrifice their intervention/recess time and visit Schramm on a weekly basis for one hour. These students are immersed into the Schramm classrooms and play environments so that they may interact and socialize with Schramm students. Our future goal is to assist in putting Schramm electronic communication boards into "kid" voice commands and create pictorial story boards utilizing Broadmoor students. These story boards will then be utilized in Schramm classrooms.

Ms. Cosentine commented, "In just our short time together I've noticed a change in the comfort level of the Broadmoor students in interacting with Schramm students. They are eager to interact and help with the students and many have already formed a bond. I love that it is teaching acceptance, something that is so important for future leaders and young adults in our community. An additional benefit is that Schramm students are gaining exposure to appropriate social interaction and play. Exposure to their typically developing peers is vitally important to Schramm's students and they are so excited to see their Broadmoor friends. We really look forward to taking this partnership even further by providing peer tutoring and having our Broadmoor friends make materials that will help our students for years to come. We couldn't be happier that your group was so eager and willing to collaborate with us!"
