BOARD HIGHLIGHTS

The following represents the action taken at the September 28, 2020 meeting of the Board of Education.

BUDGET HEARING

The Board of Education conducted a Budget Hearing for public comment prior to the regular meeting regarding the FY21 Budget. There was no comment from the public.

SUCCESS STORY-DISTRICT RECEIVES E-RATE FUNDING FOR WIRELESS SYSTEM UPGRADE

In 2009, District 108 began utilizing wireless technology for instruction. Since that time, we have deployed wireless access points in all 11 schools and upgraded and expanded our wireless network to include connectivity throughout the district in all classrooms and common spaces. District 108's current wireless controller and access points are no longer supported by the manufacturer. While everything is still working, we are not able to add additional access points or replace any that may stop working.

For the 2020-2021 E-rate funding year, we applied for Category 2 funding to replace our aging system. The total cost to fund the project is \$63,150. We are happy to announce that District 108 was awarded funding for this project at the 85% discount rate. This discount rate is based on our free and reduced population numbers. The committed amount from E-rate is \$52,402.50 - leaving the district to fund the balance of \$9,248.

This funding will allow us to replace our 2 wireless controllers and all 125 access points across the district for a district wide update and upgrade of our wireless network. This update will support teaching and learning in all 11 schools for years to come and will help make our transition to 1:1 deployment a smooth one.
