Britt and I went to the fall directors conference in Portland for two days. We took home lots of good materials and information. Some highlights include:

- 1. McKinney Vento, I attended this session and spoke with both Sarah Furgeson the Edu Surrogate liaison and Amelia Lyons the Homeless Edu State Coordinator.
- 2. Extended Eligibility to age 22. This was a hot button topic. The crowd shredded the presenter. Mainly because she kept saying that the criteria to use is if it would "benefit" a child to stay until 22 and special ed has always been driven by an evidence based NEED practice. Also they are working on a form and a criteria that is supposed to help make the determination if a student should stay.
- 3. I have graduation and career readiness tools included. I will also pass around the career development checklist and the employability skills checklist.
- 4. I also created a transition services guide that we will start using with families as well as give to staff. It has the names, contact information, type of service, and purpose of service in the guide.
- 5. Brittney also attended the Unified Sports and Special Olympics. She learned about all kinds of exciting things she wants to bring to SACS. There is also potential for a 6000.00 grant for supplies and the training for staff is all free. We would like to attend the Unified sports conference in Orono in December.
- 6. I also attended sessions on interventions, SEL learning (<a href="https://www.maine.gov/doe/sel/sel4me">https://www.maine.gov/doe/sel/sel4me</a>), and social maladjustment VS emotional disturbance. Unfortunately the ED VS SM session was clear as mud, so I didn't feel it was helpful.
- 7. Elementary staff was set up a WHOVA app, that is where they can access the Science of Reading PD that was last week.
- 8. We currently have 10 referrals active. I have never had so many at one time. Dr. McCormick is keeping us on the timeline, but it's a lot of new kids.
- 9. Nov 4th presenting my ACT plan for sped recert and admin certification.
