2. Accept bid for Monroe HVAC project $(\$ 593,405)$

This item had been tabled from the regular meeting due to cost issues. Todd Hannah discussed some of the options to get the cost down to the $\$ 593,405$, which was a change in the type of units that would be installed. The original specs called for units that would not be in before summer work could be completed. The new specs have units that have an 8-12 week lead time. The warranty was discussed at length. The options were a 3 year warranty covering parts and labor or a one year parts and labor warranty for a difference of $\$ 14,600$ between the two. The board made the vote based on protecting the investment with the three year warranty. Superintendent Julius advised the roof bid, which will accompany this project, will be voted on at the regular meeting. All expenses are being paid through the ESSER III grant.
