

Notice of Proposed Property Tax Increase for Casey - Westfield CUSD C-4

I. A public hearing to approve a proposed tax levy increase for Casey-Westfield CUSD C-4, counties of Clark, Coles, Cumberland, Crawford, and Jasper, State of Illinois, for 2022 will be held on December 12, 2022 at 7pm at the Casey-Westfield Unit Office, 401 E. Main St., Casey, IL.

Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Superintendent Dr. Jon Julius; Phone 217-932-2184.

II. The corporate and special purpose property taxes extended or abated for 2021 were \$3,913,710.

The proposed corporate and special purpose property taxes to be levied for 2022 are \$4,360,251. This represents a 11.4% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2021 were \$664,585.

The estimated property taxes to be levied for debt service and public building commission leases for 2022 are \$661,582. This represents a .45% decrease over the previous year.

IV. The total property taxes extended or abated for 2021 were \$4,578,295.

The estimated total property taxes to be levied for 2022 are \$5,021,833. This represents a 9.69% increase over the previous year.







When any school is authorized to issue bonds, the school board shall file a certified copy of the resolution in the office of the county clerk of each county in which the district is situated to provide for the issuance of the bonds and to levy a tax to pay for them. The county clerk shall extend the tax for bonds and interest as set forth in the certified copy of the resolution, each year during the life of the bond issue. Therefore to avoid a possible duplication of tax levies, the school board should not include a levy for bonds and interest in the district's annual tax levy.
