This is the annual complaint letter sent in accordance with the RI Regulations R23-24.6PB. This act requires all school districts, public and private, to inspect each of their school buildings for lead in their drinking water. All school buildings were found below the acceptable level for lead in drinking water and all are considered lead safe.

The North Kingstown School Department is committed to remaining a safe and healthy environment for all children, employees, and guests in our schools. We will continue as we have in the past to monitor, inspect, and repair any lead containing materials. RE: Asbestos AHERA Information Report


This is the annual updated compliance letter required by the Asbestos Hazard Emergency Response Act (AHERA). This act requires all school districts, public and private, grades K through 12, to inspect each of their school buildings for asbestos-containing materials. Management Plans have been developed outlining how asbestos-containing materials will be handled in each of the school buildings.

The North Kingstown School Department is committed to remaining a safe and healthy environment for all children, employees, and guests in our schools. We will continue as we have in the past to monitor, inspect, and repair any asbestos containing materials. Copies of our Management Plan and Inspection Reports are available upon request for review at each school office, as well as in the Office of Plants & Grounds located at 120 Fairway Drive.

We intend to have our Asbestos Operation and Maintenance Program updated every six (6) months and shall notify occupants, in advance, if abatement will be performed within your school building. Unless an emergency arises, all asbestos abatement will be performed during the weekend or school holiday periods.

RE: Integrated Pest Management Information Report

This is the annual updated compliance letter which is required by the state of Rhode Island General Laws TITLE 23, Health and Safety, CHAPTER 23-25, Pesticide Control: SECTION 23-25-37. The purpose of this regulation is to govern the use of pesticide applications and requires notification of such times and places when and where pesticide applications will take place at schools, pre-schools and child care centers in the State of Rhode Island. An Integrated Pest Management (IPM) program has been developed outlining how pest control issues will be addressed in the North Kingstown School District.

All schools in Rhode Island are required to have an Integrated Pest Management Coordinator, (IPM Coordinator). The IMP Coordinator oversees all activities related to the IPM program and the use of pesticides at the district's schools. The IMP Coordinator for the North Kingstown School District is Dennis Flynn, the Account Manager for ABM Services at North Kingstown School Department, telephone # 401-406-0419.

The North Kingstown School Department and ABM Services are committed to maintaining a safe and healthy school environment for all children, employees, and guests in our schools. ABM Services maintains a pest control service agreement with Encon Pest Control of Cranston, Rhode Island. Encon is licensed in Rhode Island as a professional pesticide service vendor.

Copies of our IPM Policy and management plan are available at each school and they are available for review on request at each school office. Monthly inspection reports will be maintained by ABM Services at their office located at North Kingstown High School on 150 Fairway Drive.

RE: Radon Testing Reports


This is the annual updated letter which confirms that all schools and school buildings have been tested for radon by a certified, licensed laboratory service. The purpose of this regulation is to protect the public's health and public interest by establishing a comprehensive program to reduce exposure to radon/radon progeny levels in public and high priority buildings and to ensure that all radon/radon progeny mitigation activity in these buildings is conducted only by appropriately trained and licensed/certified personnel.

The North Kingstown School Department has contracted with Ocean State Analytical Services, and AccuStar Professional Radon Laboratory has provided radon progeny measurements to the district.

The North Kingstown School Department is committed to maintaining a safe and healthy school environment for all children, employees, and guest in our schools.
