5. Approval of Superintendent Employment Agreement The Board is asked to approve an employment agreement with Shawn Posey to serve as superintendent commencing July 1, 2021.

Government Code section 54953 states the Board must receive a verbal report summarizing the salary, salary schedule, or compensation paid in the form of fringe benefits during the open meeting prior to the Board taking final action on a contract for a "local agency executive" as defined by the statute.

In accordance with section 54953, the following is summary of the employment agreement between the Board and Mr. Posey:

- The term is for two years, July 1, 2021-June 30, 2023.
- The annual base salary is \$179,044 and includes an annual salary increase with a satisfactory evaluation.
- A \$1,100 per year Master's degree stipend.
- An automobile reimbursement of \$400 per month.
- The District will pay Mr. Posey membership dues in the Association of California School Administrators.

- Health and leave benefits are consistent with other District administrators.
- The annual work year is 225 days, excluding weekends and holidays, with no paid vacation.

I am requesting a motion to approve the employment agreement and to grant me authority to sign the employment agreement.
