The Board of School Trustees (Board) of the Logansport Community School Corporation (Corporation), Cass County, Indiana, met in regular session at LCSC Administration Building, 2829 George Street, Logansport, IN 46947, at 5:00 P.M. on Monday, June 14, 2021.

Mr. Cyle Dibble gave a technology update.

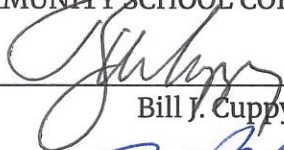
Mrs. Hagerty gave a curriculum update.

Comments were made by board members.

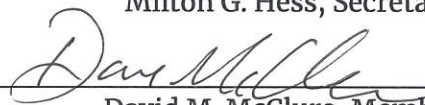
There being no further business to come before the Board, the meeting was adjourned at 6:14.
