Comments from the Board

Ms. Ward shared that she had received an alarming email regarding board members being a part of operations meetings, specifically with Facilities and Construction and expressed concern that it was unethical. She continued that the employees of the District, specifically Dr. McNulty was hired to do a job and that the Board should trust that he is doing his job and not have to be monitored. Ms. Ward added that it was an insult to her as an African-American female and to Dr. McNulty, a caucasian male. Dr. Remele responded that in September of 2017 the Board voted and selected her to attend all future facilities meetings due to the inequities that were found during the Mills High School construction. She added that if the Board no longer wanted her to attend then she would not attend.



Mr. Keller shared that there are other committees within the District that Board members are on and attend meetings for, i.e. the Health and Wellness Committee and he did not think it was unethical. He also congratulated Dr. Smith on her doctoral accomplishment and thanked Dr. Warren and the Committee involved with the Food Services proposal.

Mr. Maune expressed his support for Dr. Remele as a representative for the Board and a benefit to the District for her knowledge and experience. He thanked the administration for the community meeting on block scheduling and looking forward to more information to come.

Ms. Gillen apologized for not attending the last board meeting when the ADE waiver for half-day Wednesdays for the 2021-2022 school year was presented to the Board. She stated that this was something that the majority of our staff and constituents wanted and that the Board had failed our teachers and families. Ms. Gillen asked that the item be placed on the next meeting agenda. Ms. Burgess explained that the District would not be able to move forward with the waiver because the timeline had already passed.

Mr. Keller added that the Discipline numbers were impressive and that teachers and students have done a fantastic job.

Dr. Remele stated that she had received a letter from Larry Wilson, with 1st Arkansas Bank and Trust congratulating the District on its recent Unitary Status ruling and thanked the Board for their continued support.

Superintendent's Comments

Dr. McNulty stated that he was thankful for the community meetings and appreciated the questions as well. He added that there would be structure across the board for all four middle schools in the District. Dr. McNulty continued that the District's focus is on all students succeeding and providing flexible opportunities. He thanked the board for their support and stated that he is focused and transparent as the District continues targeting student success. Dr. McNulty added that the District-wide AVID training that was happening at Sylvan Hills High School this week has been great. He concluded with thanking the Board for their trust.
