### Charity helps give kids reason to smile

In my role as the McKinney-Vento liaison, I am often speechless by the generosity of people and organizations in the county.

A recent example was getting to work with Anne's Smiles to help a family in the Westfall school district who lost everything in a house fire. The family includes four children, three of whom have special needs.

With the help of generous donors, Anne's Smiles provided each of the four students with two pairs of shoes, socks, a bookbag, a coat and sweatshirt, and other necessary clothing items that were needed in this emergency

Marisha Eveland founded Anne's Smiles in December. It partners with school counselors,

social workers and other community leaders to provide shoes, hygiene products, emergency clothing and other needed items to fulfill its mission of providing dignity, joy and a smile to children of all ages.

"We started with just shoes and then added socks with each pair of shoes. School counselors requested hygiene products be made available, so we began offering full size hygiene products in a toiletry bag as well," Marisha said.

She emphasized that the charity provides new, quality, trendy shoes.

"It's very important to give students the feeling of dignity and pride," Marisha said, adding that by providing quality footwear it is likely to be passed down to a sibling.

As costs rise and temperatures drop, Mari-

This can include a variety of specific situations, but it comes down to this: If you are staying with someone temporarily, and that person could ask you to leave at any time, your living situation likely meets the definition of homelessness.
