Meeker High School - Amy Chinn- The high school will receive a grant from the County for TANF (Temporary Assistance for Needy Families) funding that will help purchase a chrome book cart for the Credit Recovery program. The grant will provide reimbursement for 39% of the costs. This could be ongoing funding.

Superintendent Report Additions:

Mr. Selle recommends changing to Mountain West Insurance as the district's broker for property, liability, and automobile insurance for FY 19. This change will reduce the cost significantly and will also use a local broker.

It was brought to the district's attention that we must pass a resolution on sharing mill levy override funds with charter schools in our area. This plan must be passed before July 1 of this year in order to be able to change the plan in the future, if needed. Currently our district does not have a charter school, but being proactive just in case one formulates in the future.

This stipend is for the extra duties after school hours that the athletic director has to attend. Dr. Dorsett inquired as to why the teacher salary schedule percentages at a different rate than all other schedules. Mr. Selle clarified that indeed all salary schedules percentage the same. Dr. Dorsett also mentioned that he felt the max out on the teacher salary schedule should be higher than most of the classified staff. Mr. Selle also replied that the classified staff does not have room to move horizontal and most of that staff work twelve months instead of nine months, contributing to the max salary.
