- 1. Jacqueline Baker called the meeting to order at 6:00 p.m.
- 2. Alfred Hogan offered invocation.
- 3. Jeanette Walker called the roll and a quorum was declared with all members present.
- 4. The Board recited the District Vision and Mission statement.
- 5. Motion James Baker, seconded by Torian Bell to approve the February Regular Meeting Minutes. Motion passed 7-0.
- 6. Mr. Hogan introduced Dan Lovelady with First Security Beardsley. Mr. Lovelady went over the final recap of the Bond sale. He stated the sale date was February 24, 2021. Four bids were received. The lowest bid was from Raymond James & Associates with a rate of 1.149227%. Raymon James & Associates appointed First National Bank of Lawrence County, Walnut Ridge, Arkansas to serve as trustee. \$33,920 will be deducted for bond issuance cost and \$1,556,448.60 will be wired to Merchants & Planters Bank, Newport, Arkansas to pay off the February 1, 2012 bond issue. Mr. Lovelady stated that these are unrestricted funds.

Motion Michael Ephlin, seconded by Torian Bell to Adopt the Resolution Authorizing the Issuance and Delivery of the \$1605,000 Osceola School District No. 1 of Mississippi County, Arkansas Refunding Bonds dated March 1, 2021 and other documents pertaining thereto as prepared by the Friday, Eldredge & Clark Law Firm. Motion passed 7-0.

7. Mr. Hogan introduced Donn Mixon. Mr. Mixon presented two resolutions for renaming the Osceola STEM Academy and went over the talking points the Board had concerning the renaming. He stated one resolution has the name of the school as Osceola Middle School and the other resolution has the name blank should the Board approve a different name. Mr. Hogan

stated that the top two names from the survey were Osceola Middle School and Rose Willis Middle School. Motion Kristain Dedmon, seconded by James Baker to rename the Osceola STEM Academy to Osceola Middle School. Motion passed 6-1 with Mr. Collins voting no.

Motion Ollie Collins to rename Osceola STEM Academy to Rose Willis Middle School. Motion failed for lack of a second.

- 8. Mr. Hogan presented the Proposed Budget of Expenditures with Tax levy for Fiscal Year Beginning July 1, 2022 to and Including June 30, 2023. Motion Denise Williams, seconded by Michael Ephlin to approve the Proposed Budget as presented. Motion passed 7-0.
- 9. Motion Michael Ephlin, seconded by James Baker to amend the Timed Agenda to 6:36 p.m. Motion passed 7-0.
- 10 Jacqueline Baker introduced the Financial Reports. Michael Ephlin asked if this is pretty much where we usually are this time of the year. Samantha Tippy stated that we are a little lower than we normally are but we can attribute a lot of that to our ESSER money because we pay for a lot of our expenses out of that but we're doing good, we are where we are projected to be. Motion Kristain Dedmon, seconded by James Baker to approve the financial reports. Motion passed 7-0.
- 11 Jacqueline Baker presented the list of bills. Mr. Hogan stated that the last draw on the Greenhouse will be right at \$22,000. We had a walkthrough of the Greenhouse last Wednesday. The natural gas bills might be high but wait until we get next month's bill because this is just the front end of the ice and snow we had. Mr. Hogan stated that we are working on a plan to have a socially distance grand opening of the Greenhouse around April 21. Motion Torian Bell, seconded by Michael Ephlin to approve the list of bills. Motion passed 7-0.
