I. CALL TO ORDER

IV. ITEMS OF DISCUSSION

1. Building and Grounds:

Steve Sura said that there are no new projects right now. He stated he is looking into different equipment to help the air quality in the buildings. He has a breakdown of the prices and will get that sent out as soon as it is ready. He is also looking into purchasing a bus since no bus purchases were made last year.

2. Bills for the month:

Julie stated that the bills were emailed out last week to the board members. There were no questions. She did mention the Kids Read Now program and the Chromebook purchase that will be on the table at next week's meeting.

3. Financial Statement:

Julie explained to the new board members that she sends this statement out every month to the board members. She stated that it shows where the budget is now compared to last year at the same time.

- 4. FICA on 3% Health Care Deduction:
 - Julie explained that this is a very confusing topic. Basically, it boils down to 700+ W2's being adjusted from the past 4 years. The school will be reimbursed for these funds and half of those funds will go to the affected employees depending on what each employee paid in.
- 5. Review Handbooks and Revised Board Policies:
 - The first reading will be at next week's board meeting. Julie explained that she had Bruce Bigham go through all the handbooks and suggested many changes so that the handbooks represent what is stated in the revised board policies.
- 6. Superintendent Search:

Matt explained the two proposals, one from MLI (Michigan Leadership Institute) and the other from MASB (Michigan Association of School Boards), to the board members and discussed why going through a company for the search has its benefits.

 - Greg said that Ryan has been working on all the athletic changes that come with Covid19. As of right now practices will begin after January 15, 2021 if there are no changes due to Covid19. The biggest challenge as sports move forward are the wrestlers because they will be face to face without maintaining the 6-foot social distancing rule plus trying to keep masks on.
