
# **Perception Data**







# Sioux Valley Elementary Assessment Protocol - Grades JK-5 Data Based Decisions Result in Increased Student Achievement



We continue to meet weekly (on Tuesdays) with the principal, teachers, special education teachers, school counselor and/or outside counselor, if needed, school psychologist, and Title I teacher to monitor progress and identify intervention strategies, and to determine if a referral for special education is needed, if agreed upon by parent/guardian. (Teacher Assistant Team)

# **Professional Development:**

Sioux Valley Elementary (SVE) is a MTSS school and does receive support from MTSS/RTI coordinators and facilitators. SVE staff does attend the yearly summer MTSS conference and other MTSS (RTI or PBIS) yearly trainings as professional development.

We use our first and third Wednesdays as PLC time. During this time, all grade level teachers complete an agenda and focus their time on ways on how to make sure students are on track to meet their reading goals.

# Middle School and High School

#### **Needs Assessment:**

During the 2021-2022 school year, Sioux Valley Middle School and High School conducted a comprehensive needs assessment based on the South Dakota Comprehensive Needs Assessment process looking at the areas of Effective Leadership, Curriculum & Instruction, Talent Development, and Family, Culture, and Climate (Mr. Bolstad has conducted this process in two previous school districts). This included surveys of students, certified staff, classified staff, parents, and community members. Additional qualitative data came from a focus group of staff members held by CNA committee members. The needs assessment also included a review of attendance, behavior, and achievement data on state assessments. With this qualitative and quantitative data, the CNA committee, which included a mix of staff members and departments at the secondary level, conducted an analysis of the data to determine strengths and areas to target for growth. Of those areas identified for growth, the committee engaged in a protocol to prioritize the needs based on the impact level and how long this has been a concern.

#### Focus Areas:

These are the four highest areas identified areas:

- \*Effective Leadership
- \*Curriculum & Instruction
- \*Talent Development
- \*Family, Culture, and Climate, respectively.

#### **Identified Goals:**

- \*Sioux Valley students will meet or exceed the state average in all SBAC tested categories.
- \*Sioux Valley junior and seniors will meet or exceed the state average on the ACT sub scores in English, math, science, and social science.
- \*Attendance rates in all grade levels should be at or above 95 percent.

### **Intervention Strategies & Measuring Progress:**

- Our MS/HS school needs a teacher's assistance team that meets to support the students brought forward that the teacher has concerns with. This process should be improved and streamlined.
  - o Action Plan By the beginning of the 2022-2023 school year, our process for referrals to Tier 2 and Tier 3 services will be streamlined. Tier 2 will follow the TAT process of the elementary level that has been working effectively. These interventions are designed to be implemented quickly and monitored for fidelity and measured in their success. Tier 3 interventions will be developed with the student and parents during a student intervention plan meeting that is specific to the individual child's needs. Both steps occurred during the 2021-2022 school year, but the process needs to be cleaned up and clarified.
- 2. Using assessment results to determine the next instructional steps.
  - Action Plan PLCs to analyze student achievement data, with emphasis on formative assessments.
- 3. Students feel emotionally safe at school.
  - o Multiple avenues will need to be taken to improve on this metric.
    - v Involvement of our leadership organizations to approach the issue: Student Council, NHS, FCCLA, FFA; See Something, Say Something v Responding to Students' Perspectives and Needs: Student Focus Groups, Annual Survey to gauge progress, Weekly Check-In form with Class Advisor(s)
    - v Establishing Consistent Routines and Procedures: Effective routines, procedures, and structures do not overly control students' choice and voice, but create predictability so students know what to expect. These types of consistent, predictable routines help reduce stress and facilitate learning for all students, including those who have experienced trauma, are on the autism spectrum, or struggle behaviorally.

# **Professional Development:**

Sustained, relevant, usable PD on the following interrelated topics: student behavior, classroom management, and student engagement.

- Continued training and discussions on responding effectively to misbehavior.
- o Adult learners need constructivist opportunities to learn by sharing experiences.
- Personalized professional development PD Goal Groups, New Teacher Meetings
- Potential resources First Days of School (new teacher book study), Better than Carrots and Sticks, Hacking School Discipline,

#### Transition to Middle School

**Transition to Middle School:** The MS/HS Principal, MS/HS Counselor, and JK-12 Dean of Students plan a Back to School meeting to review expectations and tips for success along with helping students examine their schedules to see how to get to their lockers and classroom.

### **Transition to High School**

The MS/HS Counselor and MS/HS Principal meet with 8<sup>th</sup> grade students in December to discuss changes from Middle School to High School along with developing their personal learning plans for their high school careers.

# **ARSD Waivers and Waiver Review**

Sioux Valley School District currently has the following waivers from administrative rule, as authorized by ARSD 24:43:08:03 and ARSD 24:43:08:08.

24:43:08:03. Application for waiver. An application for a waiver shall be made using a form provided by the Department of Education. The form shall require the district to specify the administrative rule or policy for which the waiver is sought and the school that will implement the waiver; the form shall include a detailed description of the waiver and its effect on student learning, the reasons for requesting the waiver, the expected outcomes if the waiver is granted, an explanation of how the intent of the standard to be waived will be met if the waiver is granted, and a detailed description of the plan for evaluating the effectiveness of the waiver in achieving the outcomes specified in the application and contributing to the school's continual improvement. The plan for evaluating the waiver shall become a part of the annual review of a public school district's approved five-year district improvement plan as required by ARSD 24:43:02:03.

24:43:08:08. Evaluation of waiver. A school district or nonpublic school or program that has been granted a waiver shall implement its plan for evaluation of the waiver as required by § 24:43:08:02. A public school district that has been granted a waiver shall include a report of the waiver evaluation in its annual review of its approved five-year district improvement plan as required by ARSD 24:43:02:01.

# Credit before Grade 9 – 8<sup>th</sup> grade Algebra I – Expires in 2023

Sioux Valley School District applied for this waiver in April of 2018. We had several students take advantage of the waiver during the 2018-2019 school year. Our district has not offered Algebra I in 8<sup>th</sup> grade since the 2018-2019 school year. However, our district is in the process of submitting a new application for this waiver in order to keep this option available to our students.

#### Teacher Certification Requirement Rules - Expires in 2023

Sioux Valley School District was unable to hire a fully certified special education teacher for the 2022-2023 school year because we did not have any fully certified applicants apply. Current teacher has an active teaching certificate, but not in special education. Current teacher is on a Plan of Intent and will be taking the necessary coursework, which should be completed by 07/01/23, to become fully certified to teach JK-12 special education.

All waivers are reviewed annually by the superintendent to ensure compliance. This is typically done in collaboration with building principals once the school year is finished.

# **Alternative Certification**

#### **Teacher Certification Requirement Rules – Expires in 2023**

Sioux Valley School District was unable to hire a fully certified Spanish teacher for the 2021-2022 school year because we did not have any fully certified applicants apply. Current teacher has an Educator Certificate with Alternative Certification to teach Spanish I and is currently taking coursework, which should be completed by 07/01/23, to become fully certified to teach Spanish.

All alternative certificates are reviewed annually by the superintendent to ensure compliance. This is typically done in collaboration with building principals once the school year is finished.

## **Analysis of Demographic Data**

## **Enrollment & Enrollment Projections**

Sioux Valley Schools has a current JK-12 enrollment of 740 students for the 2022-2023 school year. Approximately ½ of the grade levels have two sections and the other half have three sections. Student enrollment at all levels appears to be on an upward trend.

# **Population**

The population of Volga and the surrounding communities continues to grow, reflecting an increase in our student enrollment, as well. This year's student enrollment increased by approximately 50 students from the previous school year.

Open enrollment has also had a significant impact on our student enrollment. Based on the

SD DOE website, Sioux Valley currently has 66 resident students that enroll out of the district to another school district and 151 non-resident students that currently enroll into the Sioux Valley School District.

There is a private K-8 school, Volga Christian, within Volga city limits. These students will eventually filter into our District either through the extra-curricular activities or when they complete eighth grade.

#### Free and Reduced Lunch

The free and reduced lunch numbers for the district for 2022-2023 are as follows: elementary – 14.7%, middle school – 17.9%, high school – 9.8%, JK-12 – 13.9%.
