The tentative amended budget has been on display at the District Office for thirty (30) days. There were no public questions or comments regarding the amended budget. Regular Meeting of the Litchfield Board of Education

The regular monthly meeting of the Litchfield Board of Education was called to order at 6:03p.m.

Closed Session

A motion was made by Ron Anglin and seconded by David Belusko to enter into closed session at 6:04 pm. to discuss: The appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the District or legal counsel for the District, including hearing testimony on a complaint lodged against an employee or against legal counsel for the District to determine its validity. 5 ILCS 120/2(c)(1) Collective negotiating matters between the District and its employees or their representatives, or deliberations concerning salary schedules for one or more classes of employees. 5 ILCS 120/2(c)(2) A Roll Call Vote: YEA: Abel, Anglin, Belusko, Cain, Fleming. Motion carried 5-0. A motion was made by Ron Anglin and seconded by Mike Fleming to return to open session at 6:53 p.m. A Roll Call Vote: YEA: Abel, Anglin, Belusko, Cain, Fleming. Motion carried 5-0.

Consent Agenda

A motion was made by Ron Anglin and seconded by Mike Fleming to approve the Consent Agenda as follows:

Yearly approval of adding incoming Freshmen account and deleting previous senior class account. Bills payable in June total \$376,737. From Education fund \$244,888; from Operations & Maintenance \$35,460; from Transportation \$33,185; from Capital Projects \$40,000; and from Tort \$23,203. Ending balance in all funds at May 31, 2021 is \$30,229,406. Balance in operating funds is \$7,924,068. Balance in Capital Projects is \$13,576,877; and in Health Life Safety \$7,669,652. New Business

Emily Spindler of FGM Architects along with Eric of Poettker Construction gave the board the latest updates to the elementary building project. The plans were updated to include sinks in classrooms and lockers for the 2nd and 3rd grade students. Samples of the exterior materials that will be used were presented for the Board. FGM Architects and Poettker construction will give the next updates at the July 20, 2021 meeting.

A motion was made by Valerie Cain and seconded by Ron Anglin to grant Poettker Construction permission to issue a Solicitation for Bids for the Precast and Structural Steel packages for the New Elementary Building at State Street. This approval does not constitute any approval for acceptance of submitted bids nor shall it bind the District to award any bids. Separate approval from the Board of Education shall be obtained to obligate any bidder. This approval is strictly to allow Poettker Construction to act, on the District's behalf, to issue a Solicitation for Bid, advertise and collect bids, and prepare results for the District's consideration for award. A Roll Call Vote: YEA: Abel, Anglin, Belusko, Cain, Fleming. Motion carried 5-0. As a discussion point, these packages are being released early due to the long lead times of materials. The balance of the packages will be released under a separate approval.

A motion was made by Ron Anglin and seconded by Valerie Cain to approve setting the amended Fogleman Scholarship dollar amount to \$ 3,000.00 for the 2020-2021 school year. In light of the reduction in renewals this year, it is recommended that the scholarship amount for 2020-2021 be set at \$3,000.00. A Roll Call Vote: YEA: Abel, Anglin, Belusko, Cain, Fleming. A budget amendment hearing, which was advertised in the newspaper, was held prior to tonight's board meeting. Information Items

The Administrators gave a brief update on Summer School and Camp Panther. 116 students are attending Camp Panther. The last day will be July 1st. Many donations of gift cards and merchandise have been made by business in the community. Beth Cherry with the Chamber of Commerce was a great recourse. The High School has 65 enrolled in summer school while the Middle School is up to 34 students. Attendance has been exceptional. There is room for improvement and the administrators are collecting feedback from students, parents, and staff. Ideas are already forming for next year.
