## WAUKOMIS PUBLIC SCHOOL

2021-22 Learning Plan

#### **MASKS**

- In compliance with Senate Bill 658, masks will not be required unless Garfield County has been declared as a State of Emergency and in consultation with the county and other health departments.
- If Garfield County is declared as a State of Emergency, WPS will implement our system to determine site by site if masks should be required.

#### **SOCIAL DISTANCING**

- Social distancing will be encouraged when space allows.
- Students will not be restricted from interaction throughout the buildings.

#### **CONTACT TRACING**

- Sites will track the number of positive COVID cases reported.
- Contact tracing will not take place unless directed by the Garfield County Health Department.

## **VIRTUAL LEARNING**

- If a school site is closed due to COVID positive cases, poor weather or other extraordinary circumstances then virtual learning could be instituted.
- Students will receive instruction through Google Classroom and other supplemental programs.

#### **VACCINATIONS**

Vaccinations are encouraged but not required for those eligible.

## **HYGIENE**

- Hand sanitizer will be available and encouraged for use.
- Hand washing for a minimum of 20 seconds will be encouraged.

#### **TEMPERATURE CHECKS**

- Temperature checks will not be taken at the door. If a student is sent to the office for possible COVID or other illness symptoms then temperature may be taken.
- WPS encourages all parents/guardians to, please, monitor your children and please keep them home if symptoms are present.

 Students with disabilities will be provided services based upon their IEP or 504 educational plans.

#### **VIRTUAL MEETINGS**

- Virtual Parent/Teacher Conferences will be offered to parents/guardians who cannot or choose not to attend in person.
- Virtual IEP/504 meetings will be offered to parents who cannot attend in person.

#### PARENTS, GUESTS & VISITORS

- Parent volunteer workers are welcome inside the buildings.
- Visitors and guests will be allowed in the buildings for programs, concerts and other special events.

## **FIELD TRIPS & TRAVEL**

 Field trips and travel will be allowed based on the restrictions that were in place pre-COVID.

#### **LUNCHES**

- Students may eat in the cafeteria and/or the all purposes room if needed.
- Parents, guardians and guests will be limited to special occasions set by the school.

## **DISTANCE LEARNING PLATFORM**

- WPS will use the Acellus platform for distance learning.
- Parents/guardians of those students wanting to enroll in distance learning will need to fill out school enrollment packet and distance learning enrollment form as well.

#### **OTHER**

 Waukomis Public School will remain in contact and continue to seek advice from state and local health departments as well as the Oklahoma State Department of Education.

# Waukomis Public Schools Tiered System

Elevated numbers at a single site will be investigated on a case by case basis. Mask requirements will only be implemented if Garfield County is placed under a state of emergency by the Governor pursuant to SB 658.

## Positive cases include students and staff members.

Tier 1  0-3% per site	Masks welcomed, not required; follow typical school procedures. No changes necessary.
Tier 2 3.1 – 5%	If declared a state of emergency by the Governor pursuant to SB 658, masks will be required in all hallways and entering/exiting buildings, large group settings and in areas where a certain level of risk has been determined.
Tier 3	Site shutdown for 10 calendar days. Students move to virtual learning through Google Classroom.
