Dear Parents and Guardians,

Welcome back to Coshocton City Schools!! I am looking forward to working with each of you to ensure the health and safety of our students and staff. We know from research that students learn best when they are healthy and it is a privilege for me to be able to provide care to your children when needed.

As the school year begins, I would like to remind you of some important school policies to make note of:

**Immunizations**: Proof of immunization is required by the State of Ohio to be on file **prior** to the beginning of the school. Vaccines are required for Kindergarten, 7th, and 12th grade.

**Medications:** It is school policy that students **are not** permitted to carry medications with them at school. All medications including Over the Counter medications are to be administered, stored, and locked in the school nurse's office. If your child has medication that needs to be administered at the school, please ask for the *PHYSICIAN'S ORDER FORM*. The form needs to be filled out and signed by you and your child's physician.

\*\*Medication must be brought to the school by an adult in the original container with a pharmacy label in place. Forms can also be found online under the **School Nurse** tab.

**Food Allergies/Anaphylaxis/Asthma**: If your child has food allergies that can lead to anaphylaxis or has asthma that requires an Epipen or inhaler, a *PHYSICIAN'S ORDER FORM* is needed. Please call my office for assistance.

\*\*Children are allowed to carry an Epipen or inhaler as a medical necessity with doctor and parent permission. Food Allergies require documentation from a physician if certain foods are to be withheld

**Health Concerns:** Please inform the school nurse of medical conditions or concerns and any changes in health status. It is important for the school nurse to know medications your child takes regularly. All medical information is confidential.

**Vision and Hearing Screenings**: Our school district routinely performs Vision and Hearing screenings as mandated by ORC 3313.50 to identify students who have vision or hearing problems or might be at risk for vision or hearing problems. Routine Vision and Hearing screenings are conducted by your school nurse for grades 1, 3, 5, 7, 9, 11, and Kindergarten. Any student with an IEP or a new student will be screened as well.

**Clothing:** At times children have accidents, spills, or torn clothing. If your child is prone to accidents, please make sure you provide them with a complete change of clothing in their backpack.

**FinalForms:** It is very important that your student's FinalForms are updated and accurate. We use this information to contact you throughout the year or in the case of an emergency. It is also important that you include any medical information that you feel is necessary for school staff and me to know for your student to have a healthy, safe, and successful school year.
