- III. Superintendent Updates
 - Dr. Brooksher discussed a bus incident.
 - The attendance rate is leveling off.
 - Our budget process has been modified this year to include more face to face meetings and an earlier timeline. Dr. Brooksher will bring the budget goals to the board in April.
 - Ms. Mary Beth Brothers presented the board with certified contract renewal recommendations. These will be included as an action item on the February 22nd board agenda.

V. Capital Projects Discussion

- Dr. Brooksher has an executed copy of the land donation contract of 209 acres.
- Ms. Melanie James updated the board on the upcoming bond sale. Raymond
 James will be the underwriter and we plan to sell around 70 million in bonds
 to cover projects over the next 3 years.
- Jon Pannell, our bond attorney and Todd Barnes, our underwriter will join us at the March session. Copies of the bond resolutions will be distributed at that time.
- County commissioners will vote on the tax levy resolution the week of April 9th with a closing on April 12th.
- Todd Barnes is working with his team to develop an informational guide on the bonds that can be shared with those interested in purchasing bonds.
- Dr. Robertson shared that we currently have 3 open RFP's for modular units, auto scrubbers, and surveillance systems.
- The board reviewed a quote from Pope Construction to renovate the gymnasium at the Community Education Center. An action item will be included on the February 22nd board agenda.
- We are working on final pricing for bus radios.
