Levy hearing for proposed levy increase for 2009-2010 school year (discussion/action)

- · Our school district is entitled to every dollar and needs every dollar the CPI will allow.
- The tax rate for this school is either the lowest or 2<sup>nd</sup> lowest in the state.
- Total levy requested is \$6,301,263, an increase of \$821,903.
- Some Board members made comments on the levy.
