**VISION:** The Lennox School District seeks to create a challenging learning climate that encourages high expectations for success in a safe, caring, and supportive environment and actively involve our parents, teachers, and community members in our students' learning.

**MISSION:** Lennox School District's mission is to work together to inspire lifelong learners who innovate, persevere, and collaborate to solve the challenges of tomorrow.

#### **Part I: Lennox Elementary Expectations:**

"Parent and Family Engagement" refers to the involvement of parents and family members of Lennox Elementary students.

- The Principal and Title I Director shall ensure that Lennox Elementary parent and family engagement strategies

# 1. Lennox Elementary will involve parents in the development and review of the district-wide parent and family engagement plan:

The Principal and Title I Director will establish a Title I Focus Group to review Title I programs, School Improvement Plan/Goals, and Family Engagement on a regular basis, along with implementing ways to provide information in a format families can understand.

- 2. Lennox Elementary will establish objectives for meaningful parent and family engagement:

  - a. Lennox Elementary Title I Focus Group will determine how funds will be used for family engagement.
  - b. Lennox Elementary will conduct parent-teacher conferences in the fall and spring to communicate academic achievement and school performance with parents.
    - 1. The teachers will provide information and discuss state and district assessments, content standards, and student progress.
    - 2. Lennox Elementary will implement Family Engagement Opportunities during the 2023-2024 school year.
  - c. Supporting ongoing communication by:
    - a. Providing (EL) interpreters for parent-teacher conferences and other formal meetings.
    - b. Providing comprehensive information through the District's website, <a href="www.lennox.k12.sd.us">www.lennox.k12.sd.us</a>. This information includes all District policies, agendas and minutes of School Board meetings, data profiles and performance reports for all schools; state report card, announcements, and teacher lesson plans/websites.
    - c. Providing an opportunity for parents/guardians and community members to respond to news and announcements through District Communication Tools; Twitter, Zoom, Remind App, Class Dojo, School website, Weekly Announcements, and Tuesday Folders, Emails/Texts, Teacher Websites; in their primary language whenever possible.
    - d. Providing timely updates and messages to parents, in their primary language whenever possible.
    - e. Providing, upon request, printed copies of the District Data Profile, the District Budget, specific District policies, and the District and individual school accountability report cards with summaries.
    - f. Facilitate information from parents through online surveys to understand strengths and needs within Lennox Elementary.
- 4. Lennox Elementary will build the school's and parents' capacity for strong parental involvement and develop strategies to support successful school and family interactions by;
  - Facilitating communication between school personnel and the families of English Language Learners (ELL); Provide Interpreters for (EL families) at parent-teacher conferences and other parent/guardian meetings.
  - b. The Principal and Title I Director will provide professional development to enhance the skills of teachers, administrators, and other staff, in building ties between parents and family members and the school.
  - c. The Principal and Title I Director will coordinate training with community resources to enhance engagement opportunities in the district.

- d. The Principal and Title I Director will support teachers in developing academic kits/materials to strengthen connections to school-home and community resources and/or providing learning kits/materials for students to take home.
  - a. K-2 Grade Decodable Books
  - b. Math games sent home and shared with families
  - c. Teachers have grade-level reading materials/activities that go home periodically.
- 5. Lennox Elementary will coordinate and integrate parent and family engagement strategies in Title I with parental involvement strategies to the extent feasible and appropriate with other relevant Federal, State, and local laws and programs (Head Start, Migrant Education, McKinney Vento, and English Learners).
  - a. The Lennox Elementary Principal and Title I Director and other staff involved in Early Childhood Programs, Migrant Education, McKinney Vento, and English Learner programs will review reports and plans for parent and family engagement to identify gaps, overlaps, and opportunities for reinforcing involvement.
  - b. The Lennox Elementary Principal and Title I Director, and other staff involved will consult and communicate with parents and program representatives to ensure smooth transitions; For example: B-3, Head Start, Kindergarten, other transitional grades, ELL students new to the district.
- 6. Lennox Elementary will conduct, with the involvement of parents and family members, an annual evaluation of the content and effectiveness of the parent and family engagement policy in improving the academic quality of all schools served under Title I.
  - a. The building Principal, Title I Focus Group, and the Title I Director will annually review Parent/Teacher/Student Compacts; policies, and the Family Engagement Plan.
  - b. Superintendent and Title I Director will remain current on Title I rules and regulations to advise and support Title I schools and will meet with the Lennox Elementary Principal and Title I Teacher on a regular basis to keep him/her updated.
  - c. The building Principal, Title I Focus Group, and Title I Director will evaluate the policy and include identifying barriers to greater participation by parents and family members in parent and family engagement activities, especially barriers to parents and family members who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background.
  - d. The building Principal, Title I Focus Group, and Title I Director will examine how funding set aside for Parent and Family Engagement is spent.
- 7. Lennox Elementary will involve parents in the activities served under the Title I Program.
  - a. Lennox Elementary staff and administration will continue to create a safe and welcoming environment where families feel welcome at school.
  - b. Lennox Elementary staff and administration will continue to inform families of school goals; Strategic Plan, and Building Goals.
  - c. Building Principal and Title I Director will provide continued support to staff in the ongoing process of involving and encouraging parents in their child's education.

- g. Work completed with the Title I teacher will be stamped so it can be deciphered as to what is classroom work and what is Title 1 work.
